Bill Summary: The bill provides for a revised plan for financing and construction of a new approximately 15-story, \$316 million county criminal and civil courthouse on the site previously prepared for that use on the western edge of downtown. The bill approves a future \$52.5 million special revenue bond issue to finance construction of the project in conjunction with existing Better Jacksonville Plan funds and other court-related funding sources. The bill amends the 2006-11 Capital Improvement Program to authorize priority 1 status for the elements and phases encompassed within the reconfigured "Duval County Courthouse Facilities Project" (see attached). The bill authorizes the Mayor to engage consultants, design professionals, construction firms, and other professional assistance necessary to design and construct the new courthouse.

The bill extends the appointment of the Courthouse Architectural Review Committee established via Ordinance 2004-1339-E to review and approve the design of the exterior of the facility. The bill restricts the use of the funds to the uses specified in the attached Duval County Courthouse, provides that the Mayor may consider authorizing use of program contingency funds to address requests made by the Chief Judge for reasonable additions to the courthouse program, and provides for an appeals mechanism to the City Council should the Mayor deny a request of the Chief Judge costing \$100,000 or more. Finally, the bill declares that the courthouse location will not cause a permanent closure of Monroe Street.

Background Information: The project documentation proposes a courthouse of 15 stories, plus a penthouse and basement, encompassing a total of 611,000 square feet. Of that amount, 509,000 sq. ft. would be finished initially and 102,000 would be left as empty shelled space. The project also includes renovation of the old Federal Courthouse (205,560 sq. ft.) for use by the State Attorney and allocation of 60,000 sq. ft. in the Ed Ball Building to house the Public Defender's Office. The project, at completion, would house 29 criminal courtrooms, 15 civil courtrooms and 60 judicial offices. Twenty-five criminal courtrooms, 11 civil courtrooms and 52 judicial offices would be completed in the initial construction phase.

The Part creates a mechanism by which the owners of working waterfronts (hotels and motels, marinas, boat yards, docks, boat hauling and repair businesses, etc.) may defer payment of ad valorem taxes on such properties, under certain conditions, until such time as the property ceases to be used for an eligible recreational or commercial use or is sold to a new owner. The deferral would apply only to taxes levied by the City of Jacksonville, and would not apply to School Board, FIND or Water Management District taxes, non-ad valorem special assessments, or taxes levied make payments pledged to bond debt service. Applications for the deferral will be submitted to and approved or disapproved by the Tax Collector. Appeals of the Tax Collector's denial of a deferral application shall be to the Value Adjustment Board, and further appeal of a denial by the VAB shall be to the circuit courts.

For each property on which taxes are deferred pursuant to this program, a lien shall be created and the Tax Collector shall issue to the City a tax certificate for the deferred taxes, which shall accrue interest based on the average yield of Florida Retirement Savings investments. The property owner is required to maintain insurance on the property to safeguard its value for purposes of satisfying the lien. The deferred taxes are due and payable when the property is sold to a new owner or ceases to be used for a tax deferrable purpose.

Background Information: The working waterfront tax deferral program was authorized by a law passed by the 2006 Florida Legislature to provide a means to incentivize owners of marinas, boat ramps, boat sales and repair yards, etc. to maintain these uses and thereby the public's access to waterways in the face of rising tax bills due to the assessment of waterfront property based on its highest and best use, which often would be expensive condominiums that would preclude public use of the waterfront.

The bill amends the 2006-2011 Five Year Capital Improvement Program, approved by ordinance 2006-789-E, for the "Fanning Island Park" project. The funds will carryover from Fiscal Year to Fiscal Year and the Department of Parks, Recreation, Entertainment & Conservation is designated to oversee funding the project.

Background Information: The site for Fanning Island Park is located on Heckscher Drive. Once the funds are appropriated for this project, Parks & Recreation will request bids of the items and award the bid to the contractor with the most creative and functional design. Other items in the design/build project include fencing, irrigation, landscaping, grills, trash receptacles and shade structures.

Bill Summary: This ordinance appropriates \$100,000 from ETR Bonds, Series 2004 (Autumn Bonds) from the Council District 8 Excise Tax Revenue Bond account to assist in funding to construct a building for the Youth Crisis Center, Inc. The bill finds a municipal purpose and waives the requirements of the Autumn Bond, Ordinance 2004-998-E, as amended by 2005-1044-E and Section 106.315, *Ordinance Code*, that bond funds be used on City property and be open to the public. The bill requires that the Youth Crisis Center, Inc. comply with the provisions of Section 106.315 and Chapter 118, Parts 1, 3, 4 & 5, *Ordinance Code*, unless otherwise waived herein. The bill authorizes the Mayor and the Corporation Secretary to execute a contract and appoints the Department of Public Works to oversee the project. Funding shall carryover to Fiscal Year 2007-2008.

Background Information: The Youth Crisis Center, located on Parental Home Road, Council District 4, addresses the needs of children under the age of eighteen (18) who have neither a permanent living facility or life skills training. Over the last 33 years, Youth Crisis Center has sheltered over 1,200 children per year. The Center proposes to build a 40 bed residential unit, New Life Village on land that the Center currently own on Parental Home Road. The program would not only house but also educate and nurture at risk children. The Jaguar Foundation ahs granted \$750,000 contingent upon a City match involving SHIP funds, bond dollars and any other city contribution.

Policy Impact: At Risk Youth

Fiscal Impact: This bill appropriates \$100,000 in District 8 Bond funds.
