**Background Information:** The Jacksonville Ethics Commission is established pursuant to Chapter 602, Part 9, *Ordinance Code*, and empowered to review, interpret, render advisory opinions and enforce Chapter 602, *Ordinance Code*; and, in accordance with Section 1.202, *Municipal Charter*, to exercise the following powers and duties:

- Authorized to receive, and to investigate and issue findings with regard to complaints alleging an ethics violation:
- Provide assistance and input into the management and coordination of the training and education of local officers and employees in state and local ethics, including the City's Ethics Education Program, as well as all public records and sunshine law training throughout the government;
- May, upon employee or citizen complaint, or upon its own initiative, seek information and gather
  facts for the purpose of reviewing any circumstance or situation of which the Commission may
  become aware that appears to violate or may potentially violate an acceptable standard of
  ethics conduct for City officers and employees;
- Jurisdiction to levy those civil fines or penalties authorized in Chapter 602 for violations of the City's ethics code; and
- Act as the hiring committee, subject to Council confirmation, for the executive director of the Ethics Oversight and Compliance office.

Section 602.912, Ordinance Code, provides that one of the nine members of the commission shall be appointed by the Sheriff and confirmed by Council.

Mr. Pritchard received a law degree from <u>Florida State University</u> and is a retired Assistant State Attorney. He resides in Duval County.

**Bill Summary:** The bill appropriates \$900,000 from the Special Law Enforcement Trust Fund to Edward Waters College as a contribution toward the cost of constructing a combination criminal justice education building/police substation on the campus. The bill authorizes execution of a contribution agreement with the college and authorizes a lease and use agreement for the City's use of portion of the building as a police substation.

**Background Information:** The estimated cost of the proposed building is \$2.68 million, of which the Sheriff will contribute \$900,000, Edward Waters College \$750,000 and private donors \$1,030,000. The facility will combine a JSO substation with classroom space for the college's criminal justice program, all of which will be located on the Edward Waters campus in the City's New Town Success Zone. The contribution agreement between the City and the college provides that EWC may hold the City's \$900,000 contribution until such time as sufficient private donations are received to allow construction of the project to begin, but provides for reversion of the funds back to the City if the City and EWC fail to enter into a mutually agreeable lease and use agreement, or if the building is not constructed and the City's contribution utilized for construction costs within 18 months of the effective date of this ordinance.

The proposed lease and use agreement authorizes the City to utilize approximately 7,373 of the 10,500 square feet of space in the building (a portion of the first floor and the entire second floor) as a police substation, along with exclusive use of 30 parking spaces. The City's space will contain a zone commander's office, several lieutenant offices, roll call room, conference room, break room, and waiting area and counter for public transactions with the JSO. The college will be responsible for utilities and maintenance, the City for installation and maintenance of any specialized security equipment. While increased police presence will be a natural result of use of the building as a police substation, the City makes no promise of any increased level of police service to the college. The agreement is terminable by the City upon 90 days written notice, with or without cause.

**Background Information:** The new compressed air refill stations will be National Fire Protection Association-certified and will replace older, non-certified equipment. Twenty seven fire stations currently have NFPA-compliant refill pumps; two stations under construction will have compliant pumps installed. Nineteen stations have non-compliant pumps, and six stations rely on Air-5 (a mobile recharge pump unit) or carry their tanks to other stations for refill. The grant appropriation will provide for the purchase of 10 new refill stations to be located at fire stations 2, 13, 17, 19, 27, 29, 51, 54, 56 and 58. The units were allocated to stations based on the highest number of suppression runs made per year.

If a vehicle's license plate is covered, hidden or otherwise obscured, then Code Enforcement is powerless to determine if the vehicle is properly licensed and therefore is prevented from issuing a citation for the potential violation.

("developer"), HP/CSD, Partners, LLC, and 200 Riverside Avenue, LLP ("owners"); (2) an amended and restated Infrastructure Costs Disbursement Agreement between the City and developer ("Disbursement Agreement"), and (3) related agreements described in the Redevelopment Agreement, for the completion of the public open space, road and utility improvements approved by Ordinance 2007-831-E; authorizes a Recapture Enhanced Value (REV) Grant not to exceed \$4,905,980; waives the public investment policy restrictions on REV Grant terms; invokes the exemption of the Procurement Code, Section 126.107(G), *Ordinance Code*, to authorize direct contracting with the developer; designates the JEDC as contract monitor for the Redevelopment Agreement and the Public Works Department contract monitor for the Disbursement Agreement.

**Background Information:** The economic downturn caused the developer, Hallmark Partners, Inc. and its affiliate, HP/CSD Partners, LLC, to alter the scope of the proposed redevelopment project in Brooklyn that was approved in Ordinance 2007-831-E. In the amended disbursement agreement, the City agrees to complete the road and utility improvements, improvements that the City had previously allowed the developer to make on the City's behalf under the prior agreement. The developer in the new agreement will continue to have the right to complete certain open space improvements on the City's behalf, upon the satisfaction of certain conditions. The stormwater project has been completed. In the amended Purchase and Sale and Redevelopment Agreement, the developer will construct a project that entails apartments, retail units and a parking garage (deleting the previous condominium component) with the assistance of a REV Grant that the City will provide. The REV Grant will not constitute a liability or debt to the City. The Public Investment Policy adopted by Resolution 2006-119-A is waived because the grant does not conform to the policy guidelines for REV grants for downtown residential projects. The waiver enables the current proposed project to proceed and further needed development in Brooklyn.

**Background Information:** The Duval County Research and Development Authority is established pursuant to Chapter 67, *Ordinance Code*, and charged to oversee "First Coast Technology Park", a 285-acre commerce center at the University of North Florida; for the purpose of promoting scientific research and development in affiliation with and related to the research and development activities of one or more state-based, accredited, public or private institutions of higher education; for the purpose of financing and refinancing capital projects related to establishment of a research and development park in affiliation with one or more institutions of higher education, including facilities that complement or encourage the complete operation thereof; and for the fostering of the economic development and broadening the economic base of the county. Section 159.703, *Florida Statues*, provides that members of the Research and Development Authority shall be residents and electors of, or have their principal place of employment in, the county.

Ms. Dion is the President of *Dion Marketing Co.* She has previously served on the Duval County Tourist Development Council. Ms. Dion resides in Neptune Beach within Council District #13.

**Bill Summary:** This bill confirms the Mayor's appointment of Jefree Shalev as a member of the Art in Public Places Committee, as a Planning District #1 community representative, for a first term ending December 31, 2014.

**Background Information:** The Art in Public Places Committee is established pursuant to Chapter 126, *Ordinance Code*, and charged to choose art which is compatible with and which will enhance the architecture and general environment of the City; responsible for receiving, reviewing and acting on the recommendations of the Art Selection Panels; seek to ensure that at least 15% of the artists selected for purchase or commission will be resident(s) in the Greater Jacksonville area (Duval, St. Johns, Nassau, Clay and Baker Counties); will also encourage the selection of regional artists e.g. Florida and the Southeastern United States. Section 126.903, *Ordinance Code*, provides that the members of the committee are appointed by the Mayor, with five of the members representing the community at large, each residing within a different planning district.

Mr. Shalev received a bachelor's degree in architecture from New York Institute of Technology and is a Senior Systems Engineer with *Mayo Clinic*. He resides in the Springfield area within Council District #7 (Planning District #1).

**NOTE:** This bill may need to be amended to correct the name of the body from Art in Public Places Commission, which no longer exists, to the **Art in Public Places Committee**. The bill may also need to be amended to include the correct name of the member being replaced. James Reed Beaubouef was a member of the former commission, but has never served on the current committee.

**Bill Summary:** This bill confirms the Mayor's reappointment of Marvin C. Hill, Jr. as a member of the Planning Commission, as an alternate member, for a three-year term ending October 1, 2014.

**Background Information:** The Planning Commission is established pursuant to Chapter 30, Part 2, *Ordinance Code*, and charged to review proposed land use changes, text changes to the Comprehensive Plan, requests for exceptions, variances and waivers to the Zoning Code, appeals from written orders granting or denying an administrative deviation and written interpretations of the Zoning Code and final orders of the Cell Tower Review Committee and other matters related to land use and area planning which are referred to the Department or to the Commission pursuant to law; review and make recommendations to the Council on proposed changes to the Zoning Code, the Code of Subdivision Regulations and other land development regulations or amendments thereto, and with respect to all rezonings; review and make recommendations on plans and programs developed by the Planning Department; and serve as the local planning agency per 163.3174 F.S. and prepare the comprehensive plan.

Section 30.201(a), *Ordinance Code*, provides for three alternate members on the Planning Commission to be appointed by the Mayor and confirmed by Council. The alternate members shall either be former Planning Commission members or former City Council members who have served on the Land Use and Zoning Committee of the City Council.

Mr. Hill, a retired Architect, received a bachelor's degree in architecture from Auburn University. He served on the Planning Commission from 1999 to 2005. Mr. Hill resides in the Sunbeam area within Council District #5.

**Type of Action:** Repeal of prior ordinance; direction to Council Secretary

**Bill Summary:** The bill repeals prior Ordinance 2011-399-E pertaining to amendments to the General Employees' Pension Plan and directs the Council Secretary to inform the Municipal Code Corporation of the repeal and to prevent the codification of the changes.

**Background Information:** At the end of his second term Mayor John Peyton proposed a package of reforms to both the General Employees' Pension Plan and the Police and Fire Pension Plan which increased the age of eligibility to receive retirement benefits, changed the timeframe for determining final monthly compensation, made changes to the cost of living allowance (COLA) and surviving spouse benefits, and made other changes. Ordinance 2011-399-E regarding the General Employees' Pension Plan was enacted by Council but its application was made conditional upon the passage of 2011-400 which made similar changes to the Police and Fire Pension Plan. 2011-400 has been withdrawn from consideration so 2011-399 will not become effective and is therefore being repealed. The Brown administration intends to propose a new package of pension reforms at a future date.

**Policy Impact Area:** Pension reform

**Fiscal Impact:** At the time of their passage, Mayor Peyton announced that the combined pension modifications in 2011-399 and -400 were estimated to produce savings to the City of approximately \$1 billion over 35 years.

**Type of Action:** Amendment of prior ordinance

Bill Summary: The bill amends prior Ordinance 2007-401-E which established the current Unified Courthouse Program by adding new language to Section 4 – Responsibilities of the Architectural Review Committee, Chief Judge and Council President – to mandate that the Mayor and the members of the Unified Courthouse Project management team must consult with the State Attorney in addition to the Chief Judge and Council President when making decisions about the courthouse and State Attorney's Office design and furnishing. New language is also added urging the Mayor and Unified Courthouse Project management team to move as promptly and efficiently as possible to design and renovate the old Federal Courthouse into the new State Attorney's Office.

Background Information: During the deliberations of the Council's Courthouse Oversight Committee the State Attorney has expressed dissatisfaction with the lack of progress being made on the design and construction of the old Federal Courthouse renovation to house the State Attorney's Office and with the lack of consultation that has taken place with her staff before critical decisions have been made which affect the design and the construction timeline for the building. The Courthouse Architectural Review Committee is currently required to consult with the Chief Judge and the Council President about plans, specifications, designs, and other factors affecting the courthouse project. This bill adds the State Attorney to the list of public officials who must be consulted regarding the progress of the project.
