C. 13-111.

Background Information: The Metropolitan Medical Response System is a component of Jacksonville Fire & Rescue that is trained to prepare communities for major catastrophes, mass casualty incidents or pandemics. The program is funded by the federal government. The federal government awards grants to sixty (60) cities for the MMRS program.

Policy Impact: Jacksonville Fire & Rescue Department

Background Information: Paul Coverdell was a United States Senator from Georgia who served in the Senate from 1992-2000. He suffered a cerebral hemorrhage on a visit to Georgia and died shortly thereafter. He had previously served as Director of the Peace Corps (1998-2000). The Coverdell Forensic Science Improvement Grants Program is named in his honor. The Coverdell program awards grants to states and units of local government to help improve the quality and timeliness of forensic science and medical examiner services. The program is administered by the Research, Development and Evaluation Agency of the U. S. Department of Justice. The equipment purchased with this grant will be used to automate the task of shaking liquid/liquid extraction tubes used for certain drug analyses, thus insuring the uniform treatment of all calibrators, controls and samples that is vital to forensically defensible quantitative results.

Background Information: The appropriation in this ordinance represents grant funds from FDOT for its financial contribution in the National Pollutant Discharge Elimination System (NPDES), Phase 1 Permit #FLS00012-003 Cycle 3 requirements, which includes a Monitoring Plan (MS4 Permit). The City and the Florida Department of Transportation are co-permittees of this national program. The National Pollutant Discharge Elimination system permit requires that FDOT to perform stormwater discharge compliance and water quality assessments, TMDL (Total Maximum Daily Loads) monitoring for nutrient levels in the Lower St. Johns Basin (Duval County), illicit discharge and improper disposal proactive inspections, and other means of monitoring the impairment of waterways. Through the Interlocal Agreement, the City provides services to FDOT as required by the MS4 Permit. Failure to accept the funds from FDOT leaves the City solely responsible for funding the permit requirements.

Background Information: The Council has traditionally appropriated \$3-4 million into the fund per year for the purpose of funding substantial public facility repairs as needs are identified during the fiscal year. The fund had accrued to over \$11 million dollars until the passage of several recent bills to appropriate approximately \$5.2 million for a variety of projects. Background Information: The chairs around the City Council dais in the Council Chamber were purchased by the City Council in 2004 to replace the chairs originally purchased for the Chamber by the Public Buildings Division when the St. James Building was opened as the new City Hall in 1997. After years of daily use by the City Council, its standing and special committees, and numerous other bodies (Waterways Commission, Planning Commission, TRUE Commission, Duval Legislative Delegation, etc.), many of the chairs are in very poor condition. The bill directs that the chairs are to be procured from Office Environments and Services (OES).

Bill Summary: The ordinance regards Chapter 745 (Addressing and Street Naming Regulations), *Ordinance Code*. The ordinance renames Evergreen Drive which extends 520 feet east from San Pablo South to a dead end in Council District 3 to "Beaver Dam Drive"; directs the Legislative Services Division to forward this ordinance to the Planning & Development Department.

Background Information: The Addressing Section of the Planning & Development Department has determined that Evergreen Drive which extends 520 feet east from San Pablo Road South to a dead end should be changed to a new street name. There is no physical connection between that portion of Evergreen Drive accessed form Riverview Drive and the portion accessed from San Pablo Road South. Any attempt to access a property from an incorrect road segment may create a delay in emergency response. The existing road configuration and name for that segment of Evergreen Drive is confusing and inconsistent. The renaming of Evergreen Drive eliminates confusion and allows for precise location of properties having access from the portion of Evergreen Drive that extends east from San Pablo Road South. The Planning & Developing Department requested affected property owners' participation in renaming the roadway. In December 2012, the property owners submitted a written request to the Planning & Development Department to name their road "Beaver Dam Drive." The Jacksonville Historic Preservation Commission reviewed the recommendation of the 911 Emergency Addressing Advisory Committee and determined that there was no historical impact in the name change.

Background Information: The Information Technology Division currently has 3 separate subfunds within its budget for its computer, communications (primarily telephone and Internet), and radio operations. With personnel reductions in recent years, the division has begun combining the personnel in the Information Technologies (computers) and Communications (telephones and associated wiring, WiFi equipment, Internet access lines) divisions to work on both areas as workload dictates. The IT division is developing a new cost allocation model by which to charge user agencies for its services and has determined that accurate billing for these combined workforces would be facilitated by combining the budgets for the two now combined operational units.

Policy Impact Area: ITD operational and budgetary transparency

Bill Summary: The bill modifies Schedule A-2 (Jacksonville Children's Commission budget) to the FY12-13 budget to reflect a reallocation of funding for after-school programs among the various provider agencies.

Background Information: After the Children's Commission submitted its FY12-13 budget proposal, the commission elected to change the method by which it allocated funding for after-school programs to a competitive bidding methodology. The amount of funding for after-school programs remained the same but the allocation among the participating providers changed as a result of the bidding process. This bill amends budget Schedule A-2 to reflect the revised allocations among the agencies.

The City's fiscal year overlaps two school years, so current payments to the provider agencies will continue through the end of the current academic year, then the new payments resulting from the competitive proposal process will take effect. Most of the \$544,030 in changed funding will continue to go to current service providers, with some increases and some decreases. One provider will not be renewed, one provider will lose the contract for two of its current sites, and three new providers will begin service for the next school year.

Policy Impact Area: Budget accuracy

Fiscal Impact: None overall – the bill reallocates existing funding among current agencies in different amounts, and funds several new agencies while other providers see a reduction or elimination of their contracts.

Additionally it removes from Chapter 368 – Noise Control the exemption for fireworks and outdoor musical entertainment events pursuant to Chapter 191, Part 2, which is being repealed.

Background Information: In 2004, in preparation for the 2005 Super Bowl, the City created a Super Bowl Entertainment Zone in the downtown area (Northbank and Southbank) within which various City regulations were temporarily waived during the week of Super Bowl-related activities. The waivers included non-enforcement of the noise ordinance, the open container alcoholic beverage regulations, and the zoning distance limitation on the location of businesses selling alcoholic beverages from churches and schools. After the game the Super Bowl Entertainment Zone was repealed, but Council Member Pat Lockett-Felder introduced an ordinance to re-adopt and expand the portion of the Entertainment Zone that covered A. Philip Randolph Avenue and several blocks of the Eastside neighborhood surrounding A. Philip Randolph Park. The entertainment zone and its three Code waivers is effective for a set of specific events listed in Chapter 191, which includes annual events such as the Florida/Georgia and Gator Bowl football games, all events at the Arena, Baseball Grounds, EverBank Field and the Jacksonville Fairgrounds, and certain events at Metropolitan Park, including "12 ticketed events" which includes privately-produced music concerts.

The repeal of these provisions will have the effect of eliminating the Entertainment Zone as it now exists in the Eastside neighborhood and eliminating any exemptions from the noise ordinance as it is now written.

Bill Summary: The bill authorizes execution of a lease between the City and Demetree Brothers, Inc. for approximately 50,000 square feet of space in the Southgate Shopping Center at 3428 Beach Boulevard for use as the Supervisor of Elections' operations center. The bill authorizes a lease period of 10 years with free rent for the first year and a base rent of \$5 per square foot beginning in year 2 (plus a common area maintenance fee of \$3,750), increasing by 3% per year through year 9. The lease provides for one additional 2-year lease renewal option under the same terms.

NOTE: Although the bill and attached lease refer to a 10 year lease period, the payment schedule attached as Exhibit C to the lease document only shows the lease rates for years 1 through 9. Also, the renewal option in Paragraph 31 of the lease document has a blank where the percentage of annual rent increase for the renewal period is missing.

Background Information: The bill represents another location option for the Supervisor of Elections' operations center should the decision be made to move the facility from its current location at the Gateway Center mall. Several bills pending before the Council propose a specific alternate location, an RFP process to choose a potentially new location, and a renewal of the lease at Gateway Center provided that substantial repairs and upgrades are made to the facility.

Bill Summary: The bill appropriates \$2,040,000 from the Loblolly Wetlands Mitigation Fund to the Jacksonville Zoo and Gardens to pay a portion of the construction cost of the zoo's new Land of the Tiger exhibit. It authorizes the execution of a Funding Assistance Agreement between the City and the zoo for the project and invokes the exception in the City's Procurement Code which allows the City Council to fund a contract without a competitive solicitation process by directing the award of the contract to a particular party in the ordinance that appropriates the funding for the project. The bill amends the 2012-17 Capital Improvement Program to add and authorize funding for the zoo project, and finds that it would be detrimental to the public interest to delay the CIP amendment to the next budget cycle.

Background Information: The City owns the Jacksonville Zoo property and has contracted for the last 40 years with the Jacksonville Zoological Society, Inc. to operate the facility on the City's behalf. The Jacksonville Zoo is in the process of beginning construction on a new \$9.5 million expansion of its Asia Precinct on the Trout River waterfront which will feature Sumatran tigers, hornbills, Asian small-clawed otters and other Asian species to help celebrate the zoo's upcoming 100th anniversary. This bill proposes to fund \$2,040,000 of the construction cost via an appropriation from the Loblolly Wetlands Mitigation Fund. That fund was created in 2003 in conjunction with the purchase of 4,878 acres of land on the Westside and the formation of the Loblolly wetlands mitigation bank to provide wetlands credits to mitigate for the effects of Better Jacksonville Plan projects on regulated wetlands. The enacting legislation provided that credits would be applied first to BJP projects, then "excess credits" could be sold to other users and the revenues deposited into the mitigation fund for future capital improvements for conservation and park uses, or as otherwise appropriated by City Council.

The City's Procurement Code provides that certain procurements can be done without a competitive solicitation or bidding process if the ordinance appropriating the project funds specifically directs the funding to a named entity. That exception is being invoked to directly authorize the Jacksonville Zoological Society to undertake the construction project without a competitive procurement process through City Procurement.

Bill Summary: The bill waives certain provisions of Ordinance Code Chapter 368 – Noise Control and Environmental Protection Board Rule 4 – Noise Pollution Control to waive application of the City's noise regulations to outdoor musical entertainment events held during a specified Activity Period in Metropolitan Park during the month of April 2013. The bill waives all civil and criminal penalties associated with violations of the noise ordinance and EPB Rule 4 regulations for the specified events during the specified activity period. The bill directs the City's Environmental Quality Division to measure and record sound levels both inside Metropolitan Park and at various locations in surrounding residential neighborhoods during the specified events. The bill establishes the Activity Period for the waivers as 9 a.m. to 11 p.m. on Saturday, April 13 and 9 a.m. to 10 p.m. on Sunday, April 14 in connection with the Jacksonville Boat Show, and 9 a.m. to 11 p.m. on Saturday, April 27 and 9 a.m. to 10 p.m. on Sunday, April 28 in connection with the Welcome to Rockville concert. The bill requests emergency adoption of the waivers to take effect before the beginning of the first event.

Background Information: The Metro Park and Urban Parks Ad Hoc Committee proposed this waiver as a temporary step in the larger process of determining how to utilize Metropolitan Park for large-scale events while at the same time protecting surrounding neighborhoods from the noise generated by those events. The sound level data collected from these two events, both inside the park at the sound mixing board and outside in the neighborhoods, will provide a baseline of data that will help the City establish future limits on sound production inside the venue that will produce the desired sound levels at the receiving properties.

Policy Impact Area: Noise regulation; special events and park utilization

Fiscal Impact: The Environmental Quality Division estimates the cost of personnel to monitor sound output from the Welcome to Rockville event at \$2,346.96 for 4 personnel working 12 hours per day for both days of the event and the cost for the Boat Show at \$285.32 for 3 personnel working 2 hours per day for both days of the event.
