The bill provides that the funds carryover to Fiscal Year 2008-2009, which authorizes expenditure of the appropriated funds for the water taxi station following a review of the Site Selection Feasibility Studies by the Jacksonville Waterways Commission, the JWC's submission of its recommendation(s) for water taxi sites to Council, and the Council's approval of the JWC's site selection recommendation. The bill amends the 2007-2012 Five-Year Capital Improvement Program, approved by Ordinance 2007-814-E, to establish Priority 1 Status for the "Water Taxi Station at Alimacani Boat Ramp" project. The Mayor and Corporation Secretary are authorized to execute and deliver documents and take further action to implement the legislation. The bill provides that the Department of Recreation and Community Services shall provide oversee the project. The site is located in Council District 11.

**Background**: Ordinance 2005-60-E appropriated funds from FDOT to fund water taxi stations. Subsequently, CH2M HILL conducted a feasibility study on proposed water taxi station sites located on the west bank of Fort George River in the Timucuan Preserve. The Alimacani site is near the Alamacani RV Park. The feasibility study focused on the overall feasibility of a water taxi station at the site including accessibility to the station by both land and water, potential impacts resulting from the construction of the water taxi station. The appropriated funds are for the design and construction of dock facilities, parking areas, lighting, pedestrian walkways and the construction or renovation of passenger amenities such as shelter, restrooms, waiting areas, administrative offices supporting ticketing/fare collections at the water station. The Recreation and Community Services Department endorses the study recommendation.

**Bill Summary:** The bill amends Ordinance Code Chapter 320 – Building Code, General Provisions – to provide for the suspension of building permits if no inspections of work performed pursuant to the permit are scheduled for a period of 180 days. Such suspended building permits may be reactivated for an additional 180 days upon a permit holder showing just cause and paying a \$20 reactivation fee. A contractor holding 4 suspended permits shall not be eligible to apply to the City for any additional permits until all suspended permits have been reactivated by the payment of the required reactivation fees and the contractor has personally appeared in the Building Inspection Division office and paid a \$250 Reinstatement Fee. The bill deletes the current language revoking a building permit if no work is done within 6 months and requiring an application for a new permit to restart work.

The bill also amends the Building Code to require that all repairs, renovations or alterations of existing pools or spas, including waterfalls, water features and fountains, must be contracted by a state certified or registered pool/spa contractor and must be permitted by the City. Repairs, renovations and alterations of swimming pools and spas at single-family homes are exempted from required plan review and inspection by the Building Inspection Division and are subject to a new \$5.00 permit fee.

The bill lowers the threshold value below which roofing repairs and re-roofing do not require City plan review and inspection from \$5,000 to \$2,500.

Background Information: According to the Chief of Building Inspection, the Construction Trades Qualifying Board suggested the permit suspension and reactivation process and fee as a way of assisting citizens and businesses whose contractors have abandoned their job by giving the Building Inspection Division greater "teeth" to enforce sanctions against contractors who have numerous outstanding but inactive permits. The permit and inspection requirement for repairs, renovations or alterations of swimming pools and spas was requested by swimming pool contractors who believe that some of this work is being done locally by unlicensed contractors who can escape detection because, although state law requires the work to be done by a licensed contractor, there is no inspection requirement. The reduction in the threshold for plan review and inspection of roofing work was requested by the local roofing contractors association to combat a practice of unscrupulous contractors understating the cost of roofing jobs to less than \$5,000 to avoid plan review and inspections.

Pending bills 2008-729 through 2008-739 reappoint the existing members of the Housing Commission and Housing Finance Authority to the newly formulated boards.

NOTE: The appointment resolutions refer to appointment of the existing board members to the new boards to fill unexpired terms of varying lengths – if the members are deemed by this ordinance to have resigned their seats then legal clarification may be in order to determine if it is proper to appoint the members to unexpired terms on a newly-created board.

NOTE: Sec. 159.605, F.S. relating to housing finance authorities states that "Each housing finance authority shall be composed of not less than five members appointed by the governing body of the county for which the housing finance authority is created..." (emphasis added). Sec. 420.9076, F.S. relating to affordable housing advisory boards states that "The governing board of a county or municipality shall appoint the members of the affordable housing advisory committee by resolution." (emphasis added). The two current boards and two proposed boards are composed of a majority of members appointed by the Mayor and confirmed by Council and a minority of members appointed directly by the Council.

The bill says that the wastewater discharge pipeline will result in environmental harm to the St. Johns River and that the 2002 permit did not take into account scientific and technological advances in evaluating the permit renewal and what the pipeline discharge entailed regarding the health of the river.
