Bill Summary: This bill grants the petition to amend the boundary of Cypress Bluff Community Development District approximately 24.19 acres to the Cypress Bluff Community Development. Chapter 92, Section 92.22 *Ordinance Code* is amended to reflect the additional boundary acreage.

Background Information: Pursuant to Chapter 92, *Ordinance Code*, and Sec. 190.046, F.S., the Board of Supervisors of the Cypress Bluff Community Development District, has by District Board Resolution 2019-07, petitioned the City of Jacksonville to amend the District's boundaries to add approximately 24.19 acres to the District. The required fee to defray the City's cost of review and consideration related to the Petition to Amend the Boundary of the Cypress Bluff Community Development District has been paid. The Office of General Counsel prepared the Final Report of Counsel, which states that the Petition is sufficient and complete to permit the fair and informed consideration of the matter by the City Council. City Council has considered the Petition in light of the record developed at the public hearing and finds there is good reason to grant the request as petitioned.

The bill amends the CIP to provide funding for the project entitled "Bethesda Park - Adaptive Kayak Launch." The Department of Parks, Recreation and Community Services will oversee the project. The bill authorizes the Mayor to deliver the Grant Award Letter.

Background Information: The proposed adaptive launching system includes a unique gangway with kayak chute connected to a floating dock with kayak cradle, transition seat, grab bars, and straps to assist the launching of kayaks for people of a wide variety of abilities. In addition, the project will include improvements and expansion of the existing sidewalk that connects to the existing accessible parking area.

Policy Impact Area: Appropriation of funds, Jacksonville Waterways, Parks & Recreation

Fiscal Impact: The funding is a grant in the amount of \$25,000.00 from the Christopher and Dana Reeve Foundation and a City match of \$57,850.00 from the ADA funds of the Department of Parks, Recreation and Community Services in FY19-20. The grant period runs from 6/1/2019, through 5/31/2020. The funds appropriated will not lapse and will carryover from year to year until completion of the project. Existing Parks staff will maintain the kayak launch which should involve minimal ongoing cost.

Bill Summary: The bill waives Sections 260.201 (License), 260.206 (Temporary storage of waste tires), and 260.208 (Hours of operation) of Part 2 (Licensing and Transporting Requirements; Revocation of License) of Chapter 260 (Disposal of Waste Tires) of the Ordinance Code for the 2019 Waste Tire and Snipe Sign buyback event from September 14, 2019, to September 28, 2019. The Department of Public Works will oversee the event.

Background Information: The Department of Public Works is requesting legislation to waive certain portions of Ordinance 260, Part 2 that governs waste tire transporter and generators in Duval County that will allow Duval County residents the opportunity to participate in the event to earn reward money for the collection of waste tires and snipe signs from COJ right-of-ways and public properties where these materials are either illegally placed or dumped, and from private properties where these materials may end up being dumped on public properties. The nature of the emergency is that scheduling conflicts with other events at Lot J and adjacent City venues did not allow for the sufficient time period from Friday to Sunday to set up, take down and hold the event until later in the fiscal year when Lot J became available.

Policy Impact Area: Ordinance Code Waiver, COJ right-of-ways, Public Works

Fiscal Impact: Funding totaling \$150,000 was approved in FY18-19 budget within the General Fund for the Sixth Annual Waste Tire and Snipe Sign Buyback. The funds are used for the advertisement of the event, expenses for the event such as tents, chairs, rental of Lot J at TIAA Bank Field, vendors for food, water, lunches, printing supplies, gloves, safety vests, transport and disposal of the waste tires and snipe signs, reward monies for Duval County residents who bring in the tires and signs and for overtime of COJ personnel to staff the event. There is no funding match requirement. The funds will be used to conduct the event on September 28, 2019. There is no maintenance cost with this legislation and staffing is allocated within the budget. There are no post construction costs associated with this event.

Bill Summary: The bill appropriates a \$12,462,500 grant from the Florida Department of Transportation for the demolition of a portion of the elevated Hart Bridge Expressway between Liberty Street and Festival Park Avenue and the construction of a new ramp at A. Phillip Randolph Boulevard and at-grade intersection with Gator Bowl Boulevard. It authorizes the execution between the FDOT and the City of Jacksonville of a Local Agency Program Agreement for use of the funds and a Roadway Transfer Agreement for the City to assume ownership of certain rights-of-way. The bill amends the 2019-2023 Five-Year Capital Improvement Program to provide funding for the project entitled "Hart Bridge Ramp Modification." The Engineering and Construction Management Division of the Department of Public Works is designated as the City's oversight agency.

Background Information: The project will demolish the elevated expressway in order to facilitate the development of the Lot J, Metropolitan Park and Jacksonville Shipyards properties, increase the pedestrian friendliness of the Sports Complex area with improved pedestrian and bike paths, traffic calming features, improved signalization, etc. Upon completion of the project the City will own, operate and maintain all rights-ofway, structures and facilities associated with the project. The project will be constructed under a design-build contract, with construction beginning in the first quarter of 2020 and being completed by the end of 2021.

Policy Impact Area: Downtown redevelopment

Fiscal Impact: The bill appropriates a state grant of \$12,462,500, which will be matched with City funding of \$12.5 million (borrowed funds) and a federal grant of \$12.5 million. Total project cost is estimated at \$38.9 million, with \$1.5 million being provided from other available City funds for the preparation of the design criteria package.

Bill Summary: The bill repeals previous Ordinance 2017-433-E, which authorized an easement agreement between Southbank Apartment Ventures, LLC and the City of Jacksonville, and authorizes a new agreement granting the City easements over portions of the company's property on the downtown Southbank for construction of an extension of the existing Southbank Riverwalk. The Department of Parks, Recreation and Community Services is designated as the City's oversight agency for the project.

Background Information: In 2017 the City entered into an easement agreement with Southbank Apartment Ventures that would allow for the construction of an extension of the Southbank Riverwalk to the west across the company's property where a new apartment building is to be constructed (on the parking lot between the One Call building – formerly the Aetna building – and the FEC Railroad bridge). The owner of the One Call building appealed the regulatory approvals for construction of the new apartments and the parties eventually reached a settlement agreement to reduce the number of apartments to be constructed. As a result of the project being redesigned pursuant to that settlement, the former easement agreement needs to be abandoned and new easements granted to the City. The agreement provides for a 20 foot wide easement (accommodating a 12 foot wide path and 8 feet of landscaping) from Prudential Drive to the riverfront adjacent to the FEC railroad line, a 20 foot wide easement (accommodating a12 foot wide multi-use path and 8 feet of landscaping consisting of a minimum 2 foot wide grass strip adjacent to the curb and the remainder on the interior side of the path) along the northerly border of Prudential Drive, and the expansion of the existing portion of the Riverwalk along the Southbank of the St. Johns River running through the Property from its current width of approximately 5 feet to a total width of 20 feet.

The closure will not hinder any other improvements on-site and can be removed after the site is free of contamination.

Bill Summary: The bill appropriates \$4,084,269 from the Environmental Compliance – Countywide Account to the Confederate Park – MGP Waste Remediation Account to fund activities involved in the cleanup of manufactured gas plant waste required by the Brownfield Site Rehabilitation Agreement between and among the Florida Department of Environmental Protection (FDEP), the City of Jacksonville, Southport Financial Real Estate, LLC, Jacksonville Hospitality Holdings, L.P., and Shoppes of Lakeside, Inc. The bill amends the 2019-2023 Five-Year Capital Improvement Program to reduce funding for the project entitled "Environmental Compliance - Countywide" and provide funding for the project entitled "Manufactured Gas Plant Waste Remediation".

Background Information: The bill authorizes the transfer of existing debt authorization from a non-site-specific countywide environmental remediation project to fund the specific Manufactured Gas Plant Waste Remediation project. From approximately 1874 to 1912, there was a private manufactured gas plant located on the corner of State Street and Main Street, which deposited its waste into nearby Hogan's Creek in what is now Confederate Park. Once the contamination was discovered, the FDEP required the City to conduct a remedial investigation and feasibility study. The City has entered into a multi-party Brownfield Site Rehabilitation Agreement (BSRA) among the surrounding property owners that spells out what actions, documents and time frames for the documents that need to be submitted to the FDEP. The remedial action plan has not been prepared yet. A feasibility study was done as part of the ramp up to the BSRA that reviewed various technologies that could be used to clean the site up and ranked them accordingly to cost and effectiveness to reach cleanup goals and the City is currently doing a work plan (that has four components) that is determining geochemical and geophysical data that will be used to design the remedial action plan. For now the current anticipated plan from the feasibility study is to do a hydraulic containment system with a groundwater treatment component to reduce or eliminate the impacted groundwater plume.

The program's three components are the detection and interruption of potentially violent conflicts; the identification and treatment of highest risk; and the mobilization of the community to change norms.

The appropriation will fund the ongoing implementation of the program, training and technical assistance, site operations and other activities to sustain the execution of this violence reduction strategy.

Bill Summary: This bill repeals Chapter 111, Part 3, Section 397, *Ordinance Code* which relates to the Sheriff's Red Light Safety Revenue Fund. Chapter 636, Part 4, *Ordinance Code*, which refers to Red Light Violations, is also repealed.

Background Information: In 2013, the City of Jacksonville contracted the company Redflex to install red-light cameras at the most congested intersections in town -- 37 total on either side of the St. Johns River. However, in 2017, the contract was not renewed in light of a report from the Department of Highway Safety and Motor Vehicles that showed red-light cameras were not making the roads safer. According to that study, crashes increased by more than 10 percent after red-light cameras were installed. The purpose of this legislation is to repeal portions of the *Ordinance Code* which refer to the JSO Red Light Camera Program, which was discontinued June 30, 2018.

Bill Summary: This bill approves the Memorandum of Understanding between the Fraternal Order of Police Lodge #5-30 and the City of Jacksonville. The MOU raises the administrative fee charged to secondary employers by fifty cents, which will be remitted to the FOP Foundation Trust Fund. Articles 31.2 and 32.2 in the FOP Police collective bargaining agreements will be modified accordingly. The MOU was overwhelmingly ratified by the FOP police membership.

Background Information: The secondary employment must be related to public or private security services where the police officer is in a position to use real or implied police authority, uniform and equipment to prevent and/or detect crime or to enforce laws. The hourly rate, paid to the officer, for secondary employment is \$33/hr for Officers and \$36/hr for Supervisors. Currently, for any JSO employee working secondary employment, the secondary employer pays to the Jacksonville Sheriff's Office an administrative fee of \$5.00 per hour for each hour paid. With this legislation, the fee will increase to \$5.50 per hour for each hour paid. The FOP Foundation will use the funds from the administrative fees from secondary employment for the training of FOP members, contributions to other local non-profit corporations, and/or a Fallen Officer Relief & Welfare Fund.

Policy Impact Area: Fraternal Order of Police Foundation

Fiscal Impact: The administrative fee is a pass through from secondary employers and does not create any additional cost to the City.

Background Information: The Jacksonville Sheriff's Office is requesting this legislation to reflect recent changes in the Florida Statutes regarding the Florida Contraband Forfeiture Act. All sums collected as a result of settlements made pursuant to cases prosecuted under the Florida Contraband Forfeiture Act will be credited to the Sheriff's Vehicle Maintenance Fund and shall be used for the acquisition and maintenance of vehicles forfeited to the Office of the Sheriff. An annual report from the Budget Division of the Jacksonville Sheriff's Office regarding the Florida Contraband Forfeiture Act must be submitted to FDLE and City Council by December 1st each year.

Bill Summary: The bill authorizes execution of a redevelopment agreement between the City and Blue Cross and Blue Shield of Florida, Inc. (Florida Blue) for the design, construction and public use of a parking garage in the Brooklyn area of the Northbank Downtown Community Redevelopment Area. It conveys by quit-claim deed from the City to Florida Blue a 2.3-acre parcel of land on Forrest Street. The bill approves a restrictive covenants and parking rights agreement between the City and the company for use of the parking garage by the general public on weeknights, weekends and national holidays. It designates the Downtown Investment Authority as contract monitor and the Department of Public Works as the oversight agency for the project.

Background Information: Under the terms of the agreements, the City will convey to Florida Blue, at no cost, a 2.3 acre parcel of land along Forrest Street between Park and Magnolia Streets, currently a stormwater retention pond appraised at \$3.17 million. Florida Blue will construct a \$21 million parking garage with at least 750 spaces to serve its employees in a nearby building. Upon completion of the garage, the City will provide a parking facilities grant of \$3.5 million, in consideration for which the garage will be available to the general public for parking after 6 p.m. on weekdays and all day on weekends and national holidays. The Florida Blue employees currently park in a surface parking lot on the south side of Riverside Avenue, east of Gefen Park and the old Fire Station #5 site. When the garage is complete, those employees will shift from the surface lot to the garage, freeing up that waterfront parcel for commercial redevelopment, which the Downtown Investment Authority has recently approved, pending the successful development of this new garage.

Policy Impact Area: Brooklyn area redevelopment

Fiscal Impact: This bill conveys a parcel of land valued at \$3.17 million to Florida Blue at no cost, and commits to a future \$3.5 million parking facilities grant not appropriated in this bill. The new garage will be privately owned and taxable, and the vacation of the surface parking lot on Riverside Avenue will free up that land for commercial redevelopment, both of which will increase the City's ad valorem tax revenues.
