**Bill Summary:** The bill approves an economic development agreement between the City and Uptown Signature Development, Inc. for the construction of a mixed use commercial and residential development on Max Leggett Parkway at Owens Road in the JIA CRA tax increment district and the creation of at least 20 new full-time jobs. The City commits to funding a Tax Increment District Infrastructure Grant of \$200,000 and a Recapture Enhanced Value (REV) grant of up to \$1.75 million. The bill designates the Office of Economic Development as the City's oversight agency for the project and requests fast-track adoption on second reading after one committee cycle.

Background Information: The proposed project will consist of a retirement/nursing home, offices, restaurant, bank, warehouse/flex space, multi-family/senior living facility and a gas station/convenience store on 162.56 acres on Max Leggett Parkway north of the River City Marketplace complex. The \$200,000 infrastructure grant is conditioned upon proof of private investment of at least \$4 million in project infrastructure consisting of roadways, water, sewer, electricity, gas, lighting and stormwater management facilities for the project. The REV grant of \$1.75 million represents 50% of the incremental increase in taxable value of the property for 10 years after the property begins paying taxes on the new development. The 20 new full-time jobs to be created by the project (which are a condition for receipt of the TID infrastructure grant, but not of the REV grant) do not carry any specific salary requirements. The developer's JSEB good faith participation goal is \$370,500 or 19% of the City's maximum financial contribution to the project. A motion by the JIA CRA Advisory Board to recommend this project to the City Council failed on a 2-2 vote.

The current budget for July 2016 through June 2017 originally provided for \$2,001,969.59 in reimbursement to the City. A subsequent inventory by FDOT has determined that the City is actually maintaining and powering 753 more lights than the 8,343 lights that were originally budgeted. This bill appropriates an additional \$180,688.37 (\$266.62 per fixture x 753 fixtures) in FDOT contractual funding.

Policy Impact Area: Contract street light operations

**Background Information:** Ordinance 2014-667-E established a trust fund to account for donations and contributions of money, including gifts and grants received by the City, for use in furthering the goals of installing, making, signage and/or devices necessary for a crosswalk installation. AARP donated \$3,000 to support the City's efforts in this regard. The Hartley Rd Mandarin Senior Center expansion project is currently underway and this location has been identified as a high priority area to provide a rapid flashing beacon pedestrian crosswalk to ensure the safety of pedestrians going to or coming from this highly utilized facility. Once the work is complete, all unspent donation funds will revert to the Un-Signalized Intersection Crossing (Crosswalk) Trust Fund.

**Bill Summary**: This bill appropriates \$144,214.00 from the General Fund – GSD Fund Balance to General Fund – Reserve for Federal Programs, as initiated by B.T. 17-038, to cover the City's required 10% match of a 2016 FEMA Assistance to Firefighters Grant (AFG).

**Background Information:** The Fire and Rescue Department received a grant from FEMA in the amount of \$144,214 for the purchase of 53 power load stretchers. These loaders will improve the safety of the firefighter and patient by providing support throughout the loading and unloading process from an EMS transport unit.

The Public Health & Safety Committee amended the Ordinance 2016-598-E on October 4, 2016 to switch the fiscal year from 2016 to 2017. This appropriation will properly align the FY17 reserves for federal programs considering that the match was intended to come from the FY16 reserve balance.

The local match for the grant was intended to be paid from the 2016 budget for grant matches that had a sufficient remaining balance to cover the match amount. When the bill was amended in committee to change the fiscal year of the match from 2016 to 2017 it left the match amount for this grant in the FY16 swept fund balance account and took the match from the FY17 grant match account which reduced the amount available to match grants in the current fiscal year. This bill returns the grant match for the 2016 grant to the FY16 budget fund balance account, restoring the ability of the FY17 appropriation to cover all anticipated 2017 grants.

**Background Information:** The reallocation of small amounts of residual funding from scores of completed projects will provide supplemental funding for two existing projects – Drainage System Rehabilitation (\$49,660.71) and Public Buildings Security – Don Brewer Center Camera Installation (\$89,999.81). It will also provide funding for 3 new CIP projects; A. Philip Randolph Boulevard at Bay Street floating dock (\$175,000); JRFD Tactical and Support Logistics Facilities Consolidation (\$100,000) and Countywide Parks Maintenance and Upgrades (\$506,947), and will appropriate \$435,001 already allocated in a ShotSpotter reserve account to an equipment purchase account for installation of the test site. The A. Philip Randolph Boulevard floating dock will provide a new boat dock to serve the Sports Complex area. The JFRD logistics facilities consolidation project will move the current Logistics Support Facility from JFRD headquarters on Julia Street into the existing Tactical Support Facility on Ellis Road at Highway Avenue to centralize the delivery and pickup of uniforms, medical supplies, equipment and other items and the maintenance and repair of equipment and apparatus for greater efficiency. The ShotSpotter pilot project will install acoustic gunshot detection and surveillance technology in a 5 square mile area of Health Zone 1. The Countywide Parks Maintenance and Upgrades project will provide funding for repairs and upgrades at existing parks, including such items as fencing replacement, playground equipment replacement, gym floor resurfacing, restroom renovations, safety lighting, trail repairs and drainage improvements.

**Background Information:** This lease provides approximately 440 square feet within the Duval County Courthouse to 121 Financial Credit Union for the purpose of offering financial services to its customers on the 1<sup>st</sup> floor of the Duval County Courthouse. Additionally, it provides approximately 100 square feet for an ATM kiosk, also located on the 1<sup>st</sup> floor of the Courthouse. This is a five (5) year lease with one (1) option to renew for five (5) years. The initial Base Rent is \$23.64 per square foot, plus Operating Costs of \$4.86 per square foot, and both are subject to 3% annual escalation rate, as shown in the Rent Schedule attached to the Lease Agreement. The credit union is located in Council District 7.

**Bill Summary:** The bill adopts an inventory of City surplus properties deemed to be appropriate for potential use of affordable housing purposes, declares 101 of those parcels to be surplus to the City's needs and authorizes their disposition to entities willing to use them to produce affordable housing stock pursuant to the City's affordable housing process.

**Background Information:** State law requires each county to produce a listing every 3 years of all county-owned property (vacant or improved) that is suitable for affordable housing purposes and to make those properties available to private for-profit developers or non-profit housing organizations for the purpose of producing new affordable housing stock. Ordinance Code Section 122.463 requires the City Housing Division to file legislation with the Council each December to adopt an Affordable Housing Inventory List developed by the Real Estate Division. This year's affordable housing inventory encompasses 101 parcels of city-owned property in Council districts 7, 8, 9, 10 and 14 with a total assessed value of \$783,010. The parcels range in value from \$140 for a 35 by 95 foot vacant lot to \$59,509 for a single family house. The vast majority of the listed properties were acquired by tax reversion. The properties are declared to be surplus to the City's needs and are authorized for disposition by sale or donation according to the Ordinance Code provisions for affordable housing purposes.

**Fiscal Impact:** The total assessed value of the 101 parcels is \$783,010.

**Bill Summary:** The bill authorizes the execution of a Memorandum of Understanding (MOU) between the City and the JAXUSA Partnership of the Jacksonville Regional Chamber of Commerce for management of an export enhancement plan initiative and for development of a Foreign Direct Investment Strategy to implement strategies developed through Jacksonville's participation in the Global Cities Initiative. The MOU authorizes a contractual payment to JAXUSA of \$60,000 in FY16-17. The Office of Economic Development is designated as the City's oversight agency for the project.

Background Information: In November 2013, Jacksonville was chosen as one of the first 8 cities (now up to 27) to participate in the Global Cities Initiative, a program created by the Brookings Institution (a Washington "think tank") and JPMorgan Chase (a global financial services company) to encourage international trade and foreign investment in metropolitan areas around the United States. In December 2014 an Export Markets Assessment was produced by a regional working group and in April 2015 the Metro Jacksonville/Northeast Florida Export Plan was completed. This MOU formalizes an agreement between the City and JAXUSA Partnership for the Partnership to begin implementing the export plan on behalf of the City. The MOU calls for JAXUSA to establish a "one-stop shop" to provide interested businesses with information, research and assistance in developing export activities; to create a Global Cities Advocacy Team to lead the implementation effort; to conduct outreach activities to at least 25 potential export businesses; to recruit businesses currently exporting products and services to serve as mentors to businesses considering export activities; to provide research on existing export development programs and create an Export Directory; and to market Jacksonville and Northeast Florida as an area for export and international investment as part of JAXUSA's overall marketing outreach program.

The ordinance says the MOU is for 1 year with an option for a 2-year renewal; however the attached MOU does not appear to contain any provision for renewal. The ordinance also states that the purpose of the MOU is to implement the Phase 1 Export Plan and begin the development of Phase 2 – a Foreign Direct Investment Strategy (FDIS); however the MOU does not appear to contain any reference to the FDIS.

The bill declares that the revenue bonds are not a liability of the City and the City does not endorse or recommend the borrower or the creditworthiness of the project.

**Background Information:** Capital Trust Agency, Inc. is a not-for-profit corporation that issues tax-advantaged revenue bonds to assist in the financing of capital improvements for governments (such as public buildings, recreational facilities, social service facilities and public safety facilities) and for private entities (schools, child care facilities, medical facilities and the like) as permitted by state law and pursuant to Internal Revenue Service tax regulations. Validus Senior Living REIT Investment Company, LLC, the developer of "Inspired Living at Jacksonville" intends to construct 109 assisted living units and 43 memory care units using the proceeds of the revenue bonds issued by Capital Trust Agency. The City of Jacksonville's consent is required for the use of the proceeds of tax advantaged bond issued by another entity within its jurisdiction.

**Bill Summary**: The resolution urges the Florida Legislature and Cabinet to dedicate conservation funds for water conservation projects in the environmentally sensitive areas of North and Central Florida and to provide fair and equal funding statewide from the Land Acquisition Trust Fund for important water protection projects; directing the Legislative Services Division to forward copies of this adopted resolution to the Florida Legislature and Cabinet.

Background Information: With an overwhelming majority, Florida voters passed the Florida Water and Land Conservation Amendment that provided a guaranteed source of conservation funds for the purpose of protecting all of Florida's vital water resources. The Florida Department of Environmental Protection has found that eighty percent of Florida's lakes and seventy percent of Florida's springs are considered impaired by excessive levels of nutrients like nitrogen and phosphorus. In 2016, the Everglades and southern estuaries received 380 percent, or 4.8 times more Land Acquisition Trust Fund funding than statewide springs protection; a supermajority of conservation funding being dedicated to one project or Water Management District will jeopardize funding for other essential projects and priorities. This resolution implores the Legislature and the Cabinet to allocate conservation funds through the Acquisition Trust Fund each year for water conservation projects in the environmentally sensitive areas of North and Central Florida.

**Bill Summary:** The bill expresses the Council's support for local legislative bill J-3 that would amend Chapters 563 & 564, Florida Statutes, to amend the application of the term "premises" for beer and wine licenses issued to establishments located contiguous to or within areas within which open container restrictions on alcoholic beverages are waived pursuant to Jacksonville's Ordinance Code Chapter 191.

**Background Information:** Section 191.203 – Waiving provisions of Chapter 368 – of Ordinance Code Chapter 191 – Special Events and A. Philip Randolph Entertainment District – provides for a waiver of the open container restrictions on alcoholic beverage consumption within the A. Philip Randolph Entertainment District during a list of 15 designated "special events" and any other event designated as "special" by the City Council. Legislative bill J-3 would amend the Florida Statute chapters regulating beer and wine sales and consumption to provide that for purposes of the application of the state law, the open container law exemption in Jacksonville's special events district shall apply to "premises" licensed for "consumption on premises" that are either within or located contiguously to the A. Philip Randolph Entertainment District.

The bill is intended to clarify the special event open container exemption as it applies to the new Intuition Ale Works located at the corner of A. Philip Randolph Boulevard and Bay Street. The front third of the building along A. Philip Randolph Boulevard is within the Entertainment District, while the rear two-thirds of the building is not within the district. The "contiguously to" language within the bill would make the entire facility eligible for the open container exemption during designated special events.

**Bill Summary**: This resolution supports the vacation of a portion of the plat of Jacksonville Heights, pursuant to Section 177.101(3) *Florida Statutes*; returns a portion of the lands shown on said Jacksonville Heights Plat to acreage; abandons certain unopened roads within the boundaries of the Jacksonville Heights Plat that have not been opened and have not become roads suitable and necessary for the traveling public; and ensures legal access to abutting properties.

**Background Information:** *Florida Statutes* authorizes the governing bodies of municipalities and counties to adopt resolutions vacating plats of subdivisions and returning the property to acreage. Jacksonville Heights plat is recorded in Plat Book 5, Page 93 in the current public records of Duval County, and encompasses lands west of downtown Jacksonville adjacent to Lane Avenue and Wilson Boulevard. This site is located in Council District 9. The rights-of-way described in the survey, project number 4FER-J1, are presumed to be dedicated public rights-of-way; however, none of the platted rights-of-way located within the lands described in the survey were ever opened, improved or accepted by the City for maintenance. In addition, the rights-of-way have not become highways suitable for the traveling public.
