The automatic co-sponsor provision was added several years ago to simplify the former process of council members informing the Chief of Legislative Services in writing or by e-mail of their desire to co-sponsor a particular resolution. Frequently such resolutions ended up being amended on the floor at the time of final passage to add all council members' names as sponsors.

**Background Information:** The recent revision to Ordinance Code Chapter 118 – Public Service Grant Criteria – provides that the Council shall, on or before January 15 of each year, establish one or more "priority populations" to be specifically targeted for assistance through the public service grant process. This information will be provided to the Public Service Grant Committee to guide its review of PSG applications and funding decisions, which will be presented to the City Council for approval during the annual budget process.

The bill provides an exception to the 3-year maximum funding rule for programs that deliver services determined to be an essential function that would otherwise be performed by the City. The bill also provides for public service grants to be made to public or governmental agencies in addition to private agencies. The bill also provides that the 24% limitation on public service grant funding as a percentage of a recipient agency's budget shall be calculated as an average figure over the 3 previous years. Finally, the bill adds a provision requiring that public service grant recipients be performing services or operating programs in Duval County.

NOTE: The bill may need correction of scrivener's errors on page 4, lines 18 - 21, where paragraph 118.203(b) appears to be duplicated, and on page 4, lines 29 - 30 where previously existing language is underlined as new language.

**Background Information:** The bill makes further refinements and clarifications to the re-write of Chapter 118 passed in January to recognize the different types of agencies and programs that are funded by public service grants and to provide for a revised timetable for implementation of the grant council and the Council's adoption of priority populations for the first year of operation of the new system.

The relocation would entail IBA hiring 20 new full-time positions within 36 months at an expected average wage of approximately \$85,000. There are clawback provisions in the event that the developer does not create the committed number of jobs at the salaries and by the deadline stipulated in the Development Agreement.

The amended definitions include a revision to the definition of "impervious area" to include compacted and semipervious (clay and gravel) road surfaces. A new definition of "owner" is included, which may include a tenant in a rental unit if the lease agreement provides that the fee is payable as a maintenance fee. The definition of an "equivalent residential unit" of 2,443 square feet is deleted and replaced with a "single family unit" of 3,100 square feet as the basic unit of fee computation. The definition of "stormwater management facility impervious area factor" is deleted. The definition of "stormwater management system" is amended to include TMDL compliance requirements. New definitions of "TMDL", "user fee or service charge", "user fee adjustment", "user fee credit" and "user fee reduction" are added.

The existing schedule of fees for residential properties is expanded from 3 categories (under 1,800 sq. ft. of impervious area [0.5 ERU], 1,800 to 3,400 sq. ft. [1 ERU], and over 3,400 sq. ft. [1.5 ERU]) to 6 categories:

- Single-family detached residential 1,549 sq. ft. of impervious surface or less 0.5 SFU (\$2.50/month)
- Single-family detached residential 1,550 4,650 sq. ft. of impervious surface or less 1 SFU (\$5.00/month)
- Single-family detached residential greater than 4,650 sq. ft. of impervious surface 1.5 SFU (\$7.50/month)
- Townhouse, duplex, triplex, quadraplex and condominium 0.49 SFU (\$2.45/month)
- Mobile home and mobile home park 0.81 SFU (\$4.05/month)
- Multi-family dwelling units w/5-9 units 0.32 SFU (\$1.60/month)
- Multi-family dwelling units greater than 9 units 0.44 SFU (\$2.20/month)

The bill provides that the first fee collection period will cover July 1 – December 31, 2008, and thereafter the fee shall be collected on a calendar year basis and shall be billable on a monthly, quarterly, semi-annual, annual or pro-rated basis as the City shall determine to be in its best interest. Collection by the Tax Collector is specifically authorized based on mutually agreeable methods and costs between the Tax Collector and the City. Language is

added providing that liens placed against properties for non-payment of amounts due may not be foreclosed without authorization from the City Council.

The bill establishes a system of user fee credits, reductions and adjustments as follows:

- User fee reduction of 50% for organizations classified under Section 501(c)(3) of the IRS code, providing that the structure to which the fee applies is owned and used by the agency to provide its programs to the community;
- User fee reduction of 100% for residential properties owned by an individual or family with an income level within 150% of federal poverty guidelines;
- User fee adjustments for errors as permitted by the Adjustment and Credit Manual;
- User fee credits of up to 50% (75% in extraordinary circumstances) for use of stormwater best management practices (BMPs) pursuant to the Adjustment and Credit Manual.

The Adjustment and Credit Manual dated February 2008 is referenced as on file in the office of Legislative Services, and may be modified by the Subdivision Standards and Policy Advisory Committee.

Background Information: This bill authorizes a cost reimbursement contract for a period of three (3) years between the City and the St. Johns River Water Management District to fund projects for tributary water quality restoration in the Lower St. Johns River Basin. (The City will fund the projects and then invoice SJWMD on a monthly basis for reimbursement). There are six components to the restoration project. (1) Microbial Source Tracking - \$145,000 budgeted that enables the City to issue and manage a contract for services to assess fecal coliform bacteria impairment of tributaries (2) \$11,200,000 allocated for Oakwood Villas Estates Phase 2 project—to engineer, design, plan and construct sewer infrastructure for approx 515 homes and allow for the phase-out of existing septic tanks (3) funding that enables the City's Housing Services Division to administer a program that allows qualified property owners to abandon failing septic tanks and connect with a sanitary sewer (4) funds to enable the Duval County Health Department to inventory the existing septic tank system, evaluate conditions, facilitate repairs and track inspections and results (5) raising public awareness concerning septic tank and pet waste contributions to fecal coliform pollution (6) funds to enable WSEA to engineer, design, plan and construct gravity sewer infrastructure for approx 85 access points in Lincoln Villas Service Area I and to allow for the phase-out of existing septic tanks. Lincoln Villas and Oakwood Villas are housing developments in Council District 10.

Policy Impact: SJRWMD/Environmental and Compliance Department/WSEA/Water Quality

**Fiscal Impact:** This ordinance appropriates \$14,720,000
