**Background Information:** Council Member K. Brown held a notice meeting on January 11, 2018 to discuss LUZ Matters, liquor stores, and game rooms. In regards to liquor stores, it was determined that a revised review process was necessary to monitor the number of stores in a particular area. Also, residents and district council members should have an opportunity to vet additional liquor stores opening in a neighborhood. The Planning and Development Department suggested that liquor stores should only be granted by exception and that all alcohol waivers must be heard before Land Use and Zoning Committee.

Part 1 amendment adds language and authority for the Planning Commission or the City Council to consider waivers related to liquor locations.

Part 3 amendment adds language and references of Council approval, via an exception, for an establishment or facility (commercial or industrial) which includes the retail sale and service of all alcoholic beverages including liquor, beer or wine for off-premises consumption or both on-premises and off-premises consumption.

**Bill Summary:** This bill amends Chapter 656, *Ordinance Code*:

- Section 656.133 (Waivers for Minimum Distance Requirements for Liquor License Locations; Minimum Street Frontage Requirements; Signs; Downtown Properties), to provide a waiver process for minimum distance requirements for Medical Marijuana Dispensing Facilities;
- Repeals Subsections 656.313(IV)(A)(25), (IV)(A)(26), (V)(A)(28), and (V)(A)(29) (Community/General Category) related to the processing and/or dispensing of Low-THC *Cannabis* as a permitted use in the CCG-1 and CCG-2 Zoning Districts in their entirety;
- Repeals Subsections 656.321(I)(A)(14) And (I)(A)(15) (Business Park Category) related to the processing and/or dispensing of Low-THC *Cannabis* as a permitted use in IBP Zoning Districts in their entirety;
- Repeals Subsections 656.322(II)(A)(22), (II)(A)(23), And (II)(A)(24) (Light Industrial Category) related to the cultivation, processing and/or dispensing of Low-THC *Cannabis* as a permitted use in IL Zoning Districts in their entirety;

**Background Information:** The Florida Legislature initially enacted a medical marijuana law in 2014 to allow the operation of a limited number of dispensing organizations to cultivate, process, transport, and dispense low-THC cannabis to qualified patients and. In November 2016, the voters of the State of Florida passed an amendment that fully legalizes medical use of marijuana for qualifying patients and authorizes the cultivation, processing, distribution, and sale of marijuana by Medical Marijuana treatment Centers (MMTC). Thus, the Florida Legislature expanded the use of marijuana for debilitating medical conditions, known as the Medical Marijuana Act. This amendment provides local government a choice regarding the boundaries and restrictions on MMTC dispensing facilities.

For the best interest of the City, MMTC dispensing facilities can be within the boundaries of the City of Jacksonville and may be located within 500 feet of a public or private elementary, middle or secondary school, if the location has been determined to promote public health, safety, and general welfare of the community.

Based on the possible locations of MMTCs, the Zoning Code must be amended to add language referencing the minimum requirements for Medical Marijuana Dispensing Facilities; and revoke all subsections regarding cultivation, processing and/or dispensing of low-THC *Cannabis* in CCG, IBP, and IL Zoning Districts.

**Bill Summary:** The bill amends City Charter Article 21 - JEA - to create a requirement that JEA must install water and sewer mains and related facilities along all public highways and streets in "pre-consolidation urban areas" that are currently without City water and sewer service.

**Background Information:** The preamble of the bill states that many areas of the city that are unserved by public water and sewer systems have been promised connection to such systems since city/county consolidation in 1968, but only a very small number of such properties have ever been connected to public utilities while JEA has during the intervening years expanded its service area into St. Johns and Nassau Counties. The bill raises the issue of retrofitting these unserved areas as an important factor to be considered in the current discussion of the potential sale of the JEA to private investors. JEA has long had a policy that its system expands through the construction of utility infrastructure by private developers to serve new customers, and that it generally does not use revenues derived from current customers to build infrastructure for new growth.

The Task Force on Consolidated Government in its 2014 report *Blueprint for Improvement II* made two recommendations with regard to infrastructure improvements promised at the time of consolidation:

- 1. Amend the Ordinance Code to require that a specified percentage of appropriated spending and authorized borrowing for the annual Capital Improvement Program budget be specifically used for projects in pre-consolidation urban areas that were promised but not delivered, such as roads, water lines, sewer lines, storm water drainage, and streetlights.
- 2. Amend the Ordinance Code to require appropriate independent authorities with responsibility for carrying out capital improvements projects in the pre-consolidated urban areas of the City to assess the unmet CIP needs in those areas and set aside an annual amount of their CIP budgets to address those unmet needs.

**Background Information:** As part of the FY 2017-2018 budget process, six months of operating funding, including salaries and benefits, were placed in an operating contingency pending the outcome of Ordinance 2017-563-E. This legislation provides funding for operations for the next six months, through September 30, 2018. Estimated personnel cost savings of \$174,000 is being moved into professional services for program performance evaluation contracts with the University of North Florida and NLP Logix, the CEO search and rebranding. The CEO search allows the Kids Hope Alliance to outsource the search process, if necessary using a professional executive search firm. Employee Services estimated the cost of using an outside company to run approximately 25% of the salary for the position. Rebranding requires changing the name from the Jacksonville Children's Commission to Kids Hope Alliance, the Jacksonville Partnership for Children, Youth, and Families, as required by the ordinance. This includes changing stationary business cards, webs, website as well as internal and external buildings signage.

The bill authorizes execution of the settlement agreement and authorizes the Office of General Counsel to take such actions as are necessary to conclude the litigation.

**Background Information:** The plaintiff in the case of *Winston Judge v. City of Jacksonville*, a Fire and Rescue Department employee, alleges unlawful denial of compensable employment opportunities based on his race and in retaliation for his prior complaints, and seeks damages exceeding \$300,000. The plaintiff and the City have negotiated a settlement agreement in the total amount of \$100,000 for compensatory (pain and suffering) damages only to avoid the expense and uncertainty of further litigation, upon payment of which the case will be dismissed with prejudice and considered permanently settled.

**Background Information:** This legislation waives certain portions of Ordinance Code Chapter 260, Part 2 that governs waste tire transporters and generators in Duval County that will allow Duval County residents the opportunity to participate in the event to earn reward money for the collection of waste tires and snipe signs from the City's right-of-ways and public properties where these materials are either illegally placed or dumped, and from private properties where these materials may end up being dumped on public properties. The waiver would cover the time frame from March 16, 2018 to the event on March 24, 2018 at Lot J. Everbank Field from 8:00 A.M. to 2:00 P.M. and allow residents to haul tires without a license from the City, allow for the temporary storage of tires and allow the transport of tires after hours.

**Background Information:** The non-exclusive franchise agreement is for a term through December 31, 2020, and is renewable for an unlimited number of 2-year periods thereafter, or for a longer term if approved by City Council. The company will pay the City a franchise fee equal to 5% of gross revenues from gas sales (as defined in the agreement and interpreted by the Florida Public Service Commission) within the city of Jacksonville. The franchise agreement requires the company to comply with the applicable provisions of Ordinance Code Chapter 711 – City Rights-of-Way. The City reserves the right to terminate the agreement for failure to comply with its terms or with the requirements of Chapter 711, following service of written notice and holding of a public hearing.

**Bill Summary**: The ordinance approves and authorizes the Mayor and Corporation Secretary to execute and deliver Outlease No. 101-ORP-2017-09-3 between the United States of America, by and through the U.S. Department of Veterans Affairs (Lessor), and the City of Jacksonville (Lessee), said lease for a term of ten (10) years, from July 29, 2018, through July 28, 2028, with no option to renew, for the 18.96 acre model aircraft flying field and the 3.21 acre ball park at Lannie Road Park at no charge. It provides for oversight by the Department of Parks, Recreation and Community Services.

**Background Information:** The City of Jacksonville's Lease No. 41F-MSN-11-02-7 with the U.S Government, Veterans Administration (VA), for the use of an 18.96 acre model aircraft flying field and 3.2 acre ball park at Lannie Road expires July 29, 2018. The VA has proposed a new 10 year lease, Outlease No. 101-ORP-2017-09-13, with no option to renew. The unsigned, proposed lease starts July 29, 2018 and expires July 28, 2028. The proposed lease has been reviewed by the Real Estate Division and Office of General Counsel. If the new lease is executed, the Parks, Recreation and Community Services Department plans to continue operation of the model aircraft flying field and ball park until the agreement expires in 2028 or until the VA terminates the lease to expand the adjacent National Cemetery.

The Office of Public Parking shall notify the Jacksonville International Airport with a copy to the Executive Director of the Jacksonville Aviation Authority and the Beaches police chiefs of the extension of the 180 day moratorium.

**Background Information:** Ordinance 2015-835-E, enacted on December 8, 2015, established a temporary moratorium (90 days) on medallion renewals and late fees for medallion renewals pertaining to vehicles for hire, pursuant to Section 220.217, Ordinance Code. This is the seventh time the moratorium has been extended, in part because legislation was pending the state legislature with regard to uniform regulation of Transportation Network Companies (TNCs) such as Uber and Lyft. The 2017 Florida Legislature, after several years of failed attempts, adopted statewide regulatory standards for TNCs, which may change how the City wishes to deal with other vehicles for hire such as taxis in its local regulations. The medallion renewal fee moratorium will give the Council time to consider potential changes to the City's vehicle for hire regulatory system.

**Background Information:** Ordinance 2015-781-E approved an Amendment 14 to the City's lease with the Jacksonville Jaguars for EverBank Field to provide for the construction of an amphitheater and "covered flex field" (indoor practice facility) outside the stadium, with project costs to be shared by the two parties up to a maximum City contribution of \$45 million. The bill also approved separate development, operation, management and lease agreements between the City and the Jaguars for construction and operation of the covered flex field and between the City and Bold Events LLC (an affiliate of the Jaguars) under which the company would build and manage the facilities on behalf of the City. The lease for the Covered Flex Field granted to Bold Events the right to name the facility with City Council approval. The City Council previously approved the naming of both the amphitheater and the covered flex field as "Daily's Place" via Ordinance 2016-740-E; this bill approves a subnaming of a portion of the larger complex.

Background Information: The 9A/Baymeadows Regional Park is situated between Baymeadows Road East and State Road 9A (now I-295) in southeast Jacksonville in District 11. Perimeter Realty, a property management subsidiary of Fort Family Investments, a company begun in 1972 by Donald Fort. Fort Family Investments owns and manages 225,000 square feet of commercial properties while focusing on apartment development, primarily in South Jacksonville and one in Jacksonville Beach. The Fort Family desires to continue investing in the community. Thus, this agreement will provide Perimeter Realty the naming rights of the regional park and allow renaming the park to "Fort Family Regional Park at Baymeadows". The City will retain ownership and operation of the park. Perimeter Realty will provide an annual contribution of \$100,000 for up to ten (10) years, with an option to renew for an additional five (5) year period. The contribution will be used for capital improvements to enhance the park in coming years.

**Bill Summary:** The bill creates a Task Force on Civil Rights History to review and recommend ways to recognize, explain and publicize Jacksonville's role in the U.S. civil rights movement for local citizens and for visitors to the area.

**Background Information:** The bill's preamble notes that Jacksonville has been the home to several major figures in African-American history and the civil rights movement (e.g. James Weldon and John Rosamond Johnson and A. Philip Randolph), but has little in the way of recognition or interpretation of those persons and the events with which they were connected except a few historical markers. The Task Force is charged with reviewing the important persons, places and events in Jacksonville's civil rights history and suggesting ways that they can be better memorialized and publicized. The Task Force will consist of 26 members, co-chaired by former City Council member and current School Board member Warren Jones and Ju'Coby Pittman, President/CEO of the Clara White Mission. The deadline for the Task Force to make its report is June 30, 2018.
