Bill Summary: The bill appropriates \$16,408.02 from the FY16-17 City Council travel account to a new Council Travel - Associations/Memberships account. It amends Ordinance Code Chapter 10 - Organization of the Council – to provide that approved travel by designated council members to state and national League of Cities and Association of Counties meetings shall be reimbursed from the newly created league/association travel account, and that funding in the amount of 10% of the overall membership dues for the 4 organizations or \$20,000, whichever is greater, shall be appropriated annually to this travel account. Council Rules 1.304 is amended and a new Rule 1.306 is created to provide that the Council President shall appoint four different council members as representatives to the four organizations – 2 members assigned to the Florida and National Leagues of Cities and 2 members assigned to the Florida and National Associations of Counties. Assignments to the city associations and the county associations shall include one council member in their in their second term of office and one member in their first term of office. For the sake of continuity, preference in assignment of second term members to the associations shall be given to council members who were previously assigned to that association as a first-term member. The appointments as delegates to the associations shall be for 4 years or remainder of the member's elected term of office, if less. The Council President shall establish the manner in which designated council members shall request and be approved for travel to these meetings, taking into account the budget, public purpose and benefit to the City of their participation.

Background Information: The bill derives from a discussion at a Finance Committee meeting about how to categorize council member travel to League of Cities and Association of Counties meetings – specifically whether such travel by appointed delegates to the organizations counts as "travel undertaken on a special assignment or at the direction of the Council President", which is exempt from the \$3,000 per year limitation on individual council members' reimbursed travel. The committee discussed the value of having elected officials participate in the work of the associations and the need for continuity in participation by the same person over a number of years if the City's representatives are to achieve leadership positions in the associations. The Finance members felt that travel to the state and national meetings, within reason, is a benefit to the Council and the City and should be considered "on assignment from the President" and exempt from the \$3,000 individual member travel cap. The appointment methodology is intended to provide for continuity in City representation at the associations over time.

Policy Impact Area: Participation in city and county representative associations

Fiscal Impact: The bill appropriates \$16,408.02 from the Council's central travel budget to a new associations-related travel budget.

Bill Summary: The bill de-appropriates \$4,700,000 in anticipated grant budget for the Railex - West Bowden Rail Yard Project that never materialized.

Background Information: In 2013 the City Council approved an economic redevelopment agreement with Railex, LLC and approved a Qualified Targeted Industry (QTI) grant match of up to \$341,000 and a Recapture Enhanced Value (REV) grant of up to \$1.6 million to help fund construction of a multi-modal rail yard on 18 acres of land within the Florida East Coast Railroad marshaling yard on Philips Highway on the Southside. The company planned to construct a 252,000 square foot refrigerated warehouse/logistics center to load refrigerated cargo onto trains as part of a coast-to-coast temperature-controlled rail cargo network. In 2014 the City entered into an agreement with the Florida Department of Transportation and Railex for a state transportation grant of \$5 million to support the project. The Council subsequently approved two amendments in 2014 to the previous agreements as the project's location was changed from the east side to the west side of the FEC rail yard in the vicinity of Powers Avenue and Toledo Road and reduced the City's QTI financial commitment by \$155,000 to \$186,000 as a result of the loss of the brownfields bonus because of the relocation of the project out of a designated brownfield area.

Due to insurmountable railroad logistics issues and the decreasing price of diesel fuel making truck transportation more cost competitive with rail transportation, the project has never come to fruition and the City and FDOT have agreed to terminate the grant agreement and release the encumbered funds back to the FDOT for reallocation. This bill de-appropriates \$4.7 million of anticipated budgeted grant authorization to remove the project from the Public Works Miscellaneous Grant Projects – Other Grants and Aids account in recognition of its non-receipt.

Policy Impact Area: Economic development; budget clean-up

Fiscal Impact: The bill de-authorizes \$4.7 million in anticipated grant revenue that will not materialize.

Bill Summary: The ordinance appropriates \$52,775.00 for the removal of two derelict vessels in the Trout River (\$41,275.00) and one derelict vessel in the Ortega River (\$11,500.00), as initiated by B.T. 17-056; it approves and authorizes the Mayor and Corporation Secretary to execute and deliver on behalf of the City 1) the Small-Scale Derelict Vessel Removal Project Agreement between the City and the Florida Inland Navigation District (FIND), 2) State of Florida – Florida Fish and Wildlife Conservation Commission Agreement No. 16184, and 3) State of Florida – Florida Fish and Wildlife Conservation Agreement No. 16054; it provides for oversight by the Department of Parks, Recreation and Community Services.

Background Information: The grants agreements approved by this legislation are for the removal of three (3) derelict vessels in the City's waterways. On an as needed basis, the City of Jacksonville applies for funding assistance from the Florida Inland Navigation District (FIND) and the Florida Fish and Wildlife Conservation Commission (FWC) for removal of derelict vessels in the City's waterways. The FWC conducts an investigation of potential vessels and makes the designation, in which these vessels have been designated as derelict vessels. The derelict vessels removal projects: Two (2) derelict vessels in the Trout River (total costs \$41,275.00) FIND grant for \$30,000; FWC-Florida Boating Improvement Program (FBIP) grant for \$11,275.00. One (1) derelict vessel in the Ortega River (total cost of removal - \$11,500.00). FWC-Derelict Vessel Removal Grant for \$8,625.00. Required City match of \$2,875.00 (25%).

These three (3) grants required the City to complete the projects first and then the City will be reimbursed on actual cost. Chapter 328, Florida Statutes requires the FWC to return a portion of the Vessel Registration Fee back to the counties for providing recreational boating opportunities. City Code, Section 110.413 – Florida Boater Improvement Program revenue shares authorizes the use of these funds for recreational boating projects.

Bill Summary: The ordinance appropriates \$2,856,678 (\$1,257,695 from the Florida Inland Navigation District (FIND) and a City match of \$1,724,664.00 from the Reserve for Federal Programs) to fund five FIND grant CIP projects, as initiated by B.T. 17-057; it amends the 2017-2021 five-year Capital Improvement Program, approved by Ordinance 2016-505-E, to provide funding for the projects entitled "Northshore Kayak Launch," "Charles Reese Fishing Pier," "Half Moon Island Park & Boat Ramp – Phase 2A," "Exchange Club Island Pavilions," and "School Board Property ADA Kayak Launch"; provides for oversight by the Department of Parks, Recreation and Community Services; provides for quarterly reports to the Waterways Commission.

Background Information: On an annual basis, the City apples to FIND for funding specific waterways-related projects through their Waterways Assistance Program. FIND grants are two-fold. There is funding for the design process and there is additional funding for the construction phase of the projects. The costs of the project are shared by both FIND and the City. The Administration brings the projects before the Jacksonville Waterways Commission and the Commission proceeds to vet and prioritize each project. The Waterways Commission, in turn, makes recommendations to the City Council. The Northshore Kayak Launch (to build an accessible shoreline kayak launch) is in Council District 8; the Charles Reese Fishing Pier (to build a 100' long fishing pier and convert an old ramp into a kayak launch) is located in Council District 10; Half Moon Island Park & Boat Ramp Phase 2A (to build a boat ramp, entrance, parking & shoreline revetment) is located in Council District 2; Exchange Club Island Pavilions (to construct two pavilions and associated sidewalks) is located in Council District 1; School Board Property ADA Kayak Launch (to design/permit an accessible kayak launch) is located in Council District 5.

Bill Summary: The bill authorizes execution of an amended and restated economic redevelopment agreement between the City and HP-BDG 200 Riverside, LLC, or an affiliated company managed by the same. It authorizes a Recapture Enhanced Value (REV) grant of 62.5% of "Annual Project Revenues" (as defined) for a 20-year period, up to a maximum of \$9,000,000 to support the construction of a mixed-use residential and commercial development at 200 Riverside Avenue. The bill designates the Office of Economic Development as the City's oversight agency. It also waives the portion of the City's Public Investment Policy limiting REV grants to an amount equal to a maximum of 50% of incremental taxes on the property for a period of 10 years.

Background Information: In 2014 the City Council (via Resolution 2014-748-A) authorized an economic redevelopment agreement with Hallmark Partners, Inc. for the construction of the 200 Riverside project, encompassing 223 residential units, 18,000 square feet of retail space and 318 parking spaces in a structure at 200 Riverside Avenue. The City committed to a REV grant of up to \$7 million (equal to 75% of the additional taxes) over 20 years based on a minimum private capital investment of \$32 million. Due to changing market conditions the company (a new LLC created by Hallmark Partners to build this project) now desires to increase the number of residential units from 223 to 295 units, reduce the amount of retail space from 18,000 to 12,750 square feet, keep the number of parking spaces unchanged at 318, and increase the minimum private investment from \$32 million to \$50 million. The Downtown Investment Authority has approved the project revisions and recommends that a revised redevelopment agreement be executed and that the City's REV grant be increased from \$7 million to \$9 million, with a reduced incremental percentage (62.5% instead of 75%) applied to a larger project value and property tax revenue. The 62.5% grant over 20 years still exceeds the Public Investment Policy standard of 50% over 10 years, which was also waived for the original project in 2014.

Policy Impact Area: Economic development

Fiscal Impact: The bill authorizes a REV grant of up to \$9 million payable over 20 years.

Background Information: The City of Jacksonville is authorized to construct and maintain streets and highways, including drainage, for the general public and is vested by law with the power of eminent domain to acquire fee simple title, permanent easements for drainage purposes, and temporary construction easement rights in land for that purpose.

There is one fee parcel which has not been acquired through normal negotiation. The parcel is located on the property addressed as 600 8th Street, East, and is adjacent to 7th Street, East, between Spearing St. and Evergreen Ave.; and is approximately 307 feet long by 10 feet wide and contains 3190 square feet. The parcel is required to reestablish the original right-of-way of 7th Street at this location and for the construction of the Lower East Side Drainage Improvement Project.

The parcel belongs to Rinker Materials Corporation and the appraised value of the parcel is \$6,700. Multiple attempts over the past three years to acquire the parcel from the owner have been unsuccessful. The owner is unresponsive to mailings, emails and phone calls. Therefore, the City of Jacksonville shall acquire fee simple title to the property by eminent domain.

The license agreement would have a term of 3 years, effective July 1, 2016, at a token payment of \$1 per year. The bill designates the Sheriff's Office as the City's oversight agency for the agreement.

Background Information: Family Farms of Northeast Florida, Inc., operating as The Parent Help Center, is a not-for-profit corporation founded in 2002 by Glenn and Sheila Ellison to provide a vehicle for serving the needs of troubled youth and their parents. Empowered Parents is a parenting skills training program and Camp Consequences is an intensive behavior modification program for youth beginning to exhibit troubling behavior. The programs are conducted on weekends in a wilderness camping atmosphere under the supervision of trained program leaders and are intended to teach young people discipline and understanding of the consequences of their actions and to teach parents how to effectively guide and discipline their children with proven behavior modification techniques.

The City first approved the organization's use of a portion of the Montgomery Correctional Center property in 2009 (Ordinance 2009-840-E) for a period of 1 year with five 1-year renewal options. This bill authorizes a 3-year term, retroactive to July 2016, through June 30, 2019.

Policy Impact Area: Public safety through youth crime prevention

Bill Summary: The ordinance declares the property at 2801 Myra Street, Jacksonville, Florida 32205, R.E. Number 063004-0010, in Council District 14, to be surplus to the needs of the City; it authorizes the conveyance of the subject parcel to 6100 Philips Highway, L.L.C. at no cost and authorizes the Mayor and Corporation Secretary to execute all documents necessary for such conveyance in accordance with the provisions of Subpart B (Real Property Disposition), Part 4 (Real Property), Chapter 122 (Public Property), *Ordinance Code*.

Background Information: The parcel was acquired by the City in 1937 for \$58,000, and was used for maintenance storage until the City conveyed the parcel to the Riverside Avondale Development Organization, Inc. ("RADO") on August 8, 2006. The City's deed to RADO included an automatic reversion of the parcel to the City if RDO failed to develop the property for affordable housing within five years from the date of the deed. RADO failed to pay property taxes on the parcel and 6100 purchased the 2007 tax certificate on May 27, 2009. 6100 then applied for a Tax Deed based on the 2007 tax certificate and the Clerk of the Court issued the Tax Deed to 6100 on April 25, 2012. However, the automatic reverter in the 2006 Deed for RADO has not been cleared in the chain of title to the parcel, and the automatic reverter took place on August 8, 2011. 6100 initially paid \$9,215.94 in property taxes when it purchased the 2007 tax certificate in 2009, then paid an additional \$17,684.06 totaling \$26,900 to purchase the parcel as the highest bidder at the Tax Deed auction in 2012, and since then has paid \$21,406 in property taxes. The total amount paid to the City by 6100 since 2007 is \$48,306.30. 6100 has requested a PUD rezoning for the parcel (Ordinances 2017-41 & 2017-42, and requires the City to clear the cloud on the title to the subject parcel by conveying the City's interest to 6100 through quitclaim deed.

Background Information: In 2016 (via Ordinance 2016-145-E) the City closed and abandoned a portion of the right-of-way of North Edgewood Drive in the Biltmore neighborhood at the request of the railroad to facilitate Norfolk Southern Railroad's plans to improve access to its Simpson Intermodal Yard. The work will extend the Intermodal Yard's entrance driveway to Soutel Drive, thereby eliminating the need for truck traffic on North Edgewood Drive. The 2016 ordinance stated that the railroad plans to install culs-de-sac in the right-of-way on each side of the closure on North Edgewood. This bill authorizes execution of the agreement with the railroad to proceed with the crossing closure. The Stipulation of Parties agreement provides that the railroad will remove the crossing and closed road at its expense and that the railroad and FDOT will each provide the City with one-time payments of \$7,500 to be applied to transportation safety uses. Upon acquisition by the railroad of an adjacent property ("Kowkabany property") the FDOT will initiate closure of the crossing.

The Sheriff's Office and Fire and Rescue Department have both reviewed the proposed closure and had no objections. The traffic study attached to the Stipulation Agreement found that the transportation level of service in the area would not be substantially affected, but did recommend that the new entrance driveway of the rail yard at Soutel Drive should be signalized. Installation of traffic signals will likely cost substantially more than the \$15,000 in funds being provided by the railroad and FDOT.

The bill was not enacted as an emergency on first reading at the time of introduction and has been referred to committee for consideration.

Background Information: The Jacksonville Journey Oversight Committee was initially establish via Ordinance 2008-555-E and continued annually via the budget ordinance. Ordinance 2015-800-E codified the committee as the Jax Journey Oversight Committee in Chapter 75, *Ordinance Code*. The committee is charged to: in concert with the City's grant making agencies, establish the short, intermediate, and long term, measurement and reporting systems for Jax Journey funds; issue an annual community-wide report card on the progress of funded Jax Journey programs; make annual recommendations on programs to be funded based on each program's prior year's performance; continue the data gathering and public policy innovation initiated by the Jax Journey for further refinement and consideration of the program; and advocate for the investment of new public and private dollars as well as state and federal policy initiatives to ensure a safer city. The nine voting members of the committee are residents appointed by the Mayor and confirmed by the Council.

Background Information: The Jacksonville Housing Authority is established pursuant to Chapter 51A, Ordinance Code, and charged to within its area of operation, prepare, carry out, acquire, lease, and operate housing projects; and provide for the construction, reconstruction, improvement, alteration, or repair of any housing project or any part thereof. Section 51A.103, *Ordinance Code*, provides that the seven members of the board shall be appointed by the Mayor, subject to confirmation of the Council.
