It may also include use of short sales and investments in foreign stocks and bonds. The amendment would also require the Pension Board of Trustees to notify the Finance Committee Chair, Council Auditor and Council President at least 60 days prior to changing its investment strategy.

**Background Information:** The bill's preamble states that the objective of utilizing a wider array of investment options is to obtain potentially higher yields and to use hedging strategies to reduce volatility and limit downside risk. The City approved resolutions in 2008 and 2010 to support local legislative acts that would expand the investment options of the Police and Fire Pension Fund with regard to real estate.

**Fiscal Impact:** Undetermined; the amendment would allow the pension fund to invest in higher yielding investment options.

The bonds issued shall not be deemed to constitute a debt, liability or obligation payable by the Authority, City of Jacksonville or County. The bonds shall be payable solely from revenues derived from the sale, operation or leasing of the Pine Grove Apartments Project.

The bill returns to the JEA the unspent portion of the authority's annual appropriation to the WSEA of operating funds for FY10-11, and appropriates \$3,762,688.98 in WSEA capital funds to the City's Stormwater Utility for use in septic tank phase-out projects. Assets of the WSEA, including any remaining funds and rights to future revenues from loan repayments, are transferred to the JEA. Any WSEA interests in mortgages, leases or other interests resulting from authority project loans are transferred to the City. The WSEA's \$485,000 EPA grant for septic tank phase-out will be transferred to the City. The bill authorizes the execution of an agreement between the City and JEA to implement the shutdown of the WSEA, the distribution of assets and liabilities, and to provide for the continuation of on-going projects, the collection of revenues due, the transfer of employees and contracts, and the termination of the WSEA board's operations.

**Background Information:** The Water and Sewer Expansion Authority was created in 2003 as a result of the work of a task force studying the need to extend public water and sewer service to areas of the city then served by wells and septic tanks. The initial capitalization of the WSEA came from the City and the JEA appropriated \$800,000 per year for operating expenses. The authority primarily helped to facilitate extensions of water and sewer lines in neighborhoods where the homeowners were willing to pay the cost via special assessments, with the WSEA fronting the money for the project and the property owners repaying the cost over a number of years.
