**Bill Summary:** The ordinance concerns emergency medical transportation by air ambulance; declares that public convenience and necessity require the issuance of a Certificate for Emergency Medical Transportation Service, advanced life support, pursuant to Med-Trans Corporation d/b/a Traumaone; authorizes the Director of the Fire and Rescue Department, or designee, to issue said certificate; the ordinance amends the procedures set forth in Section 158.205 (Grant of Certificate), Part 2 (Emergency Medical Transportation Services), Chapter 158 (emergency and Nonemergency Medical Transportation Services), *Ordinance Code*, regarding procedure for review of said certificate.

**Background Information:** The ordinance concerns TraumaOne (air ambulance) service at Shands Jacksonville. Rocky Mountain Holdings d/b/a TraumaOne has provided emergency medical air ambulance service at Shands through a Certificate of Necessity that was issued by the City of Jacksonville in 2000. In January 2013, Rocky Mountain Holdings assigned its contractual rights for air ambulance service to Med-Trans Corporation, d/b/a TraumaOne to allow the continuation of service at Shands for Jacksonville area residents. The *Ordinance Code* does not allow the transfer of a CON without the submission of a new application. The Jacksonville Fire & Rescue Director has reviewed the application, pursuant to Chapter 158 and recommends that the CON be issued. The Public Health & Safety Committee will review the application. The ordinance amends Section 158.205 to clarify procedures for the issuance of certificates for Emergency Medical Transportation Services.

**Bill Summary:** The bill amends Ordinance Code Chapter 780 – Property Tax – to implement an additional homestead exemption for low income senior citizens beginning January 1, 2014. The exemption, which applies to homesteaded property with a just value of less than \$250,000 owned for at least 25 years by a person age 65 or older who is determined to be "low income" pursuant to state law, is equal to the assessed value of the property.

**Background Information:** In 2012 Florida voters approved a new local option homestead exemption for low income seniors, with an effective date of July 1, 2013. The local option exemption may be adopted by a 2/3 vote of the governing body of the jurisdiction. State law (Sec. 196.075, Fl.Stat.) defines low income to be \$20,000 as of January 1, 2001, adjusted annually by the change in the average Consumer Price Index for the preceding year as issued by the U.S. Department of Labor.

Policy Impact Area: Property tax exemption

**Fiscal Impact:** The Property Appraiser's office estimates that the cost of adopting the new exemption would be approximately \$455,000 in foregone property tax revenue in the first year of the exemption.

Background Information: Federal HAVA funds are distributed via state election offices to county governments based on their number of registered voters in the last Presidential primary election, and must be matched at a 15% rate by local governments. The funds may be used for voter education, poll worker training, standardizing election results reporting, other federally-approved election administration activities relating to military and overseas voters, or elections hardware or software purchases.

Policy Impact Area: Voter education

Fiscal Impact: The bill appropriates \$137,794.67 in federal grant funds and \$20,669.20 in local matching funds

**Bill Summary:** The ordinance concerns a continuation grant; the ordinance appropriates \$8,250 in federal funds from the Department of Homeland Security through the State of Florida Division of Emergency Management to supply Community Emergency Response Team (CERT) members with FRS/GMRS radios so as to enhance communication during events and disaster, as initiated by B.T. 13-033; the ordinance approves, and authorizes the Mayor and Corporation Secretary to execute and deliver, Modification #1 to Subgrant Agreement between the Division of Emergency Management and City of Jacksonville (City Contract #9041-55).

**Background Information:** The modification to City Contract #9041-55 is being requested to change the amount and a deliverable date from \$6,750 (previously appropriated) to \$15,000 and the term of the contract from April 30, 2013 to June 30, 2013. All other terms and conditions remain in effect.

**Bill Summary:** The ordinance concerns a continuation grant; the ordinance appropriates \$17,255 from the Department of Homeland Security through the State of Florida Division of Emergency Management (a 2012 Community Emergency Response Team (CERT) grant in the amount of \$9,755 and a 2012 Citizen Corps grant in the amount of \$7,500) to provide funding to (1) organize and equip Duval County citizens for Community Emergency Response Teams for the City of Jacksonville and (2) hire a part-time coordinator for the Community Emergency Response Team (CERT) and Citizen Corps Programs, as initiated by B.t. 13-035; the ordinance authorizes a position, as initiated by R. C. 13-082.

**Background Information:** The Community Emergency Response Team is the first responders who provide fire and medical services in the event of a major disaster; the concept is people relying on each other for help in order to meet immediate lifesaving and life sustaining needs. In the immediate aftermath of a disaster that has occurred without any warning, people volunteer spontaneously. CERT prepares citizens for this eventuality. The ordinance appropriates funds to hire a temporary Clerical Support Aide/III to coordinate the activities outlined in the contract agreement and organize and equip Duval County citizens for the Community Emergency Response Teams.

The Facilities Capital Maintenance Fund is funded with Banking Fund borrowing and was budgeted at \$4 million for the current fiscal year. The current balance in the fund in approximately \$11 million. Pending Ordinances 2013-136, -137, -140 and -141 propose to spend a combined \$5,212,000 on various projects. Emergency passage is requested because the Emergency Operations Center roof and water damage repairs portion of this request is partially funded with a grant from the Department of Economic Opportunity, Community Development Block Grant for Disaster Recovery, which expires June 12, 2013. Expiration of this grant would potentially result in the loss of approximately \$625,000 in State funding.

**Bill Summary:** The bill appropriates a total of \$163,012 from the Environmental Protection Fund in three allocations (March 2013, August 2013 and August 2014) to continue funding for a joint project by Jacksonville University and the University of North Florida to produce a comprehensive annual report on the health and state of the St. Johns River for three additional years. The bill waives provisions of Ordinance Code Section 111.755 (Environmental Protection Fund) and Section 360.602 (Environmental Regulation - Use of the Fund) to permit use of the fund for this non-specified purpose, and waives provisions of the City's Procurement Code to allow the project to be contracted directly to UNF without a competitive procurement process by specific direction of the City Council in the appropriation ordinance. The bill authorizes the Mayor to execute an agreement with the two universities for extension of the study.

**Background Information:** Funds were first appropriated from the Environmental Protection Fund for the State of the River study in November 2008 for the 2008-09 and 2009-10 reports and again in 2010 for the 2010-11, 2011-12 and 2012-13 years. The Environmental Protection Board has again recommended the use of the Environmental Protection Fund as an appropriate funding source because it produces a report that analyzes and highlights the condition and health of one of the City's most valuable natural resources, and makes the information readily available to the general public.

Policy Impact Area: Natural resource protection

**Fiscal Impact:** The bill appropriates a total of \$163,012 from the Environmental Protection Fund over three years.

**Bill Summary:** The bill appropriates \$342,000 in FDOT grant funds to the Public Works Department for construction of Segment 3 of the Timucuan National Preserve Bicycle Route. The bill amends the 2012-16 Capital Improvement Program to increase the construction budget for the project and finds that it would be detrimental to delay the CIP amendment to the next budget cycle because the low bid for the project is only good for a limited time and the grant funding will be withdrawn by FDOT if the contract is not executed in a timely manner. The bill authorizes the administration to execute agreements and contracts associated with the grant.

**Background Information:** The Timucuan National Preserve Bicycle Route is a planned 12.6 mile paved bicycle/walking trail within the right-of-way of State Road A1A beginning at Hanna Park (A1A and Wonderwood Road) and extending northward to the northern end of Big Talbot Island at the Nassau Sound bridge. The route has been under construction for several years and bids have currently been received for Segment 3 of the project. The bids came in over budget, but the FDOT has offered a grant of \$342,000 to fill the funding gap and allow the contract be awarded and the segment completed. The expiration of this supplemental grant and the inability to fund the project without the additional funding is cited as the reason for the mid-year CIP amendment.

**Bill Summary:** This bill confirms the appointment of John R. Campbell, to the Taxation, Revenue and Utilization of Expenditures (TRUE) Commission, filling the seat formerly held by Jason Fischer, for an unexpired term ending June 30, 2013, followed by a first full three-year term ending June 30, 2016.

**Background Information:** The TRUE Commission is established pursuant to Chapter 57, *Ordinance Code*, and charged to act as an advisory body to the city concerning fiscal policy and may review any aspect of fiscal policy, including: the city's long-range financial soundness, planning, budgeting, and management; the city's budgetary process, including taxation, revenue generation, expenditures, use of permit fees and user fees, bonding capacity, franchise fees, state and federal mandates, privatization, "zero based" financing and other similar topics; the appropriateness of each revenue source the city receives to make up its annual general revenue budget; potential new revenue sources, such as impact fees, and the use of any such funds; the pre- and post-retirement benefit structure for city employees and the potential impact on the financial status of the city; recommendations that will help make Jacksonville the most fairly-taxed and financially-sound city in the nation; recommendations to keep the public better informed about important issues of city financing and budgeting which affect their lives; and other areas as the commission may determine are appropriate and within their scope.

Section 57.102, *Ordinance Code,* provides that the members of the commission shall be residents of the city and six of the members shall be appointed by the President of the Council and confirmed by the Council.

Mr. Campbell received a law degree from the University of Florida and is a Senior Attorney with the *Federal Deposit Insurance Corporation (FDIC)*. He resides in the Murray Hill area within Council District #14.

**Bill Summary:** The bill authorizes the transmission to various state agencies of a proposed amendment the 2030 Comprehensive Plan's Transportation Element to make changes regarding the policy for regulating access of non-residential parcels with frontage on two or more roadways when more than one access point already exists on a roadway. The bill waives the provisions of Ordinance Code Sec. 650.404 – Planning and Development Department Review – to permit the proposed amendment to be transmitted to Tallahassee without the Planning and Development Department having first held an informational workshop on the proposal

**Background Information:** The sponsor drafted this amendment to address an issue raised in the recent Five Points Village land use change and rezoning process. The amendment would provide that the "right-turn-in-right-turn-out-only" requirement for the roadway with the higher classification or the greater traffic count could be waived if there already exists more than one full access point on roadway and at least one of the full access points is eliminated as part of the project. The amendment also changes the responsibility for reviewing the mandatory traffic study and granting the waiver from the City Traffic Engineer to the Planning and Development Department.

The waiver of the Planning Department informational workshop requirement is being requested because this proposed amendment is being sent to Tallahassee as part of the set of large scale Comp Plan amendments already being proposed to be transmitted to the various state agencies by Ordinances 2013-130 and -131. The time necessary to schedule and hold a workshop and then produce a written Planning Department report would delay the transmission of this additional proposed amendment to the state and would cause it to either be transmitted separately, with its own notice and advertisement costs, or it would not be considered in conjunction with the other amendments now pending and would have to wait until the next round of transmittals later in the year.

**Fiscal Impact:** Saves the cost of separate notice and advertisement for this amendment by allowing it to be folded into the other pending transmittals to Tallahassee.
