Bill Summary: The bill authorizes a lease agreement between the City and the ASPCA for the organization to utilize the City's former animal care and control facility at 2580 West 1st Street for 6 months at a token rent of \$1, with additional month-to-month extension options.

Background Information: The ASPCA wishes to house and care for many of the cats removed from the Caboodle Ranch cat sanctuary in Madison County in the City's former Animal Care and Control facility while the criminal investigation is ongoing and the cats are nursed back to health. The ASPCA will make some capital improvements to the facility at its own expense and will pay all utility costs. A memorandum from City Animal Care and Protective Services Chief Scott Trebatoski indicates that the ASPCA will also provide the City with future grant funds to pay for training of animal control officers.
