Bill Summary: The bill amends Ordinance Code Chapter 20 – Executive Office of the Mayor – to add a new subsection to the mayoral transition provisions to require an outgoing mayor to transmit to the incoming mayor a document outlining the City's current responsibilities and obligations for providing services to the Beaches cities and the Town of Baldwin pursuant to the various interlocal agreements between Jacksonville and those jurisdictions. The language requires the Mayor-elect to ensure that the appropriate personnel in the departments, divisions and offices within City government under the new administration are aware of their responsibilities under the interlocal agreements and for continuity of covered services.

Background Information: The Task Force on Consolidated Government heard testimony during its proceedings from the mayors and city managers of Atlantic Beach, Neptune Beach, Jacksonville Beach and the Town of Baldwin that those jurisdictions have experienced some problems with continuity of services covered by the terms of the interlocal agreements following Jacksonville's mayoral elections. It appears that information about the City's obligations under the agreements is not being sufficiently communicated between the outgoing and incoming administrations, and the managerial personnel of the new administration are unaware of, or at least not fully knowledgeable about, the interlocal agreements. This amendment is intended to codify the transfer of this piece of information from one administration to the next.

Bill Summary: The bill amends Ordinance Code Chapter 73 – Environmental Protection Board – to provide that the Board shall compile and distribute on an annual basis a report on water quality (drinking water, surface water and groundwater) in the city. The report shall be distributed to all CPACs and registered neighborhood organizations and shall be coded or in a searchable format so that citizens and organizations can easily locate information relevant to their particular neighborhood or area of town. The EPB is also required to report on incidents of chemical spills, water pollution, groundwater contamination or other health hazards known to the City Environmental Quality Division or the Florida Department of Environmental Quality. The reporting may take the form of posting the information on the City's web site, through a specially-developed alert system, or through communication with local news media which can relay the information to the general public in the event of an emergency.

Background Information: During the course of its deliberations the Task Force on Consolidated Government learned that, while the state and City collect and compile a good deal of environmental and water quality information on a regular basis, that information is not easily available to the general public on anything less than a quarterly or annual basis, and when available is not easily searchable in a way that allows neighborhood organizations or interested citizens to pinpoint potential environmental hazards in their immediate vicinity. This amendment seeks to make environmental information, particularly information relating to incidents of water contamination, chemical spills, etc. that could have an immediate impact on public health and safety, more readily available in a way that informs the public immediately and effectively about such potential hazards.

This bill is intended to foster that greater communication and cooperation.

Bill Summary: The bill amends Ordinance Code Chapter 106 – Budget and Accounting Code – to add a requirement that the Mayor certify in each quarterly financial statement that the departmental employee caps are accurate and comply with the budgetary allowance for each department.

Background Information: During the course of its deliberations the Task Force on Consolidated Government heard testimony that on occasion mayoral administrations have administratively transferred employees from one department to another which resulted in departments having more employees assigned to them than the Council-approved departmental employee authorization cap allows. Section 106.422 of the Budget and Accounting Code requires the administration to provide quarterly budget reports to the City Council not later than 30 days after the end of each fiscal quarter. This bill adds a requirement that the Mayor shall certify in each quarterly report that the number of employees assigned to each City department complies with the employee cap allocation established by City Council for each department in the annual budget ordinance.

Background Information: The Task Force on Consolidated Government during the course of its deliberations discussed the degree to which the City Council is aware of and has access to information collected and maintained by various City departments for a variety of purposes. The Governance and Management Committee felt that the Council members would find useful the information contained in the inventory of City-owned properties that the Risk Management Division maintains for the purpose of ensuring that all City properties are adequately insured, and also the semi-annual risk assessment report prepared by an outside consultant to advise the City on potential liability risks for its self-insurance purposes.

Bill Summary: The bill amends Ordinance Code Chapter 804 – Traffic Code – to provide that any person who violates the visibility obstruction provisions of the Traffic Code shall be guilty of a non-criminal offense that may be punishable either by the City as a Class A offense with a code enforcement civil penalty or punishable pursuant to state or federal law pertaining to the operation of vehicles. The bill also amends Ordinance Code Chapter 609 – Code Enforcement Citations – to add "obstruction visibility" as a listed Class A offense enforceable by citation by the Code Enforcement Division.

Background Information: Currently visibility obstruction offenses (i.e. bushes growing on private property in an intersection view zone) are enforced by the Sheriff's Office issuing a traffic ticket. This bill would make such offenses punishable by means of a civil citation issued by Code Enforcement in addition to a JSO traffic ticket.

Policy Impact Area: Traffic Code enforcement

Fiscal Impact: Undetermined – there may be some additional revenue generated if the Code Enforcement Division issues more citations than the JSO currently issues for these violations.

The bill also amends Council Rule 3.102 – Preparation of Bills – to require that any legislation filed with the Council that approves or authorizes a contract, agreement, lease, easement or grant shall specify the department, agency, commission or other governmental entity of the City that will manage and oversee the contract or agreement.

Background Information: During the course of its deliberations the Task Force on Consolidated Government learned that at the outset of consolidation in 1968, the Duval County Health Department was a full-fledged City department and the Health Department Director was a City department head on par with the other City department directors. Over the last 30 years due to changes in state law the Health Department has evolved to its current quasi-state, quasi-local status, with the department's employees being state employees housed in City buildings and the Director being appointed by the Florida Surgeon General but confirmed by City Council. The Health Department director is no longer considered a City department head and does not regularly attend internal City meetings. The Task Force believes that the Health Department's expertise and advice should be better integrated into City operations for the benefit of the public's health and safety, which could be accomplished by having the Health Department Director attend the RCDPHS meeting as an ex officio advisory resource.

The Task Force also heard testimony that the City has difficulty in tracking and managing some of its contracts and agreements because the City lacks a comprehensive contract management system. The group recommended the Council Rules amendment as a means of assuring the assignment of contract management responsibility to a specific party at the outset of the contract.

Background Information: The failed portion of the double box culvert at Egrets Nest Drive is located near the Flagler Center Industrial Park, south of Old St. Augustine Road and east of I-95. Auld & White, Inc. provided an analysis of the culvert failure. It was determined that severe storm activity in September 2013 exceeded the culvert design parameters, thus causing catastrophic damage which resulted in closing two of the four travel lanes. The area has been stabilized but is in need of immediate attention to reopen the two travel lanes while ensuring minimization of further damage. The construction will include removal of pavement and existing drainage structures; and installing new roadway, sidewalks, landscaping, and box culvert installation.

The funds will be transferred from Mandarin Area Drainage project in the CIP plan to the Egrets Nest Drive Culvert Repair project. The deferral of this amendment until the next annual budget and CIP review is not in best interest of the community because of additional failure of pavement and curb settling.

According to Ordinance 2007-281-E, NWJEDF guidelines require professional 3rd party underwriting. However, the newly constituted committee includes members with in-depth expertise and experience in financial review and underwriting of transactions in the commercial lending environment. Therefore, the committee established an Underwriting Subcommittee at the October 8, 2014 meeting for the purposes of reviewing and underwriting any NWJEDF request moving forward.

The project site is located in Council District 8.

Bill Summary: This bill approves renaming a section of Taylor Field Road which extends west from Longleaf Branch Road to a dead end in Council District 11; waives the requirements of Section 745.105(g), Ordinance Code; and directs the Legislative Services Division to forward Ordinance to the Planning and Development Department.

Background Information: Local law enforcement recently had difficulty locating a portion of the road during a call for assistance. Currently, there is no physical connection between the portion of Taylor Field Road accessed from Old Middleburg Road, and the portion accessed from a newly constructed internal street named Longbranch Drive within the Longleaf Subdivision. Section 745.105(g) requires street name changes for the entire length of street; however, waiving the requirements minimizes further delay in emergency services in locating this segment of Taylor Field Road which is in best interest of public safety.

The segment of "Taylor Field Road" which extends west from Longleaf Branch Road to a dead end will be renamed "Round House Road". There is no historical impact regarding the name change. All adjacent property owners and 13 affected property owners were properly notified of the decision to change the street name. No appeals were filed.

The code violations include but are not limited to a deteriorated, damaged or unsound porch, a leaking roof, an unsanitary bathtub and shower, numerous holes or cracks in the ceiling, insecure flooring, improper heating facility and holes and cracks in the walls. The City's Municipal Code Enforcement Special Magistrate entered an Order assessing a rolling fine in the amount of \$100 per day until violations were corrected. The Order was dated October 1, 2008 and was not appealed by owner, which deemed Order final.

The violations were corrected by the property owner, Fred Clark, on March 13, 2009, which resulted in the accrual of \$15,800.00 in penalties. According to Chapter 518, this amount is subject to foreclosure. The property was conveyed to Doris E. Davis by Fred Clark on September 2, 2014. Currently, there are additional encumbrances recorded as liens, judgments or mortgages against the property. Upon foreclosure, the City would inherit any previously recorded encumbrances, however foreclosure of the City's lien will help to eliminate blight in the surrounding area by allowing a foreclosure sale of the property, and creating a potential for redevelopment.

Background Information: During the course of its deliberations the Task Force on Consolidated Government learned that a position of Chief Administrative Officer existed in the City Charter at the time of consolidation but was removed by legislative action in 1971. Although every succeeding mayor has appointed a CAO, the Task Force felt the position was important enough to the operations of City government to be a mandated position in the charter and to merit a specific set of job qualifications and experience requirements. The Task Force also felt that the current Ordinance Code job qualifications for the Director of Finance (bachelor's degree from an accredited college and proven administrative experience in public or private sector financial institutions) needed amplification and added additional language regarding desirable educational and professional experience qualifications. The provisions regarding mandatory appointment of a CAO and the provisions regarding CFO qualifications would become effective upon a favorable vote in the May 2015 referendum.

The committee would review the study, make recommendations and negotiate a contract with vendor. The cost savings will begin the sooner the committee is constituted and completes tasks. with additional time begin seeing cost savings as soon as possible.
