Background Information: The Zoning Code currently requires that dwellings be placed on lots such that the long axis of the house is parallel to the street frontage. The Zoning Administrator may grant an exception for a structure that lacks the appropriate lot line setbacks by a small amount (less than a 10% deviation from the requirement) provided that landscaping is utilized to buffer the deficiency in the setback. The sponsor wishes to authorize the long axis of a dwelling to be placed perpendicular or diagonal to the street frontage if normal setbacks cannot be achieved in the parallel orientation because of some peculiarity of the shape or topography of a particular lot, but intends to prohibit the alternative placement of a dwelling purely because of the owner's desire to have a dwelling that does not meet setback requirements because of size or location on the lot.

The City is in the process of designing a road realignment project on West 11th and 12th Streets in Springfield which will require a relocation of the existing parking for the Medical Examiner's Office. Two ADA-compliant parking spaces are required to serve the building, and site constraints, including the lot and roadway layout and the location of a natural gas meter, dictate that perpendicular spaces are the best solution to providing the two required ADA spaces near the handicapped-accessible entrance to the building.

The City and FDEP have agreed that the contamination is not currently leaving the site and does not need to be remediated so long as certain restrictions are in place as set forth in the declaration of restrictive covenant. The restrictive covenant provides that there shall be no drilling of wells (except permitted monitoring wells) and no stormwater retention swales, ditches or ponds in the area. A permanent impervious cover is required and no soil may be disturbed without proper permits and approved disposal of any soil excavated. Upon the execution of the Declaration with FDEP, FDEP will issue a Site Rehabilitation Completion Order with conditions for the Site.

Either party may terminate the agreement upon providing 60 days' written notice to the other party. If the foundation terminates the agreement before the end of the 5-year maintenance period, the foundation must restore the site to its pre-existing condition.

Only City Council may withdraw an application once the workshop stage is passed, but because of the PUD rezoning application deficiency neither bill was ever filed, so the matter has not come before the Council and provided an opportunity for withdrawal. This bill brings both applications before the Council to allow for the withdrawal to take place and Council has sometimes authorized refund of fees. To date the Planning Department has, with respect to the land use application, published a newspaper ad, mailed notices to adjoining property owners, done field investigation, and conducted the workshop.
