Funds may be used upon written requisition of the Library Board of Trustees, subject to availability of funds in the account and appropriation in the City budget.

Background Information: During the course of its deliberations the Task Force on Consolidated Government heard testimony from the Library that the fines it collects for overdue or damaged library materials is deposited into the City's General Fund and does not belong to the library. The Task Force felt that the Library, as the generator of those fines, should be entitled to keep the revenue for library purposes.

Policy Impact Area: Library fine allocation

Fiscal Impact: The library reports that it collected \$738,119 in fines in FY12-13 and \$657,998 in FY13-14.

Bill Summary: The bill amends Ordinance Code Chapter 121 – Police and Firefighters Pension Fund – to reflect a pension reform counter-proposal by the PFPF board to the plan adopted by City Council in Ordinance 2014-386 and transmitted to the board for their consideration. The PFPF's counter-proposal differs from 2014-386 in the following areas:

- The PFPF's proposal references the Senior Staff Pension Plan being closed to new members as of August 15, 2014; the agreement approved by 2014-386 deleted any reference to the Senior Staff Pension Plan.
- The PFPF's proposal includes language stating that the City agrees not to unilaterally alter the pension benefits of Group 1 Employees (current employees) for a period of 10 years; the agreement approved by 2014-386 deleted language waiving the City's right to impose benefit changes via the collective bargaining impasse process for 10 years.
- The PFPF proposal provides for a cost of living adjustment (COLA) for time accrued after the implementation of the new agreement equal to the Social Security COLA, capped at a 6% increase; the agreement approved by 2014-386 provided for the Social Security COLA, capped at a 4% increase.
- The PFPF proposal provides for a DROP actual rate of return for members with less than 20 years of service, with a floor of 2% and a cap of 14.4%; the agreement approved by 2014-386 provided for an actual rate of return with a floor of 0% and a cap of 10%.
- The PFPF's proposal regarding the lengthening of the "final average compensation (FAC) period" from the last 2 years of service to the last 5 years provides for no change from the current status for vested employees with 5 or more years of service; the agreement approved by 2014-386 provided for the lengthened FAC period to apply to employees with less than 10 years of service.

Background Information: The ordinance contains a blank placeholder for an automatic sunset date for the ordinance should the Council-approved agreement not be executed by the PFPF by a date certain.

Policy Impact Area: Police and Fire Pension Fund reform

Fiscal Impact: Undetermined An actuarial evaluation by the Milliman actuarial firm dated January 27, 2015 estimates that the pension benefits proposed in 2015-54 would save \$1.68 billion over 30 years when compared to the current benefit package, approximately \$50 million less than the 2014-386 proposal. \$18 million of the \$50 million change is attributable to the FAC period change; \$32 million is attributable to the COLA percentage change.

Bill Summary: The bill amends Ordinance Code Chapter 656 – Zoning Code – in Part 13 – Sign Regulations – by amending the Sports and Entertainment Complex Sign Overlay Zone to revise the definitions of "Baseball Grounds of Jacksonville Signs" and "Jacksonville Veteran's Memorial Arena Signs" to remove references to prohibit commercial signs on the exterior of those facilities and to limit application of the overlay to signs on the interior of the facilities. The amendment also clarifies that permission to erect signs pursuant to naming rights or sponsorship agreements applies only to the naming of an entire facility pursuant to a long-term naming rights or sponsorship agreement in excess of 5 years. The bill also amends City Charter Article 23 – Offsite Commercial Billboard Ban – to limit the exception to the ban provided for signs erected pursuant to naming rights or sponsorship agreements to the naming of an entire facility pursuant to a long-term naming rights or sponsorship agreement in excess of 5 years. The same provision regarding long-term naming rights agreements is also added to Ordinance Code Chapter 614 – Public Order and Safety in Sec. 614.142 – Unlawful Sign Messages and to Zoning Code Section 656.1309 – Unlawful Sign Messages.

Background Information: The bill is intended to prevent the erection of signs on the exteriors of public venues advertising naming sponsors who have entered into naming rights agreements for interior portions of those venues (lobbies, suites, etc.).

Bill Summary: The bill approves an amendment to the Interlocal Agreement between the City of Jacksonville and the City of Atlantic Beach in the form of a Release and Settlement Agreement to settle a dispute between the two jurisdictions over solid waste processing and disposal fees. It designates the Public Works Department as the contract management and oversight agency.

Background Information: The current Interlocal Agreement between the City of Jacksonville and the City of Atlantic Beach provides that Atlantic Beach may deposit its residential garbage in Jacksonville's landfill free of charge until such time as Jacksonville imposes a uniform solid waste processing and disposal fee against residential premises in the city, at which time Atlantic Beach would begin paying a tipping fee at the landfill. The City adopted a residential solid waste user fee in 2011 but the cities have been in dispute since that time over whether the fee imposed met the conditions of the Interlocal Agreement and whether a tipping fee on Atlantic Beach waste should be payable.

By means of this Release and Settlement Agreement the parties: agree to settle their dispute without litigation; agree that Jacksonville has imposed a uniform solid waste processing and disposal fee that meets the terms of the Interlocal Agreement; agree that Atlantic Beach will pay \$322,709 in past due residential and sludge tipping fees and will begin paying applicable tipping fees going forward through its waste hauler contract; agree that Atlantic Beach will pay 50% of the applicable sludge tipping fees; agree that, should Jacksonville and Neptune Beach settle their separate tipping fee dispute at a rate lower than provided in this agreement, Jacksonville will reimburse Atlantic Beach for the difference between the two rates for amounts previously paid; and agree that Jacksonville has paid past-due yard waste tipping fees for Atlantic Beach yard waste due to Advanced Disposal Services of Jacksonville for the period of October 2011 through September 2012.

Policy Impact Area: Interlocal Agreement dispute resolution; solid waste operations

Fiscal Impact: Atlantic Beach will pay \$322,709 in past due residential and sludge tipping fees and will begin paying current applicable tipping fees going forward.

One-cycle emergency consideration is requested in order for the agreement to take effect in mid-February.

Background Information: The Navy is about to undertake a major runway renovation project at NAS Jacksonville, during which time the aircraft based at NAS will be relocated to Cecil Field Airport. This license agreement authorizes the Navy to relocate some of its firefighting equipment and personnel to the Cecil Field Airport fire station for 15 months from February 2015 through May 2016, with one 6-month renewal option, to support the Navy's flight operations. The agreement authorizes the Navy to patch, topcoat and stripe a parking lot for its use and to construct a sidewalk from the parking lot to the fire station.

Bill Summary: This bill approves an agreement with Habitat for Humanity of Jacksonville, Inc., a not for profit corporation (HabiJax), to refund COJ the City's cost in acquiring and donating to HabiJax the lands in this agreement, and render title to the lands marketable where possible; and waives the provisions of Section 122.461, *Ordinance Code*.

Background Information: All of the lands within this agreement are in Council Districts 7, 8, or 9. In 2002, the City used Community Development Block Grant (CDBG) funds to prosecute municipal lien foreclosure proceedings against certain lots. After judgments were obtained, the City retained successful bids at the foreclosure sales from HabiJax to construct residential housing for persons of low to moderate income. HabiJax became the record owner, on or about January 6, 2003, of the foreclosed lots and constructed housing on several of the properties. HabiJax was unable to transfer insurable titles on four properties due to interest of "true owners". The costs for foreclosure on these lots were previously reimbursed to the City. According to Section 95.12, Florida Statutes, HabiJax has satisfied the allotted time to file for quiet title on the remaining foreclosed lots. Although some the lots are unbuildable, HabiJax will retain ownership.

The City waives the reconveyance requirement because the lots are unproductive for City uses; and HabiJax is now able to render title insurable and proceed with construction on buildable lots; and will reimburse CDBG grant funds used to acquire the properties.

The U.S. Forest Service approves the proposed exchange of properties to remove the easement from the Preserve; the exchange would improve the City's ability to manage the Preserve and create net conservation value to the Preserve. In 2013, LTR began to expand to satellite sites in Downtown and North Jacksonville areas. Sites include Community Connections – serving adults Downtown Jacksonville; The Clara White Mission – serving adults in Downtown Jacksonville; the Tiger Academy, a YMCA Charter School – serving adults in North Jacksonville. There are an estimated 72,000 adults in Duval County who are not proficient readers. By providing direct instruction to 1,070 of those adults in the past four years, LTR has been able to help them gain the literacy and comprehension skills necessary to: read and fill out job applications, pass written portions of a driver's license exam, read and complete a voter registration form, read instructions on a prescription bottle label. The Olga L. Bradham and Etta L. Brooks Library is located in the 32208 zip code, surrounded by zip codes 332206 and 32209. One cycle emergency passage is requested. The nature of the emergency is that LTR has several pending grants that require these locations to be up and running as soon as possible.

Recently State Representative Janet Adkins, the Chair of the Duval Legislative Delegation, wrote a letter to Governor Scott requesting him to direct the state's Chief Inspector General and the Florida Department of Law Enforcement to audit, investigate and review the operations of the Police and Fire Pension Fund. This resolution expresses support for Rep. Adkins' request.

Bill Summary: This bill confirms the Mayor's appointment of Searcy C. Dannheim as a member of the Jacksonville Historic Preservation Commission, replacing Richard Moore, for a first full term ending March 4, 2017.

Background Information: The Jacksonville Historic Preservation Commission is established pursuant to Chapter 76, Ordinance Code, and charged to conduct an ongoing survey and inventory of historic buildings, areas, and archaeological sites in the City of Jacksonville and to plan for their preservation; identify potential landmarks and potential landmark sites and to make recommendations to the City Council as to whether such should be officially designated; recommend that the City Council designate specified areas as historic districts and to identify which structures should be considered to be contributing structures; develop specific guidelines for the alteration, construction, relocation or removal of designated property; promulgate standards for architectural review which are consistent with standards for rehabilitation established by the United States Secretary of the Interior; approve or deny applications for certificate of appropriateness for alteration, construction, demolition, relocation or removal of landmarks, landmark sites, and property in historic districts; initiate plans for the preservation and rehabilitation of individual historic buildings; undertake public information programs including the preparation of publications and the placing of historic markers; conduct public hearings to consider historic preservation issues, the designation of landmarks, landmark sites, and historic districts, applications for certificate of appropriateness and nominations to the National Register of Historic Places; and administer Chapter 307, Ordinance Code.

Bill Summary: This bill amends Chapter 656 (Zoning Code), Part 3 (Schedule of District Regulations), *Ordinance Code*, to establish development standards for single-family dwelling in the medium density residential category to reflect the Residential Low Density (RLD-40) Zoning District Standards.

Background Information: The standards listed reflect the change in the Code:

• Minimum lot requirements for single-family dwellings (RMD-A through RMD-D):

Width – 40 feet

Area -4,000 square feet

• Minimum yard requirements for single-family dwellings located on individual lots:

Front – 20 feet

Side - 3 feet, or zero lot line zero lot line provided ten feet on one side between buildings. For existing single family residential uses, zero lot line shall only be permitted through Administrative Deviation.

Rear – 10 feet

Bill Summary: The ordinance appropriates \$43,011 (\$15,000 from the Mayor's Executive Operating Contingency – Reserve Account and \$28,011 from Special Council Operating Contingency) to the Circuit Court – Administration Judicial Support (\$11,011 to the Capital Items Office Furniture and Equipment including Fax account and \$32,000 to the Specialized Equipment Account) to restore cuts to the Courts; *requests one cycle emergency passage*.

Background Information: The purpose of the appropriation is to restore the courts share of the budgetary cuts that the Finance Committee imposed. The cuts reduced the special equipment account by \$32,000 and the Capital items account by \$11,011. The nature of the emergency is that the courts are anticipating a shortfall in the operating budget and require transfer of these funds to meet current obligations and so as not to operate in a deficit.

Bill Summary: The bill amends previous Ordinance 2013-264-E to extend the date by which council district recreation funds deriving from Loblolly Wetlands Mitigation Fund revenue must be expended from September 30, 2014 to June 30, 2015. Emergency approval of the bill on first reading is requested.

Background Information: The Loblolly Wetlands Mitigation Fund was created in 2003 in conjunction with the purchase of 4,878 acres of land on the Westside and the formation of the Loblolly wetlands mitigation bank to provide wetlands credits to mitigate for the effects of Better Jacksonville Plan projects on regulated wetlands. Ordinance 2013-264-E appropriated \$2,040,000 in revenue from the sale of "excess" credits to the Jacksonville Zoo and Gardens and appropriated \$200,000 to each of the 14 Council districts for park improvement purposes. The ordinance required that the district park funds be expended by September 30, 2014 or revert to the fund of origin. This bill extends the expenditure deadline by an additional 9 months to June 30, 2015.

Policy Impact Area: Recreational improvement

Fiscal Impact: None – the bill extends the deadline for use of existing funds before reversion to the originating fund.
