Section 59.103, Ordinance Code, provides that the members of the Duval County Election Advisory Panel shall be Duval County registered voters and three of the nine members shall be designated by the Mayor and confirmed by the City Council.

**Bill Summary:** The bill requests the Mayor to resolve the solid waste tipping fee issues between the City of Jacksonville and the cities of Atlantic Beach and Neptune Beach and recommends a two-stage process of first determining a fair tipping fee for disposal of waste in the future, then a separate resolution of the amount of and a repayment mechanism for past-due tipping fees.

**Background Information:** The original 1982 Interlocal Agreements between the City of Jacksonville and Atlantic Beach, Neptune Beach and Jacksonville Beach provided that the Beaches cities could dispose of their solid waste in the City's landfill at no charge. Amendments to the Atlantic Beach and Neptune Beach Interlocal Agreements in 1995 provided that if and when the City instituted a uniform solid waste processing and disposal fee on Jacksonville residences, then those cities would no longer receive free landfill tipping. The City imposed a residential solid waste fee in 2007 but Atlantic Beach and Neptune Beach have not paid a landfill tipping fee bills sent by the City since that time. This resolution urges Mayor Brown to resolve the tipping fee impasse so that the terms of the Interlocal Agreements are being complied with.

**Bill Summary:** The bill expresses the City Council's support for legislative bill J-4 that would create a Duval County Library Authority with taxing capacity, subject to voter referendum approval.

**Background Information:** The bill provides for the creation of a library district that would be governed by a 5member board consisting of the Mayor, 3 City Council members and the chair of the Duval County School Board, which would have the power to levy up to 1 mill of property tax and to issue bonds for library capital improvements. The new district would not have the power to exercise eminent domain. The current Library Board of Library Trustees would continue to exist and would be responsible for setting library policy, hiring staff, and otherwise overseeing the day-to-day operations of the library system. The new district and governing board would become effective upon favorable passage of a referendum by the county's voters at a future election.

A group has collected over 26,000 verified signatures on petitions to place a straw ballot question on the August 2014 primary election ballot asking Duval County voters if they favor the creation of a Duval County Library Authority to govern and fund the library system so that it would have independent revenue and not be subject to the annual competition for City funding during the budget hearing process. The petition drive organizers hope that the number of petitions received will help to convince the Duval Legislative Delegation of the support for the library district among the city's voters and will encourage them to act favorably on the J-bill in the upcoming session, and in turn will convince the City Council to schedule a binding referendum on the creation of the district at the next available general election opportunity following the August primary.
