Background Information: The purpose of the change is to allow citizens who are attending a council meeting for the purpose of participating in a scheduled public hearing on specific legislation to have the opportunity to give their input earlier in the meeting than is currently the case, when public hearings follow first, second and third reading actions, the Addendum to the Agenda (if any) and the first open public comment period. A lengthily-debated third reading item or an extended session of Public Comment can delay the scheduled public hearings for several hours, inconveniencing citizens who wish to participate in one or two specific items and then depart to attend to other business.

Background Information: This ordinance would enable the City to receive and appropriate \$200,000 in grant funding from the State of Florida Department of Environmental Protection for public outdoor recreation improvements. The park improvements will include the renovation of the splash pad, an ADA accessible kayak launch, picnic facilities and additional playground equipment. The improvements will be near the existing picnic area and playground equipment. This park serves the greater Jacksonville area.

Bill Summary: The bill appropriates \$200,000 from the Countywide Economic Development II fund to provide additional funding for the commercial or retail façade renovation grant program for businesses in economically distressed areas. It requires the Office of Economic Development to report to the City Council and Council Auditor on a bi-annual basis on the use of the funds.

Background Information: When the City's Public Investment Policy was rewritten several years ago, a façade renovation grant program was created to incentivize small businesses to improve their operations and combat blight by making improvements to the exterior of their facilities. The City provides 2-to-1 matching dollars for business located in defined economically distressed areas to make certain qualifying improvements (painting, cleaning, repairs, doors, windows, awnings, signage, etc.). Most of the original funding of \$200,000 for the program from Ordinance 2016-522-E has been encumbered (\$183,915, although none yet paid out), so this allocation from the Countywide Economic Development II fund will recapitalize the program to enable additional façade improvement grants. The current available balance in the Countywide Economic Development II fund is \$383,783.

Policy Impact Area: Economic development

The funds include \$1,809,962.00 in new revenue collected from the foreclosure registry and a re-allocation of \$1,347,231.27 in previously appropriated funds from foreclosure intervention and group hospitalization insurance.

Background Information: Revenue collected from the foreclosure registry is from mortgagees with properties that are in default in accordance with Chapter 179, *Ordinance Code*. These funds will be used to support community revitalization efforts, batch foreclosure, gap financing program, matching grants and educational/communication tools/training. In addition, these funds will be used to cover the administrative activities of the registry (implementation of the programs as well as management of the enforcement process). There are currently 4 FTE positions authorized for this program. This funding is to cover the programmatic needs through FY2019 and a portion of FY2020. There will not be ongoing maintenance.

Bill Summary: This bill appropriates \$15,000.00 grant from the Northeast Florida Healthcare Coalition (NEFLHCC) to fund the purchase for the Jacksonville Fire and Rescue Department's rescue units of an Aeroclave Decontamination Unit, as initiated by B.T. 19-036; approves and authorizes the Mayor, or his designee, and the Corporation Secretary to execute and deliver the Memorandum of Agreement between Northeast Florida Regional Council and Jacksonville Fire Rescue Department; and provides oversight by the Jacksonville Fire and Rescue Department.

Background Information: The Aeroclave Decontamination Unit is a state of the art decontamination system that uses a dry mist to provide effective disinfection of all surfaces and is 90% more effective than traditional manual cleaning techniques and products. The equipment offers mobile sterilization to the rescue units. The grant funds must be expended by June 1, 2019, and are available through reimbursements only.

With concerns over MRSA, Ebola, HIV, Hepatitis, VIERS, and a variety of other bacteria and viruses, having the capability to increase efficiency and timeliness in disinfecting rescue units and fire stations is crucial. The Aeroclave allows rescue units to return to service for quicker response and continuity of the healthcare delivery system. A rescue's availability will be essential during times of disease outbreaks and pandemics when the transportation assets will be in high demand. The safety of future patients and medical crews is essential. Removing the chance for exposure to illness from inadequately cleaned surfaces helps maintain the availability of the EMS workforce during times of high demand.

Background Information: A native of Jacksonville, Gary Lee Mills, Sr. had a career in the U.S. Air Force before his honorable discharge in 1977; he subsequently spent 20 years working as a certified aircraft mechanic for Naval Air Depot (NADEP). In 1977, Mr. Mills co-founded the School of Success Academy (SOS), a charter middle school that remains the oldest operating charter school in Duval County. Mr. Mills was very active in the community volunteering with numerous organizations including Project S.O.C.K. (Save Our Community and Kids), Sweetwater Athletic Association, the Potter's House Christian Academy football team, the Mary L. Gibbs Boys and Girls Club, Sweetwater Community Association, Sweetwater Neighborhood Watch and SHADCO. Mr. Mills resided for more than 10 years within 5 miles of the street proposed for the honorary designation. In October and November 2018, the Planning & Development Department mailed notifications to property owners concerning the designation and solicited their consent or objections. A private donor has remitted the funds necessary for the costs of the honorary markers.

By invoking the exception in Sec. 126.107(g), Ordinance Code, the vehicle procurement is exempted from competitive solicitation because the supplies are to be provided by those specifically prescribed within authorizing legislation.

Background Information: The purpose of this legislation is to provide funding for the purchase of 38 covert vehicles for JSO. Fleet Management had planned to lease the vehicles under an existing leasing contract with The Bancorp Bank, but has now determined that it is in the City's best interest to purchase the vehicles. By purchasing the vehicles outright, instead of leasing, the City will save at least \$577,022 over a four year period.
