Bill Summary: The bill authorizes a provisional appropriation of up to approximately \$3.1 million from the Mobility Zone 4 Special Revenue Fund to Signature Parkway, LLC as reimbursement for the company's construction of transportation improvements on Duval Road in lieu of payment of a fair share assessment or mobility fee. The bill directs the Planning and Development Department to make quarterly requests to the Mayor's Budget Review Committee (MBRC) for disbursement of the provisionally appropriated funds from Mobility Zone 4 account until such time as the funds have been fully paid out, and authorizes an initial payment of \$235,000 from the fund to be disbursed immediately from available Zone 4 funds.

Background Information: In 2008 the City entered into a fair share contract with Signature Land, Inc. to allow the company to make improvements to Duval Road in lieu of making fair share payments. Signature Land assigned its rights and obligations under the agreement to Signature Parkway, LLC which has completed the road improvements using private funds and a City contribution of \$3,095,692.27, and was awarded \$9,407,900.73 in fair share credits. Several subsequent amendments to the fair share contract have approved an additional contribution from the JIA Community Redevelopment Agency tax increment district of \$3.4 million toward the project and additional credits (now mobility fee credits rather than the original fair share credits). Signature is currently owed \$1,296,375.73 in credits, and \$1,783,683.00 in cash toward Extraordinary Improvement Costs (primarily related to railroad grade crossing expenses) approved by the Public Works Department and the Planning and Development Department.

This bill authorizes the disbursement of the remaining amounts by the City without further Council action as funds accumulate in the Mobility Zone 4 account, with the Planning and Development Department making quarterly disbursement requests to the MBRC for payment as funds accumulate in the account.

Policy Impact Area: Roadway improvements; fair share/mobility fee disbursement

Fiscal Impact: The bill provides for the appropriation of \$3,084,181.73 to the company from the Mobility Zone 4 account as funds accumulate.

Bill Summary: The bill publishes the "rolled back millage rates" for tax year 2014, based on certified taxable values provided by the Property Appraiser, as follows:

General Services District (GSD - countywide), excluding Urban Services Districts 2 – 5: 11.1517 mills GSD within USD 2 (Jax Beach), USD 3 (Atlantic Beach), and USD 4 (Neptune Beach): 7.7758 mills GSD within USD 5 (Baldwin): 9.4990 mills

The bill proposes the following millage rates to fund the Mayor's proposed FY 2014-15 budget:
General Services District (GSD), excluding Urban Services Districts 2 – 5: 11.4419 mills
GSD within USD 2 (Jax Beach), USD 3 (Atlantic Beach), and USD 4 (Neptune Beach): 8.1512 mills
GSD within USD 5 (Baldwin): 9.6312 mills

Finally, the bill sets the required public hearing on the proposed millage rate and tentative budget for the Council meeting of September 9th and requests emergency adoption of the resolution.

The bill is requested for emergency passage on first reading in order to meet the state mandated deadline of August 4 to report a proposed millage rate to the Property Appraiser for mailed notification to all property owners.

Background Information: Florida law requires that the City annually publish the "rolled back millage rate", which is the millage rate that would be required to be levied on this year's (higher) property valuations to produce the same amount of ad valorem tax revenue produced by last year's millage rate. The county millage rates for the current year as follows: GSD (outside USDs 2-5) – 11.4419; GSD in USDs 2-4 – 8.1512; GSD in USD 5 – 9.6312. The Property Appraiser's preliminary (end of June) taxable value roll for 2014 is \$49,616,435,721, up 4% from \$47,673,605,441 in June of 2013.

Policy Impact Area: Property tax millage levy

Fiscal Impact: Provides for the levy of ad valorem property taxes calculated to produce \$527,612,369 in revenue for the FY14/15 budget.

Background Information: The total preliminary adjusted taxable value of real and personal property in the GSD, excluding the Beaches and Baldwin, is \$44,968,696,396 for tax year 2014 (up 3.8% from 2013's preliminary taxable value of \$43,298,648,655). The millage for GSD operations in the majority of the city represents an unchanged millage rate from 2013.

Policy Impact Area: Property tax millage levy

Fiscal Impact: Total ad valorem property taxes (real and personal) are projected to generate \$527,612,369 in revenue to the City General Fund and tax increment districts at a collection rate of 95.5%.

Bill Summary: The bill levies ad valorem taxes on real and personal property for the 2014 tax year for GSD operations in Atlantic Beach, Neptune Beach and Jacksonville Beach at a rate of 8.1512 mills, which represents a 4.83% increase from the 2014 rolled back rate, and authorizes the assessment and collection of the taxes.

Background Information: The total assessed value of taxable real and personal property in the Beaches cities is \$4,606,047,055 for tax year 2014 (up 6.3% from \$4,333,627,381 for tax year 2013). The millage for GSD operations in the Beaches cities represents an unchanged rate from tax year 2013.

Policy Impact Area: Property tax millage levy

Fiscal Impact: Total ad valorem property taxes (real and personal) are projected to generate \$527,612,369 in revenue for the FY14/15 budget at a collection rate of 95.5%.

Bill Summary: The bill levies ad valorem taxes on real and personal property for the 2014 tax year for GSD operations in the Town of Baldwin at a rate of 9.6312 mills, which represents a 1.39% increase from the 2014 rolled back rate, and authorizes the assessment and collection of the taxes.

Background Information: The total preliminary adjusted taxable value of real and personal property in the Town of Baldwin is \$41,692,270 for tax year 2014 (up fractionally from \$41,329,405 in 2013). The millage for GSD operations in the Town of Baldwin represents an unchanged rate from tax year 2013.

Policy Impact Area: Property tax millage levy

Fiscal Impact: Total ad valorem property taxes (real and personal) are projected to generate \$527,612,369 in revenue for the FY14/15 budget at a collection rate of 95.5%.

Bill Summary: The bill adopts the 2014-15 budgets for the City and its independent agencies and authorities. The proposed General Fund GSD departmental expenditure budget is \$946,438,107, with a total City departmental expenditure budget (General Fund, Special Revenue, Capital Projects, Enterprise, Internal Service, Trust and Agency Funds, and Other Component Units) of \$2,092,670,395. Non-departmental expenditures, interfund transfers and reserves are budgeted at \$365,700,249 for total appropriations, reserves and cash carryover of \$2,458,370,644.

The bill sets an employee cap of 7,154. The 5-year financial projection estimates the City's General Fund GSD non-departmental revenues to increase almost imperceptibly from \$993,628,597 million (proposed) in FY14-15 to \$996,855,661 in FY18-19, with property taxes projected to grow slowly but steadily throughout the period and all other sources remaining nearly flat. The proposed FY14-15 budget utilizes nearly \$45.5 million in one-time sources, fund balance transfers and allocations from reserve accounts. The FY15-16 revenue projection, without many of those one-time allocations, falls to \$971,617,246. The bill establishes a City Public Service Grant program allocating \$6,676,501. The bill sets the employer's contributions (percentage of covered payroll) to the various pension plans at 31.90% for the General Employees' Pension Fund, 116.83% for the Police and Fire Pension Fund, and 62.81% for the Corrections Officer's Pension Fund.

The bill waives provisions of Ordinance Code that require the City to increase funding for the Jacksonville Children's Commission each year by an amount equal to the average percentage increase in all City operating department budgets, up to the value of ½ mill and waives the Ordinance Code requirement that the Mayor annually calculate and report unit cost measures and service quality measures for City government operations. Additionally the bill waives certain provisions of the Procurement Code for the purpose of allowing SMG to utilize its own competitive procurement process rather than the City's process for the purpose of capital expenditures of \$100,000 or less and for non-capital extraordinary repair and maintenance projects of \$500,000 or less. The bill waives the Code with regard to the method for setting the salaries of City Council members so as to keep the base salaries for council members the same in FY14-15 as in FY11-12. Conflicting provisions within Code Section 10.105 regarding Council members' postage and communication expenses are waived so as to reduce the communication expense allowance to the lower of the conflicting provisions. The bill waives the City's debt management parameters to allow borrowing to exceed certain debt ratios and waives the Code requirement that vehicle replacement be done on a cash basis. The bill waives the restriction that the Banking Fund may not be used to purchase items with a unit value of less than \$50,000 in order to permit the fund to be

used for the purchase of fleet vehicles, and waives prohibition against amending the Ordinance Code via the budget ordinance.

Bill Summary: The bill adopts the 2015-19 Capital Improvement Program and provides that no funds may be expended for any generally described line item project within the CIP that does not contain specific reference to precise locations of work, narrowly defined project costs or narrowly defined work descriptions until such project is defined and approved by City Council via a CIP amendment and specific appropriation. The bill also authorizes amendment of the Capital Improvements Element of the 2030 Comprehensive Plan to reflect the updated CIP project list. The bill waives the provision of the Ordinance Code which specifically excludes "routine roadway resurfacing" from the definition of "capital improvement" in order to permit the use of the Banking Fund for roadway resurfacing in FY14/15. It provides that any residual funding remaining in a capital project budget when the project is deemed completed by the Public Works Director shall be transferred to a fund balance account for subsequent appropriation by City Council. Residual funds from completed projects originating from City Council district accounts or from the Special Council Reserve account shall revert automatically to those funds. No project shall be deemed complete and closed out without the preauthorization of the district council member in whose district the project is located. The Public Works Director is required to make a quarterly report to the City Council of all projects deemed to be completed. The bill acknowledges receipt of the required annual report from the Budget Office of all Capital Improvement Projects Not Lapsed.

Background Information: The CIP proposes General Fund project spending of \$111.9 million in FY14/15, with \$99.75 million of that amount being in the form of Banking Fund borrowing. The largest projects are \$13.6 million for roadway resurfacing, \$12.3 million for ash site remediation, and \$11.8 million for Jacksonville Landing infrastructure improvements. \$13.58 million of stormwater projects is proposed utilizing \$7.75 million in borrowing and \$5.8 million in pay-as-you-go funding. \$49.7 million in borrowing is allocated for solid waste projects, including \$43 million for Trail Ridge Landfill expansion and \$6.7 million for compressed natural gas conversion of vehicles.

Policy Impact Area: Capital improvement budgeting

Fiscal Impact: The City's project cost for FY14-15 (General Fund, stormwater, solid waste and CRA) is \$178.567.140.

Bill Summary: The bill authorizes Banking Fund borrowing in an amount necessary to provide \$213,651,192 in net project funds to apply to capital projects for FY14-15. That amount is accomplished by authorizing \$230,080,597 in new projects, offset by \$16,429,405 in removal or de-authorization of previously approved projects. The Banking Fund borrowing cap is set at \$810,261,053 in net project funds (comprised of \$882,954,798 in cumulative new project authorizations offset by \$72,693,745 in completed or de-authorized projects). The bill recognizes the fact that the City Council has authorized \$378,116,117 of net project funding that has not yet been borrowed.

Background Information: The Banking Fund is the primary source of borrowing for the City's capital improvement projects. The largest Banking Fund allocations for FY14-15 are for ash site remediation (\$12,328,000), Jacksonville Landing public infrastructure improvements (\$11,800,000), roadway resurfacing (\$9,972,100) and ADA compliance curb cuts and ramps (\$7,500,000).

Policy Impact Area: Capital project funding

Fiscal Impact: The bill authorizes \$230,080,597 in new projects, offset by \$16,429,405 in removal or deauthorization of previously approved projects, and an increase in the overall Banking Fund borrowing cap to \$810,261,053 in net project funds.

Bill Summary: The bill adopts the FY15-19 Information Technology System Development Program (ITECH) as required by the Budget Code. The 5-year plan encompasses a total of \$52,829,053 in IT projects, with \$31,652,854 (59%) being programmed for FY14-15, then steadily declining to \$810,000 in projects for FY18-19. 98% of the project funding is to be provided via borrowing, 2% on a pay-as-you-go basis.

Background Information: The largest projects on the ITECH list for FY14-15 are \$11.8 million to begin the replacement of the City's financial and employee management systems (FAMIS, Oracle, etc.) with a new integrated, hosted financial/resource management system; \$11.4 million for police and fire radio system refreshes, and \$2.74 million for a new permits/inspections/citations management system.

Policy Impact Area: Information technology improvements and funding

Fiscal Impact: The 5-year plan encompasses a total of \$52,829,053 in IT projects to be financed primarily via borrowing (98%) with a small amount (2%) of pay-as-you-go funding.

Background Information: Ordinance 2013-414-E provided for those that took residual waste out of the county not to be assessed a host fee which is collected and divided in to three sub programs: contamination assessment and remediation programs at closed landfills; landfill closure; and landfill mitigation which benefit the surrounding properties in the neighborhood of the landfills.

Subsequently, the provision of Ordinance 2013-414-E has developed an inequitable situation between those that take residual waste out of the county and those that do not.

Bill Summary: The bill amends Ordinance Code Chapter 35 – Regulatory Compliance Department to create a new Consumer Affairs Office to be responsible for enforcing and administering all laws and ordinances relating to consumer affairs, deceptive and unfair trade practices and charitable solicitations. The bill also amends Chapter 250 – Miscellaneous Businesses, Chapter 696 – Deceptive and Unfair Trade Practices, and Chapter 804 – Traffic Code to make reference to the new Office of Consumer Affairs in provisions regarding enforcement of various ordinances now being assumed by the office. The bill also makes several other scrivener's corrections of department and division names that were left unchanged after recent administrative reorganizations.

Background Information: The City appears to have had a Consumer Affairs office or division of some sort since the time of consolidation, which was shifted from department to department through numerous administrative reorganizations over the years. The reorganization approved by Ordinance 2011-732-E in December 2011 repealed the Consumer Affairs Division as it then existed in the Environmental and Compliance Department. This bill re-creates a Consumer Affairs Office in the Regulatory Compliance Department and makes reference to the Office in other Code chapters where Consumer Affairs is given responsibility for regulation and enforcement of ordinances regarding miscellaneous business regulations (downtown and sidewalk vendors, peddlers, transient merchants, ice cream trucks, etc.), deceptive and unfair trade practices (i.e. counterfeit goods, false or misleading advertising, etc.) and, permitting of charitable solicitations in public rights-of-way.

Policy Impact Area: Consumer protection

Fiscal Impact: Expected to be minimal; functions will be performed by existing personnel.

Philip Randolph Entertainment District – to provide for a waiver of special event permitting deadlines with the concurrence of various City officials and to provide for a reduction in the amount of one type of commercial general liability insurance required by the City of special event organizers.

Background Information: The amendment provides that, subject to application deadlines established by other permitting agencies such as the National Park Service, US Coast Guard and Florida Department of Transportation, the Chief of Special Events may waive the City deadlines for special event permitting applications (at least 90 days, but no more than 365 days, in advance of the event) with the approval of the following officials or their designees: Chief Administrative Officer, Chief Financial Officer, Director of Sports and Entertainment, and the Sheriff. The ability waive application deadlines will allow the City to be more accommodating of smaller events frequently organized by volunteers and small organizations that may not have the expertise, staff and resources to be aware of permitting regulations months in advance of their events. The bill also reduces the amount of required Commercial General Liability – Products and Completed Ops Aggregate coverage from \$2 million to \$1 million.

Policy Impact Area: Special events permitting

Fiscal Impact: None to City; reduced insurance cost to event organizers because of the reduction in the amount of insurance required.

This bill corrects that omission and approves a new license agreement for Metropolitan Park that incorporates the updated indemnification and insurance language.

Background Information: Effective July 1, 2014, Ms. Laquidara resigned her position as General Counsel and took a position with the Akerman, LLP law firm. In December 2013 another former City attorney, Carol Mirando, resigned from the Office of General Counsel to take a position as a federal magistrate. The City is currently involved in 4 federal lawsuits in which Ms. Laquidara and Ms. Mirando were involved: *Monaco v. City of Jacksonville*, a case involving an alleged violation of the Americans with Disabilities Act by the City in refusing to let a number of City employees join the pension plan because medical exams found pre-existing medical conditions; and *U.S. v. City of Jacksonville*, et. al., Smith, et. al. v. City of Jacksonville and NAACP v. City of Jacksonville, cases alleging racial discrimination in the hiring of firefighters. The City is also in the midst of a pension reform process with the Police and Fire Pension Fund. The Office of General Counsel, citing the loss of these two trial attorneys and numerous upcoming deadlines in the pending cases, has determined that outside counsel with intimate knowledge of the four lawsuits is needed to carry these cases to final decisions. Therefore the bill authorizes the hiring of Cindy Laquidara of Akerman, LLP as special counsel at an hourly rate of \$385, up to a maximum indebtedness of \$150,000, to litigate the cases over the next several months and to advise as needed as the pension reform process moves forward.

The cooperation in the City providing aviation mosquito control services is authorized by Section 388.381, Florida Statutes, upon approval of the Florida Department of Agricultural and Consumer Services. The City of Jacksonville invoices the AIMCD for recovery of expenses and/or replenishment of supplies. The AIMCD is required to provide notification of its citizens via the local media regarding dates, times and locations of the aerial operations. The Amelia Island Mosquito Control District is a special taxing district in Nassau County. The Interlocal Agreement stipulates that the City provides a pilot, chemicals, fuel, oils and aviation liability insurance on its aircraft. The District reimburses the City (within 30 days of receipt of invoices) for flight hours at the current rate of \$661.00 per hour of flight time by helicopter. The District provides monetary reimbursement or replenishes all supplies used by the City for services including chemicals, fuels, oils and other supplies. The service is considered mutually beneficial because salt marsh mosquitos can migrate from Nassau County to Duval County. By spraying at the source, Duval County's interests are also being served.

Bill Summary: The bill encourages the Council President to utilize the authority provided in Sec. 108.505(b) of the Ordinance Code to authorize the Office of General Counsel to employ former General Counsel Cindy Laquidara, now with Akerman, LLP, as special counsel for a limited engagement to meet immediately impending deadlines on several pending federal court cases.

Background Information: Ordinance Code Chapter 108 – Central Services – authorizes the General Counsel to procure the services of outside counsel as primary counsel or co-counsel for a limited engagement for an amount not to exceed \$50,000 per year with the written approval of the Council President. This bill was proposed by the Finance Committee as an alternative to pending Ordinance 2014-483 that would appropriate \$150,000 within the Office of General Counsel budget to engage Ms. Laquidara for a longer period to handle the pending federal litigation and to consult on pension reform issues as necessary.

Effective July 1, 2014, Ms. Laquidara resigned her position as General Counsel and took a position with the Akerman, LLP law firm. In December 2013 another former City attorney, Carol Mirando, resigned from the Office of General Counsel to take a position as a federal magistrate. The City is currently involved in 4 federal lawsuits in which Ms. Laquidara and Ms. Mirando were involved: Monaco v. City of Jacksonville, a case involving an alleged violation of the Americans with Disabilities Act by the City in refusing to let a number of City employees join the pension plan because medical exams found pre-existing medical conditions; and U.S. v. City of Jacksonville, et. al., Smith, et. al. v. City of Jacksonville and NAACP v. City of Jacksonville, cases alleging racial discrimination in the hiring of firefighters.
