The bill names the initial members of the governing Board of Supervisors ("Board") of Boggy Branch Community Development District: Jan Malcolm Jones, Jr.; Arthur Chester Skinner, IV; James DuBois Farrar; Breanna Danae Bohlen and Bryan David Hassel.

The bill amends Chapter 92 (Uniform Development Districts) of the Ordinance Code, Section 92.22 (Existing Community Development Districts) to include the Boggy Branch Community Development District.

Background Information: The Office of General Counsel has reviewed the Petition finding that it is sufficient, complete and ready to be brought to Council. Sawmill Timber, LLC, a Florida limited liability corporation, petitioned the City Council to establish the Boggy Branch Community Development District on approximately 559.96 acres lying wholly within the boundaries of the City. The CDD is designed to contain a total of approximately 1,800 residential units. The Annual Outlay of the CDD are estimated to be made, constructed, and installed in three three-year phases, 2021-2024, 2025-2028 and 2029-2032.

Policy Impact Area: Uniform Development Districts, District 11 roadways and development

Fiscal Impact: The City of Jacksonville and its residents not residing in the boundaries of the CDD will not incur any compliance costs related to the establishment and ongoing administration of the district. There are minimal annual costs to the city in receiving and reviewing the required reports submitted to the city by the CDD. Initial construction and related costs are funded by the CDD. Minimal costs are anticipated for the ongoing maintenance of COJ owned facilities in the CDD such as "roadways" and "traffic signals".

The bill amends Chapter 92 (Uniform Development Districts) of the Ordinance Code, Section 92.22 (Existing Community Development Districts) to include the Ryals Creek Community Development District.

Background Information: The Office of General Counsel has reviewed the Petition finding that it is sufficient, complete and ready to be brought to Council. Sawmill Timber, LLC, a Florida limited liability corporation, petitioned the City Council to establish the Ryals Creek Community Development District on approximately 414.19 acres lying wholly within the boundaries of the City. The CDD is designed to contain a total of approximately 1,319,000 square feet of commercial uses and 230 multi-family units, all within the CDD boundary. The improvements to the CDD are estimated to be made, constructed, and installed in three phases over the time period from 2020 through 2022, with the Southern Access Route to be constructed in 2026.

Policy Impact Area: Uniform Development Districts, District 11 roadways and development

Fiscal Impact: The City of Jacksonville and its residents not residing in the boundaries of the CDD will not incur any compliance costs related to the establishment and ongoing administration of the district. There are minimal annual costs to the city in receiving and reviewing the required reports submitted to the city by the CDD. Initial construction and related costs are funded by the CDD. Minimal costs are anticipated for the ongoing maintenance of COJ owned facilities in the CDD such as "collector roads" and "traffic signals".

Bill Summary: The bill authorizes the execution of an economic development agreement between the City of Jacksonville and Project Quail (name temporarily confidential) supporting the creation of Project Quail's new regional headquarters in Jacksonville. The bill makes a recommendation to the state of Florida's Department of Economic Opportunity that Project Quail be considered a Qualified Target Industry (QTI). The bill authorizes the Mayor or his designee to be the authorized official of the city for the purpose of executing the agreement and any contracts, documents and any other actions relating to the agreement. The Executive Director of the Office of Economic Development, as contract administrator, is authorized to negotiate and execute all necessary changes and amendments to the agreement and other contracts and documents, to effectuate the purposes of this Resolution, without further Council action. The Office of Economic Development will provide oversight and administration.

Background Information: Project Quail is an international web-based financial services company. Quail, which offers various personal loan products, is considering locating a Southeast Operations Center in Jacksonville. A few other cities in the Southeast are also under consideration for the proposed project. If Jacksonville is selected, the company proposes to create a minimum of 300 full-time jobs by the end of 2021. The average annual wage of the jobs is \$54,941, plus benefits. Project Quail has stated that the City of Jacksonville and State of Florida financial incentives are a material factor in their decision to establish their new Southeast Operations Center in Jacksonville.

Policy Impact Area: Economic development

Fiscal Impact: Participate in the State of Florida Qualified Targeted Industry (QTI) Tax Refund Program. The QTI proposed is \$5,000 per job. The City portion of the QTI is 20 percent of the award, or \$1,000 per new qualified job created, up to a maximum of \$300,000 (300 jobs). The QTI award will be payable after the average wage and job created is verified by the Florida Department of Economic Opportunity over the proposed four-year payout, beginning in 2022.

Bill Summary: The bill publishes the "rolled back millage rates" for tax year 2019, based on certified taxable values provided by the Property Appraiser, as follows:

General Services District (GSD - countywide), excluding Urban Services Districts 2 – 5: 10.8108 mills GSD within USD 2 (Jax Beach), USD 3 (Atlantic Beach), and USD 4 (Neptune Beach): 7.7216 mills GSD within USD 5 (Baldwin): 9.4323 mills

The bill proposes the following millage rates to fund the Mayor's proposed FY 2019-20 budget:
General Services District (GSD), excluding Urban Services Districts 2 – 5: 11.4419 mills
GSD within USD 2 (Jax Beach), USD 3 (Atlantic Beach), and USD 4 (Neptune Beach): 8.1512 mills
GSD within USD 5 (Baldwin): 9.6312 mills

Finally, the bill sets the required public hearing on the proposed millage rate and tentative budget for the Council meeting of September 10th and requests emergency adoption of the resolution.

The bill is requested for emergency passage on first reading in order to meet the state mandated deadline of August 4th to report a proposed millage rate to the Property Appraiser for mailed notification to all property owners.

Background Information: Florida law requires that the City annually publish the "rolled back" millage rate, which is the millage rate that would be required to be levied on this year's (higher) property valuations to produce the same amount of ad valorem tax revenue produced by last year's millage rate. The county millage rates for the current year as follows: GSD (outside USDs 2-5) – 11.4419; GSD in USDs 2-4 – 8.1512; GSD in USD 5 – 9.6312. The Property Appraiser's preliminary (end of June) gross taxable value roll for 2019 is \$68,449,411,924, up 7.6% from the preliminary value of \$63,557,099,633 in June of 2018.

Policy Impact Area: Property tax millage levy

Fiscal Impact: Provides for the levy of ad valorem property taxes calculated to produce \$690,634,612 in revenue for the FY19-20 budget.

Bill Summary: The bill levies ad valorem taxes on real and personal property for the 2019 tax year for GSD operations (excluding the Beaches and Baldwin) at a rate of 11.4419 mills, which represents a 5.84% increase from the 2019 rolled back rate, and authorizes the assessment and collection of the taxes.

Background Information: The total preliminary adjusted taxable value of real and personal property in the GSD, excluding the Beaches and Baldwin, is \$60,543,354,971 for tax year 2019, up 5.7% from 2018's preliminary taxable value of \$57,269,483,393. The millage for GSD operations in the majority of the city represents an unchanged millage rate from 2018.

Policy Impact Area: Property tax millage levy

Fiscal Impact: Total ad valorem property taxes (real and personal) are projected to generate \$690,634,612 in revenue to the City General Fund and the tax increment districts at a collection rate of 95.5%.

Bill Summary: The bill levies ad valorem taxes on real and personal property for the 2019 tax year for GSD operations in Atlantic Beach, Neptune Beach and Jacksonville Beach at a rate of 8.1512 mills, which represents a 5.56% increase from the 2019 rolled back rate, and authorizes the assessment and collection of the taxes.

Background Information: The total assessed value of taxable real and personal property in the Beaches cities is \$6,641,643,208 for tax year 2019, up 6.4% from \$6,240,225,683 for tax year 2018. The millage for GSD operations in the Beaches cities represents an unchanged rate from tax year 2018.

Policy Impact Area: Property tax millage levy

Fiscal Impact: Total ad valorem property taxes (real and personal) are projected to generate \$690,634,612 in revenue to the City General Fund and the tax increment districts for the FY19/20 budget at a collection rate of 95.5%.

Bill Summary: The bill levies ad valorem taxes on real and personal property for the 2019 tax year for GSD operations in the Town of Baldwin at a rate of 9.6312 mills, which represents a 2.11% increase from the 2019 rolled back rate, and authorizes the assessment and collection of the taxes.

Background Information: The total preliminary adjusted taxable value of real and personal property in the Town of Baldwin is \$48,729,631 for tax year 2019, up 2.8% from \$47,390,557 in 2018. The millage for GSD operations in the Town of Baldwin represents an unchanged rate from tax year 2018.

Policy Impact Area: Property tax millage levy

Fiscal Impact: Total ad valorem property taxes (real and personal) are projected to generate \$690,634,612 in countywide revenue to the City General Fund and the tax increment districts for the FY19/20 budget at a collection rate of 95.5%.

Bill Summary: The bill adopts the 2019-20 budgets for the City and its independent agencies and authorities, its constitutional officers, the City's Community Redevelopment Agencies (CRAs) and for the Duval County Tourist Development Council. The proposed General Fund GSD departmental expenditure budget is \$1,129,923,264, with a total City departmental expenditure budget (General Fund, Special Revenue, Capital Projects, Enterprise, Internal Service, Trust and Agency Funds, and Other Component Units) of \$2,241,043,090. Non-departmental expenditures, inter-fund transfers and reserves are budgeted at \$489,324,943 for total appropriations, reserves and cash carryover of \$2,730,368,033.

The bill sets an employee cap of 7,549. The 5-year financial projection estimates the City's General Fund GSD revenues to increase by 10.4% from \$1,264,471,645 (proposed) in FY19-20 to \$1,396,376,428 in FY23-24, with ad valorem taxes and state shared revenues growing substantially over the period, many sources remaining nearly flat, and the utility service tax, communication services tax, and transfers from fund balance projected to decline. The bill allocates \$177,533,447 for capital improvements (\$10,608,162 for stormwater projects, \$7,022,360 for solid waste projects, and \$155,902,925 for other departmental capital improvements). The bill sets the employer's contributions to the various pension plans as follows: \$71,249,679 to the General Employees' Pension Fund (plus 0.3% of payroll for disability), \$15,042,623 to the Corrections Officer's Pension Fund (plus 0.3% of payroll for disability), and \$140,292,637 the Police and Fire Pension Fund.

The bill waives the following provisions of Ordinance Code: 1) conflicting provisions within Code Section 10.105 regarding Council members' postage and communication expenses so as to reduce the communication expense allowance to the lower of the conflicting provisions; 2) the provision requiring funding to the JSEB and MBE programs in a minimum amount of \$500,000 (excluding staff costs); 3) Code Section 111.183 requiring Taye' Brown Regional Park Improvement Trust Funds to be used for improvements to the park so as to allow the funds to be used for operational costs of the Equestrian Center; 4) provisions of Chapter 126 – Procurement Code – in order to permit SMG to procure goods and services in accordance with its own competitive procurement process for capital expenditures of \$250,000 or less and non-capital extraordinary repair and maintenance projects of \$500,000 or less; 5) the requirement to annually review fees to ensure that they are recouping at least 85% of the cost to the City of providing the service to which the fee applies; 6) the requirement \$4,000,000 or 15 percent of the total revenue received from stormwater user fees, whichever is higher, must be appropriated for stormwater capital projects; 7) the requirement in Sec. 129.103, Ordinance Code, that the Mayor's salary shall be equal to the average of the salaries of the Sheriff, Clerk of the Circuit Courts, the Supervisor of Elections, the Property Appraiser, and the Tax Collector, in a county with a population equal to that of Duval County, in accordance with the provisions of F.S. Chapter 145, plus an additional amount equal to 20% of that average; 8) the provisions of

Section 77.113, Ordinance Code (Annual operating budget; budget transfers), regarding the Kids Hope Alliance budget transfer authority; 9) the provisions of Ordinance 2000-1079-E (as amended) requiring loan repayments of VCP-Lynch Ltd. to be deposited into the Downtown Economic Development Fund.

The bill budgets the Kids Hope Alliance a total of \$43,205,886 and authorizes the KHA to transfer funds administratively via a Transfer Directive from one service provider to another within the same Essential Services Plan categories, provided that the KHA Board does not transfer appropriations greater than 10% of the individual Essential Service Plan category budget. Any KHA transfers from one agency to another agency within the Plan in excess of 10% shall require City Council approval. Transfers of appropriations from one Plan category to another Plan category shall require City Council approval. There shall be provided to the Council Auditor at the end of each quarter a copy or a summary of the written documentation of all transfers made between approved budget line items.

The bill approves exceptions to the Procurement Code's competitive procurement requirements and authorizes the KHA to directly contract with the following grant recipients:

State of FL Dept. of Health - USDA Child and Adult Care Food Program - After 21 School Food Program; State of FL Dept. of Agriculture & Consumer Services - USDA Summer Food Service Program; Healthy Families - The Ounce of Prevention FL; FL Department of Education - 21st Century Community Learning Center Grant; Department of Health & Human Services (SAMHSA) - Grant; Criminal Justice Reinvestment Grant; FL Department of Education - 21st Century Grant;

Full-service school providers: Jewish Family & Community Services, Inc.; Children's Home Society of Florida, Inc.; Child Guidance Center, Inc.; and Daniel Memorial, Inc.

Early learning and after-school programs: listed on Schedule M

The bill prohibits charge-backs by the Public Works on appropriations to discretionary council district bond fund projects. It approves the food and beverage appropriations listed on Attachment A. It provides that payments to Jacksonville Area Legal Aid from court fees and costs shall be made on a monthly basis in arrears in accordance with the contracts between the City and Legal Aid. It requires the tracking by the Public Works Department of the use of its time, equipment, materials and personnel by the Stormwater Utility and quarterly reporting of such accounting to the Council Auditor's Office and the Finance Committee. It provides that the City's indigent care appropriation to Shands Jacksonville shall not exceed \$26,275,594 and requires that all Community Redevelopment Area (CRA) board resolutions approved by CRA boards shall be forwarded (along with all attachments) to the Chief Administrative Officer for transmittal. It requires that the Finance and Administration Department's annual memo to the Council Auditor describing the year-end excess funds recapture and deposit into reserve funds this year include a report on which subfunds end the year with negative balances.

The bill requires the Public Buildings Division to justify to the Chief Financial Officer or Chief Administrative Officer the uses to be made of the \$250,000 public buildings emergency fund before they are expended. It provides that each district City Council member shall be allocated \$1,000 for postage expenses and the remainder of the Council postage budget shall be distributed at the discretion of the Council President among all members.

The bill invokes the Ordinance Code's direct contracting exception for the purpose of authorizing contracts with: Gateway Services and up to seven emergency departments for the Project Save Lives opioid response project; Prisoners of Christ, Inc. for a \$400,000 ex-offender program; New Hope Education and Addiction Services, Inc. d/b/a Florida Recovery School for a \$100,000 academic program for high school students in substance abuse recovery programs; Operation New Hope Inc. for a \$400,000 program providing assistance to people exiting the criminal justice system with treatment for chemical dependency, clothing and shelter and educational training and employment; Edward Waters College for \$161,300 to be used for the New Town Success Zone for prenatal and well-baby care to college or post-secondary training for children and their families; Groundwork Jacksonville for \$50,000 to be used for support in coordinating the McCoy's Creek and Hogan's Creek Improvements to restore and develop the Emerald Trail; United Way of Northeast Florida for \$150,000 to be used to operate the United Way 2-1-1 telephone resource line; Jacksonville Zoo and Gardens for a matching grant for capital improvements; Shands Jacksonville Medical Center, Inc. for a grant for capital maintenance and capital improvements; Agape Community Health Center, Inc. for \$150,000 to be used for primary health care services; I.M. Sulzbacher Center,

Inc. for \$270,000 to provide emergency shelter, rapid rehousing, permanent supportive housing, case management, meals, life skills, employment assistance and referrals, career education, primary health and dental care, mental health care, substance abuse counseling, showers, laundry and mail access for the homeless; and with the Florida Theatre Performing Arts Center, Inc. for \$1 million in capital maintenance and capital improvements.

The bill adopts the annual budgets for the Renew Arlington, KingSoutel Crossing, Jacksonville International Airport, and DIA Community Redevelopment Areas, and adopts the Tourist Development Council budget which shall be administered by the TDC in accordance with the adopted Tourist Development Plan.

The total budgetary approval, operations and capital, for the City and the independent authorities, is approximately \$5.5 billion, excluding the Duval County Public Schools, the budget for which is not approved by City Council.

Bill Summary: The bill adopts the 2020-24 Capital Improvement Program and provides that no funds may be expended for any generally described line item project within the CIP that does not contain specific reference to precise locations of work, narrowly defined project costs or narrowly defined work descriptions until such project is defined and approved by City Council via a CIP amendment and specific appropriation. The bill also authorizes amendment of the Capital Improvements Element of the 2030 Comprehensive Plan to reflect the updated CIP project list. The bill waives the provision of the Ordinance Code which specifically excludes "routine roadway resurfacing" from the definition of "capital improvement" in order to permit roadway resurfacing to be capitalized in FY18/19. The bill acknowledges compliance with the Budget Code's capital improvement appropriations carry-over provisions by attachment of Exhibit 2 – the list of Capital Improvement Projects Not Lapsed and the proposed funding for those projects in FY19-20. It declares the City's intent to advance internally available funds for projects and to reimburse itself for all or a portion of those expenses via future borrowing. It authorizes the Office of General Counsel and the Council Auditor's Office to make changes to titles, tables of contents, the Ordinance Code, journal entries, schedules, attachments, etc. to effectuate the Council's intent.

Background Information: The CIP proposes spending \$153,317,925 million in FY19-20 on "general capital improvement projects", with \$117.2 million being borrowed funds. The largest projects are \$20 million for UF Health-Jacksonville hospital campus improvements, \$12 million for roadway resurfacing, \$5 million for Jacksonville Zoo projects, \$4.2 million for Friendship Fountain repairs and \$3.6 million for the first phase of Ed Ball Building power upgrades.

The CIP proposes \$10,608,000 in stormwater projects in FY19-20 funded without any borrowing, allocating \$4.2 million to countywide drainage system capital maintenance and \$3.85 million to the LaSalle Street outfall project. For solid waste projects it also proposes \$6.6 million for a Trail Ridge Landfill leachate evaporator system and \$424,360 for continuation of the Trail Ridge Landfill expansion project, both using borrowed funds.

The City's proposed 5-year CIP for General Fund general capital projects totals \$732,256,356 from FY20 through FY24, with \$545,003,560 (74%) being provided through borrowing. The 5-year CIP for stormwater utility projects totals \$51,408,162 million funded without any borrowing. The 5-year CIP for solid waste projects includes a total \$43,634,333 for 3 projects – Trail Ridge Landfill expansion, environmental compliance citywide and the landfill leachate evaporator system – all paid by borrowing.

Policy Impact Area: Capital improvement budgeting

Fiscal Impact: The City's total CIP projects cost for FY19-20 (General Fund, stormwater, solid waste) is \$170,948,447. The total project value for the 5-year CIP is \$827,298,851.

Bill Summary: The bill authorizes the execution of the annual letter of agreement among the City, Shands Jacksonville Medical Center, and the Florida Agency for Health Care Administration for payment of the City's indigent care contribution of \$26,275,594 to Shands Jacksonville and for the use of all of those funds to leverage the State's Intergovernmental Transfer (IGT) and the federal government's "disproportionate share" Medicaid funds to increase the amount of funding available for indigent care purposes.

Background Information: Shands Jacksonville and several of the other largest indigent care provider hospitals in the state participate in the "disproportionate share" program through which the hospitals turn a portion of their local indigent care funds over to the state to be used as matching funds to draw down enhanced Medicaid reimbursement for indigent care, thus substantially increasing the amount of care that can be provided as a result of the local appropriation. The Mayor's proposed budget for FY19-20 contains an allocation of \$26,275,594 to Shands Jacksonville for indigent care purposes.

The City's appropriations to Shands Jacksonville have remained unchanged over the past several years since an increase in FY13/14:

Bill Summary: The bill adopts the FY20-24 Information Technology System Development Program (ITECH) as required by the Budget Code. The 5-year plan encompasses a total of \$86,746,162 in IT projects, with \$25,799,795 being programmed for FY19-20, a slight increase in FY20-21 (\$29,128,079) and then declining substantially to between \$9.2 and \$12.8 million over the next 3 years. Borrowing is projected to fund \$50,928,921 (58.7%) of the ITECH projects. The bill declares the City's intent to expend available funds on IT projects and then reimburse itself using future borrowing.

Background Information: The largest projects scheduled for funding in FY19-20 are \$14,762,442 for the Enterprise Financial/Resource Management Solution project, \$3,985,877 for the Enterprise Permit/Land Use Management system and \$2,324,841 for the Portable Radio Refresh project.

This bill also authorizes a sale and purchase agreement between the City and Fidelity National Financial, Inc. for the property and amends the 2019-2023 Five-Year Capital Improvement Program. The Real Estate Division of the Public Works Department will provide oversight and contract administration.

Background Information: The purpose of this legislation is to redevelop a vacant property, known as the Old Fire Station 5 Site, in the downtown Northbank Area. In 2005, the property was a part of a Land Swap Agreement between the City and Fidelity National Financial, wherein a portion of the Fire Station 5 parcel was exchanged for a parcel for an urban park (Sidney J. Gefen Riverwalk Park) and Fidelity received a parcel needed for the construction of a new building. Purchasing and redeveloping the property will eliminate blight conditions in the area, provide job opportunities to residents, realign Forest Street to provide better access to the property and surrounding properties, and improve parking for Riverwalk Park.

The bill approves an amendment to the MOU agreeing to relocate additional resources from the company's other operating areas to Jacksonville in the event of a declared emergency and to partner with JFRD to meet the imminent needs of the citizens of Jacksonville. This bill requests one cycle emergency passage of this legislation due to Mayo Hospital emergency transport being delayed pending this COPCN. These transports would assist JFRD during hurricanes, and Florida is presently in hurricane season.

Background Information: Chapter 158, Ordinance Code, requires that a person or entity engaging in prehospital emergency medical transportation service first secure a COPCN. Pursuant to Section 158.204, Mayo Clinic Florida submitted an application to engage in prehospital emergency medical transportation service. The application was reviewed, verified and submitted to the Public Health and Safety Committee, which voted to recommend Mayo Clinic Florida's application for the COPCN to Council. In Ordinance 2018-411-E, enacted August 14, 2018, the Council authorized a COPCN to Mayo Clinic Florida. Mayo Clinic Florida is changing the name to Mayo Clinic Jacksonville. Mayo Clinic Jacksonville is the parent entity of Mayo Clinic Florida, and Mayo Clinic Jacksonville's application for the COPCN is identical to Mayo Clinic Florida's application except for the applicant name.
