Bill Summary: This bill approves and authorizes an Economic Development Agreement between the City and "Project Milan" (according to Section 288.075 Florida Statutes, confidentiality regarding an economic development project is permitted, if necessary) and authorizes a REV Grant of $\$ 700,000$. The Office of Economic Development will provide oversight.

Background Information: "Project Milan" has committed to retain 428 jobs, create a minimum of 10 permanent full-time equivalent new jobs in Jacksonville by December 31, 2021. The Office of Economic Development has reviewed the application submitted by Project Milan for community development, and has determined the Economic Development Agreement to be in the long term public interest that will enhance the City's tax base and revenues.
The Mayor is designated as the authorized official of the City for the purpose of executing and delivering any contracts, notes and documents and furnishing such information, data and documents for the Agreement. The Executive Director of the OED, as contract administrator, is authorized to negotiate and execute all necessary changes and amendments to the Agreement.
REV Grant payments will be provided in annual installments. "Project Milan" will be responsible for a $\$ 28.5$ million capital investment to construct a 95,000 sq. ft. office space on the Southside. If there is any breach or default on the agreement, the City may refuse, reduce or require the return of REV Grant payment. Specific defaults include: reporting requirements, job retention/creation and capital investment.

Bill Summary: This bill amends Section 656.1402 (Approval Procedure), Part 14 (Transit Oriented Development), Chapter 656 (Zoning Code), Ordinance Code, to add five areas suitable for transit oriented development.

Background Information: The Council approved Ordinance 2007-587-E which created the Transit Oriented Development (TOD) category to allow increased residential density, reduced automobile parking, pedestrian oriented open space, mixed use, and reduced setbacks in areas designated for mass transit stations. There were eight (8) specific areas deemed by the city to be suitable locations for TOD overlay zones. TOD districts primarily create an environment in which people can live and work comfortably without the need to utilize personal vehicles to attend to the ordinary tasks of daily life, such as commuting to work or doing weekly shopping.

This legislation proposes the addition of five (5) new TOD areas: Cedar Hills Boulevard, Collins Road, Morse Avenue, San Juan Avenue, and Townsend Road. The procedure for adopting new TOD zones includes a requirement for a public planning charette prior to submission of the proposal to the Council, and the appointment by the Mayor (confirmed by Council) of a 7-member, public/private TOD Committee to review and make recommendations on the proposal.

Bill Summary: This bill approves the proposed revisions and modifications of the 2030 Comprehensive Plan as the large scale text amendment \#3 to revise the Public Buildings and Facilities (PBF) Future Land Use Element category to add dredge disposal to the list of principal uses.

Background Information: PBF is a broad land use category that is intended to accommodate major public use or community service activities. The Planning and Development Department, Planning Commission, and Land Use \& Zoning Committee provided appropriate public hearings and information sessions with due notice. Each entity provided recommendations to the Council in support of the transmittal based on all the written and oral comments received. The proposed revision will be transmitted through the State's expedited review process to the appropriate State agencies. All local, state or federal permits or approvals must be obtained before commencement of the development or use and issuance of this revision to be operated in strict compliance.

Bill Summary: The bill publishes the "rolled back millage rates" for tax year 2017, based on certified taxable values provided by the Property Appraiser, as follows:
General Services District (GSD - countywide), excluding Urban Services Districts $2-5$ : 10.9028 mills GSD within USD 2 (Jax Beach), USD 3 (Atlantic Beach), and USD 4 (Neptune Beach): 7.7324 mills GSD within USD 5 (Baldwin): 9.4321 mills

The bill proposes the following millage rates to fund the Mayor's proposed FY 2017-18 budget:
General Services District (GSD), excluding Urban Services Districts 2 - 5: 11.4419 mills GSD within USD 2 (Jax Beach), USD 3 (Atlantic Beach), and USD 4 (Neptune Beach): 8.1512 mills GSD within USD 5 (Baldwin): 9.6312 mills

Finally, the bill sets the required public hearing on the proposed millage rate and tentative budget for the Council meeting of September 12th and requests emergency adoption of the resolution.

The bill is requested for emergency passage on first reading in order to meet the state mandated deadline of August 4th to report a proposed millage rate to the Property Appraiser for mailed notification to all property owners.

Background Information: Florida law requires that the City annually publish the "rolled back" millage rate, which is the millage rate that would be required to be levied on this year's (higher) property valuations to produce the same amount of ad valorem tax revenue produced by last year's millage rate. The county millage rates for the current year as follows: GSD (outside USDs 2-5) - 11.4419; GSD in USDs 2-4-8.1512; GSD in USD 5 9.6312. The Property Appraiser's preliminary (end of June) gross taxable value roll for 2016 is $\$ 58,882,311,525$, up 6.4\% from \$55,305,271,250 in June of 2016.

Bill Summary: The bill levies ad valorem taxes on real and personal property for the 2017 tax year for GSD operations (excluding the Beaches and Baldwin) at a rate of 11.4419 mills, which represents a $10.32 \%$ increase from the 2017 rolled back rate, and authorizes the assessment and collection of the taxes.

Background Information: The total preliminary adjusted taxable value of real and personal property in the GSD, excluding the Beaches and Baldwin, is $\$ 52,225,335,209$ for tax year 2017, up $4.7 \%$ from 2016's preliminary taxable value of $\$ 49,880,900,053$. The millage for GSD operations in the majority of the city represents an unchanged millage rate from 2016.

Policy Impact Area: Property tax millage levy
Fiscal Impact: Total ad valorem property taxes (real and personal) are projected to generate $\$ 625,195,677$ in revenue to the City General Fund and the tax increment districts at a collection rate of 95.5\%.

Bill Summary: The bill levies ad valorem taxes on real and personal property for the 2017 tax year for GSD operations in Atlantic Beach, Neptune Beach and Jacksonville Beach at a rate of 8.1512 mills, which represents a $5.42 \%$ increase from the 2017 rolled back rate, and authorizes the assessment and collection of the taxes.

Background Information: The total assessed value of taxable real and personal property in the Beaches cities is $\$ 5,770,461,163$ for tax year 2017, up $7.2 \%$ from $\$ 5,380,384,727$ for tax year 2016. The millage for GSD operations in the Beaches cities represents an unchanged rate from tax year 2016.

Fiscal Impact: Total ad valorem property taxes (real and personal) are projected to generate $\$ 625,195,677$ in revenue to the City General Fund and the tax increment districts for the FY17/18 budget at a collection rate of 95.5\%.

Bill Summary: The bill levies ad valorem taxes on real and personal property for the 2017 tax year for GSD operations in the Town of Baldwin at a rate of 9.6312 mills, which represents a $1.35 \%$ increase from the 2017 rolled back rate, and authorizes the assessment and collection of the taxes.

Background Information: The total preliminary adjusted taxable value of real and personal property in the Town of Baldwin is $\$ 44,687,742$ for tax year 2017, down $0.8 \%$ from $\$ 45,012,850$ in 2016. The millage for GSD operations in the Town of Baldwin represents an unchanged rate from tax year 2016.

Policy Impact Area: Property tax millage levy
Fiscal Impact: Total ad valorem property taxes (real and personal) are projected to generate $\$ 625,195,677$ in countywide revenue to the City General Fund and the tax increment districts for the FY17/18 budget at a collection rate of $95.5 \%$.

Bill Summary: The bill adopts the 2017-18 budgets for the City and its independent agencies and authorities. The proposed General Fund GSD departmental expenditure budget is $\$ 972,117,694$, with a total City departmental expenditure budget (General Fund, Special Revenue, Capital Projects, Enterprise, Internal Service, Trust and Agency Funds, and Other Component Units) of $\$ 1,915,340,162$. Non-departmental expenditures, interfund transfers and reserves are budgeted at $\$ 538,837,086$ for total appropriations, reserves and cash carryover of \$2,454,177,248.

The bill sets an employee cap of 7,370. The 5 -year financial projection estimates the City's General Fund GSD revenues to increase by $10.6 \%$ from $\$ 1,168,423,914$ (proposed) in FY17-18 to $\$ 1,293,265,413$ in FY21-22, with ad valorem taxes and state shared revenues growing substantially over the period, many sources remaining nearly flat, and miscellaneous revenues, other sources and transfers from fund balance projected to decline. The bill establishes a City Public and Cultural Services Grant program allocating \$5,870,765 and allocates \$120,213,976 for capital improvements ( $\$ 10,000,000$ for stormwater projects, $\$ 4,500,000$ for solid waste projects, and $\$ 105,713,976$ for other departmental capital improvements). The bill sets the employer's contributions to the various pension plans as follows: $\$ 33,270,627$ to the General Employees’ Pension Fund (plus $0.3 \%$ of payroll for disability), $\$ 13,973,105$ to the Corrections Officer's Pension Fund (plus $0.3 \%$ of payroll for disability), and $\$ \$ 135,648,057$ the Police and Fire Pension Fund.

The bill waives the following provisions of Ordinance Code: 1) the requirement that the City increase funding for the Jacksonville Children's Commission each year by an amount equal to the average percentage increase in all City operating department budgets, up to the value of $1 / 2$ mill; 2) the formula for setting the salaries of City Council members so as to keep the base salaries for council members the same in FY17-18 as in FY10-11; 3) conflicting provisions within Code Section 10.105 regarding Council members’ postage and communication expenses so as to reduce the communication expense allowance to the lower of the conflicting provisions; 4) the Code requirement that vehicle replacement be done on a cash basis; 5) the provision requiring funding to the JSEB and MBE programs in a minimum amount of \$500,000 (excluding staff costs); 6) Code Section 111.183 requiring Taye' Brown Regional Park Improvement Trust Funds to be used for improvements to the park so as to allow the funds to be used for operational costs of the Equestrian Center; 7) Code Section 117.107(2) prohibiting appropriation of a grant in advance of receipt of the grant award letter so as to allow budgeting for a U.S. EPA Clean Air Act grant anticipated to be received in 2018; 8) provisions of Chapter 126 - Procurement Code - in order to permit SMG to procure goods and services in accordance with its own competitive procurement process for capital expenditures of $\$ 100,000$ or less and non-capital extraordinary repair and maintenance projects of $\$ 500,000$ or less; 9) the Code prohibition against codification or establishment of new fees in the budget
ordinance; 10) the provisions of Ordinance 2000-1079-E (as amended by Ordinance 2001-795-E) regarding deposit of loan payments made by VCP-Lynch Ltd. into the Downtown Economic Development Fund so as to permit those repayments to be deposited in the Northeast Tax Increment District subfund to reduce the General Fund subsidy to that fund; and 11) the requirement to annually review fees to ensure that they are recouping at least $85 \%$ of the cost to the City of providing the service to which the fee applies.

The bill authorizes the Jacksonville Children's Commission to transfer funds administratively via a Transfer Directive from one line item to another, provided that appropriations are not transferred out of children's programs and provided that funding provided through the Public Service Grant process may not be transferred from one agency to another without Council approval. It provides that no Public Works Department charge-backs for services valued at less than $\$ 5,000$ shall be applied to any City Council appropriations from discretionary council district bond funds.

The bill approves the food and beverage appropriations listed on Attachment A. It provides that payments to Jacksonville Area Legal Aid from court fees and costs shall be made on a monthly basis in arrears in accordance with the contracts between the City and Legal Aid. It requires the tracking by the Public Works Department of the use of its time, equipment, materials and personnel by the Stormwater Utility and quarterly reporting of such accounting to the Council Auditor's Office and the Finance Committee. It provides that the City's indigent care appropriation to Shands Jacksonville shall not exceed \$26,275,594 and provides that the Parks, Recreation and Community Services Department shall include fees for use of Hanna and Huguenot Parks in the City's annual fee review process. The bill provides that revenue and interest deposited in the Library Fines Revenue Fund shall appropriated in the budget for identified library capital improvements or maintenance thereon. It requires that all Community Redevelopment Area (CRA) board resolutions approved by CRA boards shall be forwarded (along with all attachments) to the Chief Administrative Officer for transmittal. It requires that the Finance and Administration Department's annual memo to the Council Auditor describing the year-end excess funds recapture and deposit into reserve funds this year include a report on which subfunds end the year with negative balances.

The bill amends Ordinance Code Chapter 25 - Office of General Counsel - in Part 1 to increase that office's Litigation Imprest Fund from $\$ 500$ to $\$ 2,500$. It requires the Public Buildings Division to justify to the Chief Financial Officer or Chief Administrative Officer the uses to be made of the $\$ 250,000$ public buildings emergency fund before they are expended. The bill amends the financing exhibit to Ordinance 2001-795-E (Lynch Building project) to change the loan repayment terms from a 30 year amortization commencing July 1, 2003 with a 20 year term at 6\% interest to a 30 year amortization commencing October 1, 2017 at a $3 \%$ interest rate. It amends Ordinance Code Chapter 106 - Budget and Accounting Code - to change the funding goal for the City’s Emergency Reserve fund from 7\% of the General Fund/General Services District's budgeted expenditures (25.5 days average cash flow) to 6-8\% of the General Fund/GSD's annual revenue.

The bill adopts the annual budgets for the Renew Arlington, KingSoutel Crossing, Jacksonville International Airport, and DIA Community Redevelopment Areas.

The total budgetary approval, operations and capital, for the City and the independent authorities, is approximately $\$ 5.44$ billion, excluding the Duval County Public Schools, the budget for which is not approved by City Council.

## Bill Type and Number: Ordinance 2017-505

Type of Action: Adoption of 2018-22 Capital Improvement Program; directing Comprehensive Plan amendments; Ordinance Code waiver

Bill Summary: The bill adopts the 2018-22 Capital Improvement Program and provides that no funds may be expended for any generally described line item project within the CIP that does not contain specific reference to precise locations of work, narrowly defined project costs or narrowly defined work descriptions until such project is defined and approved by City Council via a CIP amendment and specific appropriation. The bill also authorizes amendment of the Capital Improvements Element of the 2030 Comprehensive Plan to reflect the updated CIP project list. The bill waives the provision of the Ordinance Code which specifically excludes "routine roadway resurfacing" from the definition of "capital improvement" in order to permit roadway resurfacing to be capitalized in FY17/18. It waives the provision of the Ordinance Code excluding property not owned by the City from the definition of "capital improvement" to allow the City to fund improvements on the campus of Edward Waters College. The bill acknowledges compliance with the Budget Code's capital improvement appropriations carry-over provisions by attachment of Exhibit 2 - the list of Capital Improvement Projects Not Lapsed and the proposed funding for those projects in FY17/18. It authorizes the Office of General Counsel and the Council Auditor's Office to make changes to titles, tables of contents, the Ordinance Code, journal entries, schedules, attachments, etc. to effectuate the Council's intent.

Background Information: The CIP proposes spending \$105,713,976 million in FY17/18 on "general capital improvement projects", with $\$ 67.97$ million being borrowed funds. The largest projects are $\$ 14$ million for sidewalk and curb ramp ADA compliance, $\$ 13.3$ million for roadway resurfacing, $\$ 8$ million for the Liberty Street/Coastline Drive/old courthouse parking deck project, $\$ 8$ million for the demolition and property clean-up of the former city hall and courthouse sites on Bay Street; and $\$ 2$ million for countywide parks and recreation improvements. This year a separate CIP element entitled Safer Neighborhood Investment Plan proposes one-time spending of $\$ 30,300,770$ in FY17-18 on public safety projects, including $\$ 12$ million for a new backup 911 emergency communications center, $\$ 8$ million for student housing and an athletic field at Edward Waters College, $\$ 4.4$ million for a new Fire Station \#63 and \$4.2 million for a new Fire Station \#61.

The CIP proposes $\$ 10,000,000$ (down $39 \%$ from $\$ 16,297,708$ million in the current year) in stormwater projects funded without any borrowing, allocating $\$ 4.2$ million to countywide drainage system capital maintenance and $\$ 1.48$ million to the Julington/Cormorant conveyance and pond project and $\$ 1.38$ million to the LaSalle Street outfall project. It also proposes $\$ 4.5$ million in borrowed funds (down $69 \%$ from $\$ 14.5$ million in the current year) for continuation of the Trail Ridge Landfill expansion project.

The City's proposed 5-year CIP for General Fund general capital projects totals $\$ 414,702,524$ from FY18 through FY22, with $\$ 259,600,346$ (59.7\%) being provided through borrowing. The 5-year CIP for stormwater utility
projects totals $\$ 50.15$ million ( $\$ 10$ million per year, plus an additional $\$ 150,000$ in FY21-22) funded without any borrowing. The 5 -year CIP for solid waste projects shows no expenditures beyond the $\$ 4.5$ million for Trail Ridge Landfill expansion in the FY17-18 until another allocation of \$1,712,500 for landfill-related projects in FY21-22..

Policy Impact Area: Capital improvement budgeting
Fiscal Impact: The City's total CIP projects cost for FY17-18 (General Fund, Safer Neighborhood Investment Plan, stormwater, solid waste) is $\$ 150,514,746$. The total project value for the 5 -year CIP is $\$ 499,653,294$.

Type of Action: Authorizing execution of indigent care funding agreements with Shands Jacksonville Medical Center and Florida Agency for Health Care Administration

Bill Summary: The bill authorizes the execution of the annual letter of agreement among the City, Shands Jacksonville Medical Center, and the Florida Agency for Health Care Administration for payment of the City's indigent care contribution of $\$ 26,275,594$ to Shands Jacksonville and for the use of all of those funds to leverage the State's Low Income Pool (LIP) and the federal government's "disproportionate share" Medicaid funds to increase the amount of funding available for indigent care purposes.

Background Information: Shands Jacksonville and several of the other largest indigent care provider hospitals in the state participate in the "disproportionate share" program through which the hospitals turn a portion of their local indigent care funds over to the state to be used as matching funds to draw down enhanced Medicaid reimbursement for indigent care, thus substantially increasing the amount of care that can be provided as a result of the local appropriation. The Mayor's proposed budget for FY17/18 contains an allocation of \$26,275,594 to Shands Jacksonville for indigent care purposes.

The City's appropriations to Shands Jacksonville have remained unchanged over the past several years since an increase in FY13/14:
FY12/13 - \$23,775,594; FY13/14 - \$26,275,594; FY14/15 - \$26,275,594; FY15/16 - \$26,275,594; FY16/17 \$26,275,594

Policy Impact Area: Indigent care funding
Fiscal Impact: According to Shands Jacksonville, the exact amount of Low Income Pool (LIP) to be leveraged by the use of the City's indigent care contribution is unknown at this time due to changes in the state rules governing the program. However, based on the May 5, 2017 Florida Senate Committee on Appropriations Report, $\$ 4.4$ million of the $\$ 26.27$ million will be contributed to Disproportionate Share funding resulting in a return of $\$ 7.5$ million. Although the remaining $\$ 21.87$ million contribution will be sent to the state for potential LIP matching purposes, the exact match remains unclear.

Bill Summary: The bill adopts the FY18-22 Information Technology System Development Program (ITECH) as required by the Budget Code. The 5 -year plan encompasses a total of $\$ 59,026,159$ in IT projects, with $\$ 8,760,171$ being programmed for FY17-18, increasing substantially in FY18-19 ( $\$ 16,523,953$ ) and then gradually declining again by $\$ 2-3$ million per year to $\$ 9,108,058$ in FY21-22. Borrowing is projected to fund $\$ 26,865,421(45.5 \%)$ of the ITECH projects.

A major differences between the FY17-21 and FY18-22 plans are the addition of a Fleet Management System Replacement project ( $\$ 710,000$ ), the addition of a Grants Management Software project ( $\$ 375,962$ ), the addition of a Medical Examiner Case Management System (\$881,514), an increase in the allocation to an Enterprise Permit/Land Use Management system ( $+\$ 2,500,000$ ), the addition of a Portable Radio Refresh project ( $\$ 9,016,634$ ), a reduction in the allocation to Disaster Recovery/Data Redundancy ( $-\$ 652,388$ ), the elimination of an Enterprise Auto Vehicle Locator system ( $-\$ 1,143,400$ ), and the elimination of Fire Station Fiber Upgrade (\$400,000).

Funds will be deposited into an account called the Downtown Infrastructure Enhancement Account, from which the Mayor, or designee, shall have the authority to spend in amounts up to $\$ 100,000$ to perform capital and maintenance projects in the downtown without further approval by the Council.

In 2014, the City Council adopted the KingSoutel Crossing zoning overlay and the associated commercial design guidelines which affected how property in the area could be developed.

In June 2016, the Building Inspection Division cancelled the project's building permit for inactivity, required that a new permit issued for continuation of the project be subject to compliance with the requirements of the overlay district, and informed the developer that certain aspects of the project as then completed would not be allowed under the new overlay conditions. 695 sued the City and, after negotiations, both parties agreed avoid litigation proceedings by accepting the following terms: the building permit will stand as issued, all litigation and code enforcement proceeding will be canceled, 695 will install a 6 ft .95 percent opaque fence, all existing trees will be retained and 695 will plant shrubs and curbing around the trees, 695 will remove 100 sq . ft . of asphalt and lime rock base, when not in use, all construction/nonpersonal vehicles will be parked within the fenced area. Each party shall cover the costs of their own legal fees.

The remaining balance of $\$ 8,000,000.00$ of the Series 2017 Bonds will finance or reimburse a termination payment for an interest rate swap entered into by Brooks on or about September 25, 2005 in contemplation of refunding the Series 2007 Bonds. The swap is required to be terminated with a payment due.

The other two locations are in Ocoee and Kissimmee.

A required public hearing was held by the Office of Economic Development in order to finance the cost of the project from the proceeds of the Bonds on a tax-exempt basis. The IRB Committee adopted the recommendation to approve the issuance of the Bonds on July 14, 2017. The approval by the Council does not endorse creditworthiness of the Borrower, recommend any prospective purchaser of the Bonds to purchase the Bonds, evaluate the likelihood of the repayment of the debt service on the Bonds, or approve any necessary zoning or rezoning applications nor approve any other regulatory permits related to the Jacksonville Facility. The City shall not be construed by reason of its adoption of this Resolution to have made any such endorsement, finding or recommendation or to have waived any of the City's rights or to have estopped the City from asserting any rights or responsibilities of the City may have in such regard.

Florida Statutes require that an area outside of a community redevelopment area, Enterprise Zone, Empowerment Zone, closed military base or designated brownfield pilot project area be designated a Brownfield Area by local government resolution. Following the enactment of legislation approving the designation, the owner will negotiate a Brownfield Site Rehabilitation Agreement (BSRA) with the Florida Department of Environmental Protection (FDEP). The owner is pursuing the Brownfield Area Brownfield designation and BSRA in order to benefit from the State of Florida’s Voluntary Clean Up Tax Credit Program (VCTC). The VCTC will allow the site owner to receive 50\% State corporate income tax credit assessment and cleanup costs, up to an annual amount of $\$ 500,000$. The property owner also wishes to apply for cleanup liability protection from the State. The site was used as an automobile dealership from 1970 through 2004. Environmental site assessments have discovered the presence of surface oil discharges, as well as multiple storage tanks and oil/water separator. The EPA defines Brownfield as sites that are abandoned, idled or under-used industrial and commercial facilities where expansion or redevelopment is complicated by real or perceived environmental contamination. The Planning \& Development Department recommends that the Brownfield designation requested by the property owner be approved. The site is located in Council District 5.

Bill Summary: The bill establishes a temporary moratorium on the City's acceptance, processing or approval of applications to place wireless communications facilities within the City's rights-of-way through December 31, 2017.

Background Information: As wireless communication technologies rapidly evolve, provider companies are seeking to install new types of equipment to serve their customers in the rights-of-way of cities and counties on streetlight poles, utility poles, separate free-standing poles and the like. Section 704(a) (Preservation of Local Zoning Authority) of the federal Telecommunications Act of 1996 preserves local zoning authority over the placement and construction of "personal wireless service facilities" but requires local governments to act on requests to place such facilities on public property in a timely manner and prohibits imposition of regulations that unreasonably discriminate among provider of equivalent services or that would have the effect of prohibiting the provision of such services. As wireless technologies evolve and require different transmission facilities, cities and counties are being approached by service providers with requests to allow new types of equipment, including smaller but more numerous antennas and WiFi "hot spots" that were not contemplated when the current right-ofway regulatory systems were adopted. Jacksonville's general regulations for communications systems installed in public rights-of-way (Ordinance Code Chapter 711, Part 4) were last amended in 2001. Ordinance 2016-113-E enacted new regulations for "Site Leases for Small Cell Antennas on City Improvements."

Furthermore, the 2017 Florida Legislature adopted the Advanced Wireless Infrastructure Deployment Act which requires local governments to allow certain types of wireless facilities within their rights-of-way providing they meet objective design standards, which local governments must adopt, by January 1, 2018. The moratorium will give the city the time needed to adopt such objective design standards and appropriate local regulations meeting the state law mandate.

Policy Impact Area: Right-of-way use by third parties
Fiscal Impact: Anticipated to be minimal; telecommunications service providers are currently regulated by the state and don't pay right-of-way fees directly to local governments. It has yet to be determined if private individuals could request placement of certain small wireless communication equipment on city rights-of-way, and it is not yet known if such individuals would be subject to the City's right-of-way fees.
