The changes made by this legislation make it possible for borrowers to secure FHFC program loans by a subordinate mortgage with terms and repayment to provide the minimum amount of Local Government Support necessary to score the maximum number of points under FHFC guidelines for the Housing Tax Credit. Amending the Local Government Support Revolving Fund requirements would enable the replacement of the letter of credit with a subordinate lien mortgage to secure loans from the Jacksonville Housing Finance Authority's Loan Trust Fund. The general credit or taxing power of the JHFA, the City of Jacksonville, Duval County or the State of Florida shall not be pledged to the funding of the loans or projects offered and provided by this legislation.
