Bill Summary: The bill acknowledges the submission by the Mayor of two tentative budgets for FY13-14, one based on the enactment of pension reform via pending Ordinance 2013-366 and the other formulated based on the failure of that ordinance to be enacted. The bill proposes a tentative millage rate of 10.0353 mills for the General Services District, 6.7446 mills in the Beaches cities, and 8.4472 mills for the Town of Baldwin. The bill sets the tentative rolled-back millage rate at 10.2844 mills for the General Services District, 6.7713 mills in the Beaches cities, and 8.6569 mills for the Town of Baldwin. The bill also acknowledges submission of a tentative Capital Improvement Program (CIP) budget covering 81 projects at a total FY13-14 cost of \$65,808,744.

Background Information: Section 106.200 of the Budget and Accounting Code provides that the Mayor shall by May 1st each year submit a tentative annual budget proposal, including revenues and expenses, an operating budget and a capital improvements budget, and tentative millage rate. The Council is required to act on that tentative budget by June 30th in order to provide the Mayor with guidance as to the proposed millage rate and general government expenditures for use in developing the formal budget proposal which must be submitted by the Mayor to the City Council by July 15th. This year the Council by Resolution 2013-283-A delayed the tentative budget submission deadline to June 3, 2013.

The tentative budget assuming no pension reform shows General Fund revenues and expenditures of \$950,020,294 and an estimated reduction of controllable costs totaling \$63.97 million or 13.88%. The tentative budget assuming that pension reform is enacted shows General Fund revenues and expenditures of \$950,020,294 and an estimated reduction of controllable costs totaling \$18.9 million or 4.09%.

The bill designates the Office of Economic Development as the City's oversight agency and authorizes the Executive Director of the OED to execute documents and make technical amendments as may be necessary to carry out the project. The bill affirms the compliance of the project with the City's Public Investment Policy.

Background Information: EIWC is an energy management consulting company that develops and implements energy conservation solutions for commercial building owners and operators. The company is headquartered in Jacksonville in the Baymeadows area and proposes to move its corporate headquarters to 100 North Laura Street and expand to 45 full-time employees earning an average wage of \$65,000 plus benefits, which exceeds 150% of the state average annual wage. The company proposes to make \$674,000 in capital investment in its new location for renovations and equipment.

Fiscal Impact: The City commits to paying up to \$63,000 in local match to a \$252,000 state QTI incentive with enterprise zone bonus.

Background Information: Total Quality Logistics, headquartered in Cincinnati, is a freight brokerage firm arranging for the transportation of full truckload shipments throughout the United States and is the nation's second largest freight brokerage firm by sales volume. The company proposes to establish a branch office in Jacksonville and hire up to 75 new full-time employees at an average wage of \$48,700 plus benefits. The company proposes to make a capital investment of \$380,000 to equip a yet-to-be-determined office location of 5,000 square feet.

The bill designates the Office of Economic Development as the City's oversight agency and authorizes the Executive Director of the OED to execute documents and make technical amendments as may be necessary to carry out the project. The bill waives the portion of the City's Public Investment Policy that sets a minimum score on the OED's project evaluation matrix in order to qualify a company for a 50% REV grant for a 6-year period.

Background Information: Bank of America is one of the country's largest financial institutions. The company proposes to create 200 new full-time jobs at its existing Jacksonville service centers paying an average wage of \$50,694 plus benefits (125% of the statewide average wage). The company will make a capital investment of \$13 million over three years to expand its current service centers. The Public Investment Policy waiver is requested to allow the company to qualify for a 50% REV grant over 6 years instead of the usual standard of 35% over 5 years.

Policy Impact Area: Economic development

Fiscal Impact: The bill commits the City to pay a QTI match of up to \$120,00 and a REV grant of up to \$438,422.

Bill Summary: The bill amends Ordinance Code Chapter 250 – Miscellaneous Business Regulations – to establish a penalty for property owners who allow persons to sell food, services or merchandise or to engage in any other business activity if those persons do not first obtain the appropriate transient vendor or other applicable permit. The property owner must maintain a copy of the transient merchant's permit and be able to produce it for inspection by the Sheriff's Office, Code Compliance, or other appropriate regulatory agency. The bill establishes violation of the provision as a Class E offense.

Background Information: Council Member Brown is concerned about the proliferation of non-permitted transient business operations (car washes, seafood and produce vendors, mobile food carts, etc.) that operate on private properties with the apparent permission of the owner of the property. This bill is intended to make the owners of private properties on which these businesses pop up responsible for ensuring that the businesses have the proper permits for their operations.

Policy Impact Area: Neighborhood improvement; code compliance enforcement

The bill provides that a first repeat violation within a 6 month period after either a warning of notice of violation issued by the City shall constitute a Class D offense; subsequent violations shall constitute Class E offenses.

Background Information: The sponsor wants to prevent uninhabited mobile homes from being used as storage units and to prevent property owners from evading enforcement action by removing such units when given a first warning by Code Enforcement, then returning the unit several months later and using it until being given another warning citation. This bill would make a second Code Enforcement finding of violation a citeable offense, regardless of whether the first action was a warning or citation, and would increase the penalty for third or subsequent violations.

Background Information: The FANG 125th Air Wing has received a grant from the state to create a new explosives disposal proficiency training range bunker facility at its JIA base, including construction of a bunker on a concrete pad and installation of a paved roadway, fencing, and electricity to the site. The bunker will be used by FANG to train its personnel in ordnance disposal and will be available for the safe disposal of any unexploded ordnance discovered in Northeast Florida by federal, state or local law enforcement or the military. The Florida Defense Support Task Force provides funding to projects that further the mission of preserving and enhancing the military presence in Florida, which constitutes a large part of the state's economy.

The Summer Night Lights program will provide supervised swimming pool access to 500 at-risk youth and summer sports league participation for 250 at-risk youth. Recreational services will be provided at the following parks and community centers: Emmett Reed Community Center, RFK Community Center, Johnny Walker Community Center, Clanzel Brown Community Center, Eugene Butler Park, Eartha Napolean Park, Charles Clark Community Center, Paxon Park, Thomas Jefferson Park and Woodland Acres Park. Summer job programs and Learn To Earn will take place at City Hall and other City facilities.

The Stockton Elementary PTA has raised \$10,000, the Friends of Stockton \$5,000, and several Rotary Clubs have collectively raised \$15,000. This bill appropriates funding from Enterprise Park accounts and from the council district BJP bond fund to contribute to the project, which will be constructed by the Rotary Club of Riverside. The City contribution will be made on a reimbursement basis for costs incurred by the Club. The Enterprise Park North and South funds being allocated to the project are residual council district bond funds (BJP and Autumn Bond) left over from prior appropriations to Enterprise Park projects.

Bill Summary: The bill transfers any budgetary savings for FY12-13 within the Office of the Sheriff derived from operational efficiencies (excluding internal service funds) at fiscal year-end to a Special Council Contingency account designated for the Sheriff, to be used for strategic law enforcement needs and not for normal operating expenses. The bill authorizes the Sheriff to transfer up to \$500,000 of appropriated funds within his budget into our out of any existing departmental object line for any specific purpose, project or issues, except that funds may not be transferred between subfunds or from Internal Service Fund accounts to other accounts. Such transfers shall be made by means of a memo to the Accounting Division with a copy to the Budget Office.

Background Information: By Ordinance 2012-450-E the Council appropriated \$6,123,184 in JSO budget savings from FY11-12 to use as a funding source to restore the extraordinary lapse imposed on the department's budget in FY12-13. This bill proposes to allocate savings from FY12-13 to a designated contingency fund from which the Sheriff is authorized to draw funds for special strategic or other needs as issues arise during the fiscal year which are beyond normal operating expenses, and which could not have been foreseen at budget adoption time. The Sheriff would be authorized to expend such funds by an administrative process without coming back to the Council for appropriation legislation.

Policy Impact Area: Sheriff's budget savings

Fiscal Impact: Undetermined – will appropriate the Sheriff's year-end budget savings (excluding any internal service charge savings) to a Special Council Contingency fund for the Sheriff's future use.

Bill Summary: The bill authorizes the administration to execute a revised Standard Maintenance Agreement with the Florida DOT for City maintenance of non-standard landscaping of state rights-of-way. The changes to the agreement are primarily formatting and titles, and the inclusion of greater detail, not substantive changes to policies, procedures or reimbursement rates. A 1-cycle emergency approval is requested so that the agreement can go into effect with FDOT by July 1st, the beginning of the state fiscal year, without any disruption of FDOT reimbursements to the City for work performed.

Background Information: The FDOT has rewritten its standard maintenance agreement, last adopted by the City in 1994. The new site list attached to the agreement covers 18 City-maintained sites on FDOT property in Jacksonville, while the former agreement covered 49 sites. The FDOT has resumed full maintenance of the 31 previously listed sites because of a change in state policy that now encourages plantings in and beautification of state road rights-of-way. With FDOT now assuming maintenance for trees and shrubs that it previously would not maintain, the City no longer needs to perform those duties on the beautified roadways. The City's reimbursement from FDOT will be reduced from \$410,488.28 per year for the 49 sites to \$127,943.47 for the 18 remaining sites.

Policy Impact Area: Roadway beautification; state financial reimbursement

Fiscal Impact: The bill approves a maintenance agreement that will result in the City being reimbursed \$127,943.47 from the FDOT for enhanced maintenance on 18 sites on FDOT roadways.

The license agreement is for a term of 10 years with two additional 5-year renewal options for a token lease rate of \$1 per year, with the Kirby-Smith Camp providing for restoration of the building and mowing, maintenance and insurance of the facility and grounds.

Background Information: The armory building has not been occupied for a number of years since the Department of Parks and Recreation moved to a new location because of persistent flooding problems at the site from nearby Hogan's Creek. Kirby-Smith Camp 1209 proposes to hold its monthly meetings in the building and to offer occasional exhibits and events open to the general public on local and military history. The group will perform some of the restoration work itself and raise private funds to hire contractors for more substantial work.

Policy Impact Area: Rehabilitation of historic structure

Fiscal Impact: The lease provides for a token payment of \$1 per year, with the Kirby-Smith Camp funding utility, insurance and restoration costs.

Bill Summary: The ordinance declares seven ash-remediated properties on Project New Ground Ash-Remediated Parcels for Surplus Sale List (the "Listed Parcels") to be surplus to the needs of the City; authorizes the Real Estate Division of the Public Works Department to market and dispose of the Listed Parcels in accordance with Chapter 122, *Ordinance Code*; waives the provisions of Section 122.429 (Uses of Proceeds from Surplus Land Sales) of Chapter 122 (Public Property), *Ordinance Code*, so as to allow the new proceeds from the sale of the Listed Parcels to be deposited into the Contamination Assessment Fund (PWSW442CA 36403) for future appropriation to offset the costs of the remediation efforts.

Background Information: Ash was dumped and/or used as fill in several areas of the City, including those areas surrounding Forest Street, Fifth and Cleveland Streets, Lonnie C. Miller, Jr. Park and the former Brown's Dump. Project New Ground (the "Project") is a long-term clean-up Project administered by the Remediation Program Coordinator that calls for the City to test and, where necessary, remove up to two (2) feet of soil from properties that have ash deposits, which may contain lead and other contaminants. The Project entails hundreds of properties being remediated and/or deemed safe for return to private ownership. The ordinance authorizes the sale of the ash-remediated properties. By waiving Chapter 122-429, the proceeds from the sale of each parcel are to be returned to the Contamination Assessment Fund by depositing the proceeds in an account to help offset the City's expense of the remediation effort, as well as to alleviate mounting maintenance expense.

Background Information: The Community Contribution Tax Credit allows corporations making contributions of cash or goods to approved not-for-profit organizations to take a credit against their corporate income taxes for the amount of the donation. Guardian Catholic Schools, Inc. is as support group for the Catholic elementary schools (PK-3 to Grade 8) at St. Pius V Catholic Church on Blue Avenue and Holy Rosary Catholic Church on Brentwood Avenue. The schools intend to raise donations of money and building materials to assist with renovations and security improvements at the two schools. Participation in the Community Contribution Tax Credit program would permit businesses making donations to the school improvement projects eligible to claim a credit for the amount of the donations against their state corporate tax bill. The Planning and Development Department has certified that the planned school rehabilitation program is in compliance with the City's 2030 Comprehensive Plan.
