**Bill Summary:** The bill approves an economic development agreement between the City and "Project Post" and authorizes a local QTI grant match of up to \$147,600 (20% of the total QTI grant of \$738,888). The bill also authorizes a City Training (CT) grant of up to \$246,000 (\$2,000 per job for 123 jobs). The Office of Economic Development is designated as the City's oversight agency. The bill waives the Public Investment Policy to the extent needed to grant the CT grant, which is not described in the PIP. Two reading emergency approval is requested.

**Background Information:** Project Post (the company's identity is being kept confidential for the time being pursuant to state law) is an international banking and finance company seeking to establish a Southeast U.S. office and to hire 123 employees at an average wage of \$64,356 plus a benefits package averaging \$20,000 per year. The company plans to make a minimum \$3.1 million capital investment in equipment, furniture and improvements to a leased office space. The State of Florida has agreed to incentivize the project with a QTI match of \$590,400, a Quick Response Training grant of up to \$282,900, and a Quick Action Closing Fund grant of \$500,000.

**Bill Summary:** This bill approves the proposed changes to the Development Order for the Mayo Clinic Development of Regional Impact (DRI). The changes described in the Notice of Proposed Changes (NOPC) include the phasing schedule; master site plan; transportation proportionate share circulation and mitigation plan; and the transportation specific condition are changes. Additionally, the bill determines that these changes do not constitute a substantial deviation from the originally approved Mayo Clinic DRI Development Order; and waives posting of signs and mailing of notices, if applicable.

**Background Information:** The Council adopted the Mayo Clinic Jacksonville DRI Development Order by Resolution 88-983-362, as amended by Resolution 93-226-247 and Ordinance 2006-841-E. The NOPC was submitted on June 15, 2015 by Mayo Foundation for Medical Education and Research to all appropriate state and local land planning agencies. The Planning and Development Department reviewed the NOPC and provided recommendations to Mayo Clinic Jacksonville DRI. The Northeast Florida Regional Council found that the proposed changes did not result in any additional adverse impacts nor constitutes a substantial deviation for the originally approved DRI Development Order.

Bill Summary: The bill

The bill amends the section providing for an annual debt affordability analysis to require that a *baseline* debt analysis be presented to the Finance Committee and Audit Committee by May 31<sup>st</sup> of each year listing outstanding debt current through April 30<sup>th</sup> of that year. The report is required to include an estimate of additional debt issuance over the next 5 years for borrowing previously authorized but not yet issued, and a current schedule of annual debt service requirements by individual bond issue and by Banking Fund issuance. It does not allow the inclusion of projected savings from anticipated future debt refinancings and requires disclosure of assumptions used to estimate variable interest rates.

The bill requires the Finance Director to submit to the Finance Committee and Audit Committee an annually *updated* debt affordability report in conjunction with the submission of the CIP plan and budget as part of the budget submission process. The report is required to contain the information from the May baseline debt report updated with information showing the effect of new debt for the upcoming year on the debt affordability model parameters and on the City's debt service schedules for the next five years. The report shall also show the potential impact on debt service levels and the debt affordability model of in increase or decrease of borrowing from the proposed next year's baseline amount in \$10 million dollar increments (up to a maximum of 50% above the proposed borrowing level needed for the next year's CIP), indicating breakpoints at which the debt affordability model would need to be waived to accommodate that level of increased borrowing.

The bill amends Ordinance Code Chapter 106 – Budget and Accounting Code – to make revisions to the debt management parameters by clarifying certain parameters and definitions regarding reserve funds and ratios. It also amends portions of Ordinance Code Chapter 110 – City Treasury – to delete the section authorizing the Director of Finance, with the concurrence of the Council Finance Committee, to modify or substitute projects authorized for funding by the Banking Fund within the confines of the overall Banking Fund authorization amount for each department. It deletes the section authorizing the Director of Finance, with the concurrence of the Council Finance Committee, to transfer excess Banking Fund proceeds from one project to another within a department's Banking Fund authorized borrowing cap and deletes the provision that any such "excess funds" not transferred to another departmental project become "undesignated funds" available for further redistribution.

**Background Information:** The bill derives from the work of the Special CIP Committee which felt that changes in the City's debt affordability model and increased reporting of key debt management statistics to the City Council on a regular basis would improve the Council's ability to understand and manage the City's borrowing needs and cash flow. The amendments provide for reporting of debt service levels in greater detail over a five year

time frame so that the Council can understand future debt service needs and can adjust borrowing plans accordingly to avoid debt service peaks that could stress the City budget. One of the new reporting requirements is a calculation by the Finance Department of not only the debt service on new borrowing required to fund the mayor's proposed annual CIP, but also the reduced cost of debt service for less borrowing and the increased cost for more borrowing in \$10 million increments up to 50% below and above the mayor's proposed amount. That is intended to give Council the ability to easily understand the budget impact of increasing or decreasing CIP spending from the mayor's proposed plan should the Council wish to make changes in either direction. The report would indicate at what point additional borrowing would violate the ratios in the debt management policy and therefore require a Code waiver by the Council.

Additionally, City entities utilizing the towing services under this legislation must obtain a current list of providers from JSO, updated fees, and updated policies and procedures.

**Bill Summary:** The bill appropriates \$325,000 from the General Counsel's Office retained earnings account to pay for expert witness fees and other litigation costs in connection with the case of *United States v. City of Jacksonville*, a suit filed by the U.S. Department of Justice alleging unfair hiring practices in the Fire and Rescue Department. One cycle emergency approval is requested.

**Background Information:** The lawsuit was filed by the Justice Department in 2012 alleging a "pattern or practice of employment discrimination against African-Americans" in Fire and Rescue Department hiring based on the use of written tests for promotion to the ranks of Lieutenant, Captain, Engineer and District Chief. The Title VII case alleges that the examinations negatively and disproportionately impact African-American candidates in two ways – that African-American candidates pass the promotional tests at substantially lower rates than Caucasian candidates, and that those African-Americans who do pass the test are rarely selected for promotion because promotions are primarily based on the test scores and African-Americans candidates score significantly lower on the tests than Caucasian candidates.

The federal court recently dismissed a City motion for summary judgment and set the case for trial, with a deadline of September 1, 2015 for the City to furnish expert witness reports to the court and a deadline of October 5, 2015 for the City to have its witnesses deposed. This bill appropriates funds from the OGC's retained earnings account to pay for expert witnesses, depositions, and other trial preparation costs.

- Appointed employees and officials and managerial and confidential employees also incurred a salary decrease of 2% on October 1, 2010, which to date has not been restored.
- Members of the Fraternal Order of Police (FOP) agreed to a 3% salary decrease on January 1, 2012, which to date have not been restored.

The additional years of the extension will allow the company time to amortize the cost of the new collection vehicles required for the automated collection service.

**Bill Summary:** The bill de-authorizes \$55 million of the \$105 million previously authorized Banking Fund borrowing for capital projects for FY14-15 and directs the administration to prioritize the use of the remaining \$50 million of authorization and to borrow those funds by December 31, 2015. The bill repeals Part 5 – City Banking Fund – of Ordinance Code Chapter 110 – City Treasury – to eliminate the Banking Fund.

**Background Information:** The bill derives from the work of the Special CIP Committee which found during the course of its work that the Banking Fund has never achieved one of its primary goals, which was to internally repay and re-lend borrowed funds multiple times before the external borrowing was repaid. Due to tight budgets there has never been sufficient capacity for departments to make repayments in excess of the minimum amortization so that internal re-lending has never taken place. The Finance Committee felt that the easy availability of the Banking Fund has tended to encourage more borrowing with less concern for future debt service consequences than when the City Council did almost all its borrowing via bond issues for specific lists of projects with specific revenue streams pledged to the debt service repayment.
