Bill Summary: The bill amends Ordinance Code Chapter 656 – Zoning Code – to revise and add requirements regarding buffers and landscaping on various types of properties depending on the nature of the adjacent property use, including the adoption of a buffer table. It relocates the regulation of driveway locations from Part 12 – Landscape and Tree Protection Regulations - to Part 6 – Off-Street Parking, On-Street Parking and Loading Regulations – of the Zoning Code and replaces the previous Parking Lot Landscape Matrix with narrative descriptions of the landscaping requirements for parking lots under various circumstances.

Background Information: The bill derives from the work of several council members who met on a number of occasions to discuss the reasons why Jacksonville seems to process so many rezoning applications for PUDs rather than conventional zoning districts. The group learned that one of the major reasons has to do with the desire of neighborhood residents and council members to impose varying depths and densities of buffers on new development depending on the nature of that development and the existing property uses it will abut, which is not permitted under conventional zoning categories.

The bill establishes 5 Adjacent Use Buffer Types (A, B, C, D and E) that increase in mandatory depth and in the size and density of the buffer material (shrubs, trees, fences, walls). It provides 12 buffer graphics depicting options for the arrangement of required buffer materials. It creates a Buffer Table establishing a sliding scale of buffer requirements based on the zoning category and use intensity of the two abutting properties. It provides for relaxation of or exemption from adjacent buffer requirements in certain defined circumstances. It provides specific requirements for fences, walls, berms, screening plants and associated landscaping.

Bill Summary: This bill provides up to \$10,000 from the Florida Boaters Improvement Program for the placement of Safety Zone signs in the St. Johns River and Shad's Creek, to create a safety zone within 300 feet of the centerline of the bridge, from shore to shore, on either side of the bridge.

Background Information: The purpose of the appropriation is to permit, construct or purchase, and install signs posting the Shad Creek Bridge boating safety zone. The amount appropriated will remain in the Florida Boaters Improvement Fund and will be available to future appropriation. The bill derives from a complaint by a citizen to his district council member and to the Waterways Commission about speeding boats on Shad's Creek causing shoreline erosion and dock damage due to excessive wakes.

Bill Summary: This bill creates a new Section 321.103.1 (Changing table requirements), Chapter 321 (Adoption of Building Code), *Ordinance Code*. One cycle emergency passage of this legislation is requested so as the new Section 321.103.1 is included in the upcoming Local Amendment to the Florida Building Code.

Background Information: The purpose of this legislation is to specify requirements for changing tables in any building that is newly constructed or undergoes substantial renovation on or after October 1, 2019 and that has a restroom open to the public. The rules adopted by the Building Codes Adjustment Board must require: at least one changing table accessible to women, and at least one changing table accessible to men, or at least one changing table accessible to both women and men; signage indicating the location of each changing table; for buildings with a central directory, it must indicate the location of all changing tables on the premises; an exemption for buildings when the cost of installation of the required changing table would exceed 10 percent of the total construction or renovation costs.

Bill Summary: The bill approves the acquisition of two properties along Orange Picker and Brady Roads in two separate purchase and sale agreements. The two properties are contiguous and will allow for the realignment of Orange Picker Road. The appraised value of the two properties is a combined \$305,000 (\$200,000 for the Burney property and \$105,000 for the Walsh property). Additionally, funds will be needed for environmental remediation and demolition of any structures for the expansion of the parking lot at Alberts Field, and roadway intersection improvements for a grand total appropriation of \$345,000. Funding will come from two areas:

- \$30,000 transferred between projects in Subfund 32E
- \$315,000 in available unappropriated revenue from Subfund 324

The bill amends the current CIP, Ord. 2018-505E, to include this project entitled "Orange Picker/Brady Road" and the transferring of funds required to complete the purchase and sale agreements.

The bill authorizes the Mayor and/or his designee to execute the purchase and sale agreements for each of the two properties over two separate transactions. The purchase and sale agreements require no deposit and allow the City to terminate without penalty at its sole option. Closing will take place within 30 days after title is clear to the satisfaction of the City. Oversight for the project will be provided by The Real Estate Division of the Department of Public Works.

Background Information: It is proposed that the deferral of this amendment to the CIP until the next annual budget and CIP review will cause the owners of the property to terminate the agreement and cease the City's ability to complete the roadway improvements economically and expeditiously.

Background Information: If a Code Enforcement Officer has to provide a citation for a civil infraction, the notice is issued to the tenant or lessee of the property. Currently, no official notification regarding a civil infringement on a property is provided directly to the owner. This legislation requires the civil infraction notification letter to be provided to the property owner in the same method as the original notice to the individual that committed the violation. The courtesy notice is provided to the property owner for informational purposes. It does not offer any additional rights, and the failure to receive the courtesy notice does not afford the property owner the ability to acquire a defense or other rights to the individual that committed the civil infraction.

Bill Summary: The bill authorizes the execution by the Mayor and/or his designee of a development agreement between the City of Jacksonville and the developer, Southern Baptist Hospital of Florida, for the reconstruction of Palm Avenue located between Gary Street and Prudential Drive. The reconstruction will increase the width of Palm Avenue from 60 feet to 100 feet. Oversight will be provided by the Engineering and Construction Management Division of the Public Works Department.

Background Information: Baptist hospital has constructed a new parking garage and by previous legislation the city approved construction of a pedestrian walkway over Palm Avenue to connect the parking garage with the rest of the hospital campus. The Palm Avenue improvement serves a public purpose by meeting infrastructure and public safety needs. FY 18/19 CIP already has plans for the improvements of Palm Avenue in the amount of \$480,000. Future funding for this project is from FY 19/20 and FY 20/21 for the amount of \$2,210,000 for each FY. The overall proposed funding for this project is \$4,900,000. The developer understands that future year appropriations are subject to City Council appropriations each FY and that there is no guaranteed funding appropriated.

Bill Summary: This bill is an appropriation of \$1,600,000 from the Tree Protection and Related Expenses Trust Fund, Subfund 15F, for the 630-CITY Tree Planting Program, administered by the Department of Public Works. The Tree Protection and Related Expenses Trust Fund currently contains approximately \$25,000,000.

Background Information: The purpose of this legislation is to provide funds to plant trees within public rights-of-way in Duval County in locations where adjacent property owners have requested trees through 630-CITY. The Tree Commission established the Level 1 Tree Planting Program, also referred to as the 630-CITY Tree Planting Program, which allows citizens to request up to two trees per year to be planted on City right-of-way adjacent to their property. To date, there have been a total of 900 requests, with one or two trees per request, with a cost of \$1,100 to \$1,500 per tree. Upon request, the Department of Public Works may use Subfund 15F to install either one or two trees approved in accordance with the "Tree Commission Approved Tree Planting List". The location and tree species must be approved by a City Arborist.

Bill Summary: The bill authorizes the execution of an amended economic development agreement between the City and Fanatics, Inc. to eliminate the Qualified Targeted Industry (QTI) incentive and to permit the company to receive a portion of the Recapture Enhanced Value (REV) grant for capital investments at a location other than the site originally proposed. The bill designates the Office of Economic Development as the City's oversight agency for the agreement.

Background Information: In 2015 the City entered into an economic development agreement with Fanatics, Inc., a world leader in the production of officially licensed sports apparel and other merchandise for professional sports leagues and more than 200 colleges. The agreement required the company to retain 400 permanent jobs and create 80 new jobs with an average annual salary of \$85,808 by December 31, 2019. The City also granted a 50% REV Grant of up to \$300,000, payable over 7 years, for capital improvements valued at \$10 million at 8100 Nations Way and 6800 Southpoint Parkway. The company has made \$9.82 million in capital improvements, but some improvements were made to a building on Financial Way instead of Southpoint Parkway, so no REV grant payments have been made to date. The company has also decided not to participate in the QTI program. This bill amends the economic development agreement to change the location of a portion of the capital improvements qualifying for the REV grant from Southpoint Parkway to Financial Way and extends the payout period from 5 to 6 years, still with the \$300,000 cap. It also removes all references to the QTI program and incentives from the agreement.

Policy Impact Area: Economic development

Fiscal Impact: The bill authorizes the payment of the \$300,000 REV grant for improvements made at a location not listed in the original agreement and extends the payment period for one year. It removes the City's commitment to a \$240,000 OTI local match.

It authorizes the addition of 28 employee positions in the Fire and Rescue Department to provide the service.

Background Information: The agreement provides that the City of Jacksonville shall provide 24/7 fire and rescue service within the City of Jacksonville Beach. It provides that the existing Jacksonville Beach fire trucks shall be conveyed to Jacksonville. Jacksonville will utilize Jacksonville Beach's two existing fire stations and will provide all upkeep and maintenance to the buildings and interior facilities; Jacksonville Beach will continue to maintain the landscaping around the stations. The term of the agreement is 20 years, with either party having the right to withdraw from the agreement by giving 2 years' written notice to the other party. Jacksonville Beach agrees to pay \$2.2 million for the first year of service, with that amount increasing annually by the greater of 2.5% or the Consumer Price Index. It provides that the current Jacksonville Beach Fire Department employees shall become of the City of Jacksonville's Fire and Rescue Department provided all certifications and requirements of state law for firefighters are met. The bill creates 28 new positions in the JFRD budget (18 firefighters, 10 engineers) to accommodate the hiring of those employees.

Policy Impact Area: Fire protection services

Fiscal Impact: Jacksonville Beach will pay Jacksonville \$2.22 million for the first year of service, with that amount increasing annually by the greater of 2.5% or the Consumer Price Index. A "white paper" prepared by the Jacksonville Fire and Rescue Department calculates the first-year cost of service to JFRD at \$3.55 million; the \$1.33 million differential is proposed to be absorbed in the JFRD budget in year one of the service.
