River Region plans to move its current HIV/AIDS living facility from St. John's Horizon House to this location as it is closer to the HIV/AIDS clinic and Shands Hospital, providing easier access to healthcare services. The general functionality of the buildings located at 2981 Parental Home Road and 390 Park Street is being enhanced (inclusive of repairs, equipment, and furniture) to better serve clients living at those facilities and/or coming in for outpatient services. Bill Summary: The bill amends the Nocatee DRI Development Order to make several changes in both the Jacksonville and St. Johns County portions of the proposed development, and finds that the proposed changes do not constitute a substantial deviation from the DRI development order. One amendment specific to the Jacksonville side of the development changes the timing of the development of the required 21 acres of park lands from the current 7 acres by the end of Phase I (October 2008) and an additional 14 acres by the end of Phase II of the project to 2 acres by the end of Phase 1 and 19 additional acres by the end of Phase II. Additionally, the amendment would tie the development of parkland specifically to the development of residential properties and permit non-residential development to continue from one phase to the next regardless of the status of park construction.

The second Jacksonville-specific amendment would shift the development of 6.5 acres and 60,000 square feet of office space from Phase V to Phase IV. The timing of the payment of traffic mitigation fees is not affected, as the DRI currently provides that the exact timing of the traffic mitigation for Phases IV and V remains to be determined at a later date.

The other amendments would permit the Nocatee developer to continue development beyond Phase II into Phases III, IV and V despite the fact that construction of an extension of Racetrack Road between U.S. 1 and New County Road 210 will not be complete by the end of Phase II as required, provided adequate financial assurances of eventual completion are made, and would extend the deadlines related to the widening of existing County Road 210 from the Intracoastal Waterway Bridge to Mickler Road from 2008 to 2012.

Background Information: The developer requests the changes to the parkland development schedule to specify that the parkland development requirement is related to the development of residential, not commercial properties, and to delay the construction requirement in recognition of the fact that no vertical development has taken place in the Jacksonville portion of Nocatee as of yet. The existing County Road 210 widening delay is reported to be at the request of St. Johns County and is related to right-of-way acquisition delays. The Racetrack Road extension is contemplated to possibly be constructed by a Community Development District which can provide satisfactory assurances to the City (possibly in the form of bonding capacity) that the road will be completed.
