**Bill Summary:** The bill amends Ordinance Code Chapter 30 – Planning and Development Department – to create a position of Bicycle/Pedestrian Coordinator within the Development Services Division. The bill appropriates \$39,000 from the Special Council Operating Contingency – Planning Department account to fund the salary and benefits for the position for the remainder of FY12-13.

**Background Information:** The position is being recommended by the Context Sensitive Streets Committee as one part of its legislative initiative to make Jacksonville's roadways more pedestrian- and bicycle-friendly, to reduce cyclist and pedestrian deaths, and to encourage more biking and walking for mobility purposes. The position is intended to be at a senior planner level, and the employee will review proposed public and private development plans, road project designs, etc. to ensure that full consideration is given to the needs of all transportation modes, not purely vehicles. The Special Council Operating Contingency – Planning Department account was created by the Finance Committee during the FY12-13 budget process to segregate the funding originally proposed for the salary and benefits of a Chief of Community Planning position in the Planning Department's budget. The committee recommended that the vacant position not be funded until the administration could prove that it was needed and the resources for that position were placed "below the line" in this reserve account.

**Bill Summary:** The bill amends Ordinance Code Chapter 111 – Special Revenue and Trust Accounts – to create a new Neighborhood Enhancement Trust Fund which will be funded with the revenues from card room parimutuel wagering (poker rooms) and which will be used to provide funding for capital improvements within 5 miles of the pari-mutuel facility producing the revenue.

**Background Information:** Jacksonville has the largest poker room in the state of Florida in the Best Bet Poker Room on Monument Road in the Regency Square area. The bill sponsor proposes that the state-shared revenues the City receives from the operation of the facility be deposited into a fund to be used for improvements (including but not limited to park improvement, road or landscaping improvements) that benefit the area immediately impacted by the presence of the facility in the same way that a portion of the landfill host fees are used to benefit the communities in the immediate vicinity of the landfill. The state rebates the City its portion of the pari-mutuel revenue after the close of the state's fiscal year at the end of June. In late 2012 the City received \$60,000 in revenue from the first 4 months of operation of the facility (March – June 2012). Without a longer history of operations there is no way to accurately forecast whether that represents a reliable revenue stream.

**Background Information:** The Code currently provides that the City Council's Executive Committee, composed of the Council President, Vice-President and the Chair of the Finance Committee, shall determine the pay grades for Council employees and officials and shall advise the Council Secretary and Council Auditor as they set the salaries of the employees under their direction.

**Background Information:** By Ordinance 2011-592-E the City authorized the conversion of overhead utilities (electric lines, telephone and television cables) to underground in the 1800 block of Seminole Road at the property owners' expense via special assessment. The total project cost is \$87,064.10 to be divided among 10 property owners.

**Bill Summary:** This ordinance amends Chapter 462 (Animals), Part 2 (Cruelty to or Neglecting Animals), Section 462.204 (Restraint by Tethering), *Ordinance Code*, amending the requirements for the tethering of animals.

**Background Information:** It has been established that there is a link between animals that are left tethered in one location and increased aggressiveness. Dogs that have been held in place by chains, often at considerable lengths of time, often without food or water and in inclement weather are a threat to public safety. This legislation addresses the issue with changes in the conditions for the tethering of animals. The changes require that the tether is constructed of material sufficient to restrain an animal without placing the animal in danger or injury. The changes would require that a tethered animal is within visual range of the owner; that a tethered animal is a least one year of age or older and is not sick or injured. When aggressive and dangerous tethered dogs are in areas without a secured fence or enclosure and is accessible by children or the public, the changes authorize animal control officers and/or law enforcement officers to remove dangerous and aggressive tethered dogs and impound such animals.

**Bill Summary:** The bill amends Ordinance Code Chapter 191 – Special Events and Entertainment District – to expand the Entertainment District created in Part 2 of the chapter so as to include the Sports Complex area, Metropolitan Park, portions of the Commodore's Point area east of the Sports Complex, the Jacksonville Shipyards property and East Bay Street, and portions of the southern edge of the Eastside neighborhood north of the Mathews Bridge Expressway in the district.

**Background Information:** The Entertainment District was created by Ordinance 2005-453-E and exempts the properties within the district from enforcement of the City noise ordinance, alcoholic beverage open container ordinance, and Zoning Code minimum distance limitations on establishments selling alcoholic beverages during periods when a defined list of events are being held. The list includes athletic events in the various Sports Complex venues, the World of Nations Festival, the Jacksonville Jazz Festival, events at the Arena, Fourth of July fireworks/Skyblast, 12 ticketed events at Metropolitan Park, and any other event the City Council may deem to be a special event for this purpose.

The Entertainment District currently covers the properties immediately abutting A. Philip Randolph Boulevard south of the Mathews Bridge Expressway to Bay Street, and the portion of the Eastside area from the Mathews Bridge Expressway on the south to 1<sup>st</sup> Street on the north and from Palmetto Street on the west to Van Buren Street on the east. The district does not currently include the Sports Complex, Metropolitan Park or other venues where the events actually take place. The expansion adds the Sports Complex area, including EverBank Field, Veteran's Memorial Arena, the Baseball Grounds, and the Jacksonville Agricultural Fairgrounds; Metropolitan Park and the WJCT studios; the Jacksonville Shipyard property and East Bay Street west to Catherine Street; one city block bounded by Palmetto, Phelps, Ionia and First Streets; and the blocks between Grant Street and the Mathews Bridge Expressway from Van Buren Street on the west to Bryan Street on the east.

**Bill Summary:** The bill expresses the City Council's opposition to any state legislation that would restrict, reduce or eliminate municipal revenues collected via the Communications Service Tax. It directs the Legislative Services Division to transmit the resolution to the Florida Governor, Senate President and Speaker of the House in addition to the members of the Duval Legislative Delegation.

**Background Information:** The state adopted the Communications Service Simplification Act in 2001 which consolidated 7 state and local telecommunications taxes into a single statewide uniform tax composed of 2 revenue allocations, one for the state and one for the localities. Last year the state convened a Communications Services Tax Working Group which recently released its final report to the Governor and the House and Senate leadership. The group's report recognized that revenue from the tax is falling each year as new technologies are developed and communication shifts from devices and services that are taxed to devices and services that are not taxed. The report calls for greater efficiency, transparency and fairness in the levy and collection of the tax, and recognizes the need for revenue neutrality so that the state and local governments are not subject to even further revenue reductions resulting solely from changes to the tax. The Working Group recommended a "holistic replacement" option that would reduce the telecommunications tax percentage and make up for the lost revenue by raising the state sales tax to 6.34 percent.

Section 62.101, *Ordinance Code*, provides that the 18 members of the board are appointed by the Mayor and confirmed by the Council, and that one of the members shall be a state certified swimming pool contractor.

Mr. Clarkson received a bachelor's degree in business administration from the University of Miami. He is a state certified pool / spa contractor and President of *Pools by John Clarkson*. Mr. Clarkson previously served on the Construction Trades Qualifying Board (2000-2005). He resides in the North New Berlin area within Council District #11.

Background Information: The Jacksonville Historic Preservation Commission is established pursuant to Chapter 76, Ordinance Code, and charged to conduct an ongoing survey and inventory of historic buildings, areas, and archaeological sites in the City of Jacksonville and to plan for their preservation; identify potential landmarks and potential landmark sites and to make recommendations to the City Council as to whether such should be officially designated; recommend that the City Council designate specified areas as historic districts and to identify which structures should be considered to be contributing structures; develop specific guidelines for the alteration, construction, relocation or removal of designated property; promulgate standards for architectural review which are consistent with standards for rehabilitation established by the United States Secretary of the Interior; approve or deny applications for certificate of appropriateness for alteration, construction, demolition, relocation or removal of landmarks, landmark sites, and property in historic districts; initiate plans for the preservation and rehabilitation of individual historic buildings; undertake public information programs including the preparation of publications and the placing of historic markers; conduct public hearings to consider historic preservation issues, the designation of landmarks, landmark sites, and historic districts, applications for certificate of appropriateness and nominations to the National Register of Historic Places; and administer Chapter 307, Ordinance Code.

Section 76.102, Ordinance Code, provides that the members of the Jacksonville Historic Preservation Commission shall be residents of the City of Jacksonville for their entire term and shall be appointed by the Mayor, subject to confirmation by the City Council.

**Bill Summary:** The bill expresses the City Council's support for House Bill 721 and Senate Bill 922 which would authorize an additional \$2 million sales tax rebate to provide funding for capital improvements to stadiums that house professional sports franchises when the operators of such stadiums propose to use the funds to make improvements to a stadium with a long-term professional sports tenant so as to meet league-wide standards for stadium quality and when such stadium produces over \$4 million per year in sales taxes from stadium operations.

**Background Information:** If the bills pass the Legislature and are approved by the Governor, Jacksonville would be eligible for a second \$2 million per year sales tax rebate due to the economic impact of EverBank Field hosting the Jacksonville Jaguars franchise, assuming that events at the stadium can be proven to produce over \$4 million per year in sales tax revenue and assuming that NFL Commissioner Roger Goodell certifies in writing a set of "facility standards" for NFL stadiums throughout the league which the Jaguars' proposed improvements would be meeting. The bills require that in order for a sports facility to be eligible for the additional \$2 million rebate, the professional sports franchise occupying the facility must have been in existence for at least 15 years, must have a signed lease for at least another 15 years in the facility, must produce an independent analysis or study showing that the facility will generate over \$4 million per year in sales taxes from its operations, and there must be a plan for improvements to the facility of at least \$80 million to meet or exceed facility standards applicable throughout the tenant's league as certified by the league commissioner.

The City already has received a \$2 million per year rebate since the Jaguars franchise began play in 1995. That 30 year rebate will expire in 2025. The combination of the new state sales tax rebate along with the existing sales tax rebate, tourist development tax allocation to the stadium, lease revenue and a financial contribution from the Jaguars would provide the funding for substantial capital improvements to the stadium proposed by the Jaguars.

### Policy Impact Area: Stadium improvement funding

**Fiscal Impact:** The bills, if passed by the legislature, would authorize an additional \$2 million per year sales tax rebate to the City, provided the operation of EverBank Field produces over \$4 million per year in sales tax revenue to the state.

**Bill Summary:** The bill authorizes a lease agreement between the City and GIV Imeson, LLC for 50,000 square feet of space in a building at One Imeson Park Boulevard for use by the Supervisor of Elections as the election operations center for a term of 10 years.

**Background Information:** The lease rate for the facility would be \$39,999,96 for the first year (representing common area maintenance fees only – no rent) and \$260,199.96 in year two, escalating by 3% per year thereafter through year 10. The base rent would be \$4.38 per square foot in year two, plus the CAM fee, escalating to \$5.55 p.s.f. in year 10. The lease provides that the landlord will make a specified list of tenant improvements (interior office build-out) to the space valued at up to \$650,000 and will pay \$100,000 in moving expenses to relocate the Supervisor of Elections' current facility from the Gateway Center to One Imeson.

Policy Impact Area: Supervisor of Elections' operations

**Fiscal Impact:** The lease agreement provides that the landlord will make interior tenant improvements valued at up to \$650,000 before occupancy and will pay up to \$100,000 in moving costs. It provides for no rent in year one (common area maintenance fee only) and an escalating rent and CAM fee in years 2 through 10, ranging from \$260,199.96 in year 2 to \$329,613.52 in year 10.

**Bill Summary:** The bill approves an economic development agreement between the City and Cory's Thunder, Inc. and expresses the City's support for a Qualified Targeted Industry with High Impact Sector Bonuses grant application to the Florida Department of Economic Opportunity to incentivize the company to create 35 jobs in the city. The City commits to funding up to \$49,000 in local match to the state's \$196,000 in QTI incentives, and finds that the project complies with the City's economic incentives policy. The Office of Economic Development is designated as the oversight agency for the project.

**Background Information:** Cory's Thunder Inc. produces training simulators used in the nuclear power and railroad/subway industries. The company proposes to relocate its current headquarters and 31 employees from St. Mary's, Georgia to Jacksonville and to expand the workforce by 4 additional employees by December 31, 2015. Average wage for the company's workforce is \$107,133, plus \$16,000 in benefits. The company proposes to lease 25,000 square feet of space on Tradeport Drive in the JIA Community Redevelopment Area and to make \$450,000 of leasehold improvements to the building.

Policy Impact Area: Economic development incentives

**Fiscal Impact:** The bill commits the City to funding up to \$49,000 to match a state QTI grant with High Impact Sector Bonus of up to \$196,000 for the project. The state will also provide a \$52,500 workforce quick response training grant of \$52,000.

Bill Summary: The bill expresses the City Council's support for Duval County School Board's 2013 legislative priorities agenda and for the passage by the Florida Legislature of pending House bills189 and 1031 and Senate bills 1370, 1388 and 1076 which address those priorities.

Background Information: The Duval County School Board presented the City Council with its legislative priorities agenda at a joint City Council/School Board meeting on March 12<sup>th</sup>. The School Board's priorities include the following:

- Restore an appropriate share of PECO funds for non-charter public schools to make needed capital improvements without raising local property taxes.
- Allow 100% of textbook funding to be used to purchase digital content and materials.
- Allow the class size amendment to be calculated at the school level rather than the classroom level. •
- Allow the End of Course exams to constitute 50% rather than 100% of the of the final course grade that determines whether a student is awarded graduation credit for the course.
- Revise the middle school acceleration denominator to include only students who achieved a Level 4 or 5 on the Grade 7 math FCAT exam.
- Revise state graduation regulations to include special diploma students as graduates in the 4-year rate.
