The personal escape systems include a NFPA rescue hook, 40 feet of rescue rope, one descender, and a belt that is woven into a firefighters bunker pants. Since the unit cost of the escape systems does not meet the \$1,000 threshold for capital equipment, the funding is being moved from a capital line item into an operating line item.

The nature of the emergency is that JFRD, which currently has no escape system for firefighters, must act as soon as possible to prevent additional firefighter injuries or deaths.

Bill Summary: The bill approves an economic development agreement between the City and Addeco, Inc. to move the company's North American headquarters to Jacksonville and create 185 new full-time jobs. The City is offering to pay up to \$222,000 to match an \$880,000 grant from the Florida Qualified Targeted Industry Tax Refund program (total incentive of \$1,110,000 or \$6,000 per job, 80/20 state/local split). The bill appropriates a grant from the Countywide Economic Development Fund of up to \$185,000 (\$1,000 per job) to provide a 50% match to the State of Florida's \$370,000 (\$2,000 per job) from the Governor's Quick Action Closing Fund. The State's Quick Response Training Fund will also provide \$1,800 per job, or \$333,000 which does not require a local match.

The bill designates the Office of Economic Development as the City's oversight agency for the contract. It also waives the project evaluation matrix minimum score provisions of the Public Investment Policy with regard to the Countywide Economic Development Fund grant because the policy does not contain criteria for use of the fund.

Background Information: Addeco, Inc. is a Swiss company providing human resource services in the areas of temporary staffing, permanent job placement, outsourcing, consulting and outplacement. Addeco North America is currently headquartered in Melville, New York. Addeco purchased MPS Group (formerly the Modis Company) of Jacksonville in 2010 and currently has 354 full-time employees in the city.
