**Bill Summary:** The bill amends Ordinance Code Chapter 111 – Special Revenue and Trust Accounts – to create a new Sidewalk Construction Special Revenue Fund to receive and expend developer contributions to the City in lieu of constructing sidewalks as required by the Land Development Procedures Manual as well as any private contributions and funds as may be appropriated by the City Council from time to time for the purpose of constructing needed sidewalks throughout the city. The bill also amends Chapter 654 – Code of Subdivision Regulations – to insert a provision that funds provided to the City by developers in lieu of constructing required sidewalks shall be deposited into this new fund. It also directs that the Land Development Procedures Manual be amended to the extent necessary to change references from the current "sidewalk fund" to the new Sidewalk Construction Special Revenue Fund.

The bill appropriates \$21,975 from the Public Works – Sidewalk and Curb Repairs Sidewalk/Curb Construction and Repair account and \$112,660 from the General Fund – Transfers From Fund Balance account to the new Sidewalk Construction Special Revenue Fund.

**Background Information:** During the course of its work, the Special CIP Committee learned that funds that when developers opt to make a cash payment to the City as provided in the Land Development Procedures Manual in lieu of constructing sidewalks in their developments, the funds are placed into a Public Works sidewalk and curb repair and construction account and, if not used within the fiscal year received, any excess funds are swept into the General Fund balance account at the end of the year. The committee feels that these sidewalk funds should be segregated into an all-years fund and not subject to lapse and sweeping at the end of a fiscal year. This bill creates a special revenue fund for sidewalk construction purposes which may be disbursed at the written request of the Director of Public Works in accordance with Chapter 654 of the Ordinance Code for approved uses. The bill also recaptures \$112,660 in sidewalk funds that were swept to fund balance at the end of FY13-14.

**Background Information:** The Jacksonville Sheriff's Office suggested several amendments to the existing Chapter 685 of the *Ordinance Code*, based upon the officers' experience in the field, in order to minimize or prevent attacks on children during vulnerable times of the year such as, but not limited to, Valentine's Day, Halloween, Easter Christmas, fall festivals, school parties, etc.

Sexual offenders and predators are not permitted to wear costumes, clothing, makeup, mask or anything that would alter a person's appearance; and must avoid all Halloween related contact with children. Additionally, a legible sign (clearly visible from the street) must be posted at sexual offenders and predators' residence, vessel or vehicle stating "no candy or treats here" from 6:00am to 11:59pm, on October 31<sup>st</sup> (or any other day Halloween is celebrated). Decorations are not allowed to be visible from the exterior of any sexual offender or predator's residence, vehicle of vessel, or any property which is leased, rented, owned or occupied by such person.

**Bill Summary:** This bill confirms the Chief Judge's appointment of Richard A. Brown to the Jacksonville Ethics Commission, replacing Leslie Jean-Bart, for a partial term ending December 31, 2016.

**Background Information:** The Jacksonville Ethics Commission is established pursuant to Chapter 602, Part 9, *Ordinance Code*, and empowered to review, interpret, render advisory opinions and enforce Chapter 602, *Ordinance Code*; and, in accordance with Section 1.202, *Municipal Charter*, to exercise the following powers and duties:

- Authorized to receive, and to investigate and issue findings with regard to complaints alleging an ethics violation:
- Provide assistance and input into the management and coordination of the training and education of local officers and employees in state and local ethics, including the City's Ethics Education Program, as well as all public records and sunshine law training throughout the government;
- May, upon employee or citizen complaint, or upon its own initiative, seek information and gather
  facts for the purpose of reviewing any circumstance or situation of which the Commission may
  become aware that appears to violate or may potentially violate an acceptable standard of
  ethics conduct for City officers and employees;
- Jurisdiction to levy those civil fines or penalties authorized in Chapter 602 for violations of the City's ethics code; and

**Bill Summary:** The bill appropriates \$294,550 from the Drainage System Rehabilitation – Other Construction Costs account to a DSR – Judgements, Claims and Settlement account to pay for a legal settlement arising from claims of property damage due to failure of the City's stormwater management system. The bill approves a settlement agreement between the City and Robert and Janice Fleet in the matter of Fleet v. City of Jacksonville in the amount of \$294,550 and requests one-cycle approval of this bill as an emergency.

NOTE: see companion bill 2015-199 which establishes the stormwater judgements and settlements account and appropriates funding to that account for this settlement.

**Background Information:** The Fleets own a small one-story commercial property (0.65 acres) on Sunbeam Road that has been damaged by flooding and erosion of a drainage channel belonging to the City. After negotiations over the value of the property and the amount of the damage, the City has agreed to pay the Fleets \$150,000 for their property and \$144,550 in plaintiff's damages, attorney's fees, court costs and interest to settle the case. The Property Appraiser has assigned a just value of \$237,588 to the property for 2014.

Policy Impact Area: Legal settlement

**Fiscal Impact:** The bill appropriates \$294,550 to a Drainage System Rehabilitation claims and settlements account to pay the cost of acquiring the property and paying plaintiff's damages and attorney fees and costs.
