This change will make the City's wording comport with the state's language. The Schedule of Capital Improvements is not the same as the City's 5-year CIP; it includes more projects than are in the CIP – for example school projects from the Public Schools element and regional transportation projects from the regional mobility plan.

PDD and ITD conducted extensive trials within its "BID System" proprietary software program. Therefore, in order to maintain a logical trail of where the split of permit fees are generated and avoid duplication of the trials, Subobject 32907 (Development Services Fee) within the Planning and Development Department's budget needs to be deauthorized; and Subobject 322001 (Building Inspection Fees) needs to be authorized for \$1,424,995 for Development Services' 25% split of permit fees for building inspections.

Background Information: The I-95 Overland Bridge Replacement Project has caused an existing segment of Gary Street to become segmented. The 911 Emergency Addressing Advisory Committee determined that the portion of Gary Street between Hendricks Avenue and Kings Avenue should be renamed in order to differentiate between the two unconnected segments of this roadway. The Addressing Section of the Planning and Development Department surveyed property owners adjacent and along Gary Street for suggestions for new names and received a request from the family-owned and operated Naugle Funeral Home in San Marco, to rename the segment between Hendricks Avenue and Kings Avenue "Naugle Way" in honor of the Naugle family and the Naugle Funeral Home's contribution to the San Marco community since 1928. Since the decision to rename the road originated with the 911 Emergency Addressing Advisory Committee, the filing fee for renaming the segment is not required.

**Note**: An amendment may be necessary to change the reference "Kings Street" to "Kings Avenue" on page 2, line 16 in the body of the ordinance.

The recommended priority populations and funding percentages are the same as approved by Council for FY15-16.

Following several months of work, the Finance Committee's Subcommittee on Public Service Grants proposed and the Council adopted (Ordinance 2016-56) a package of revisions to the PSG ordinance including the adoption of a process similar to the Cultural Service Grant process by which the PSG Council will solicit, evaluate and rank grant applications in the various categories but will not actually make awards until after the City Council has appropriated a lump sum amount for public service grants in the budget ordinance for the purpose.

The bill authorizes the Economic Development Officer to conduct a negotiated bond sale with a designated bond purchaser and appoints Wells Fargo Bank National Association's corporate trust office in Minneapolis as the bond trustee. The execution of all related documents is authorized.

**Background Information:** In 2006 the City authorized a sale of \$125 million of Health Care Facilities Revenue bonds on behalf of Mayo Clinic to fund the acquisition, construction and installation of health care facilities (a 214-bed teaching and research hospital) at the Mayo Clinic campus on San Pablo Road, which was to be operated by St. Luke's Hospital, Mayo's partner admitting hospital in Jacksonville. The St. Luke hospital on the Mayo campus has been subsequently acquired by Mayo Clinic Jacksonville, which proposes to refinance the bonds at a lower interest rate through a sale of 2016 refunding bonds. The bonds do not constitute a liability of the City of Jacksonville and are payable solely from the revenues generated by the hospital.

**Bill Summary:** The bill approves execution of an economic development agreement between the City and Project Star (corporate name temporarily confidential) for the development of a corporate headquarters facility in Jacksonville. The bill commits the City to a local 20% Qualified Targeted Industry (QTI) match of up to \$30,600 (51 new jobs created at \$600 per job) and approves a Recapture Enhanced Value (REV) grant of up to \$200,000, representing 50% of new tangible personal property taxes paid by the project for 10 years. The Office of Economic Development is designated as the City's oversight agency.

**Background Information:** Project Star is an advanced technology company that currently has 5,000 employees on three continents. The company commits to the creation of 51 new full-time jobs at an average salary of \$67,000 by December 31, 2017, and anticipates creating up to 100 new jobs by that time. The company will invest a minimum of \$5.7 million in IT equipment, furniture, fixtures and real estate improvements

**Bill Summary:** The bill appropriates \$250,000 from the Special Council Operating Contingency account to the Parks, Recreation and Community Services Department for transfer to 13-JAX, Inc. (d/b/a Friends of Hemming Park) to provide additional funding for continued operations and management of Hemming Park. The bill authorizes an increase in the City's maximum contribution to Friends of Hemming Park from \$1 million to \$1.25 million.

**NOTE**: the bill will need to be amended in committee to correct the "appropriated from" account to Special Council Contingency – Hemming Park.

**Background Information:** In the FY15-16 budget the Council appropriated this \$250,000 into a designated contingency account for Hemming Park to potentially provide a City contribution to Friends of Hemming Park to help fund park operations during the period from March 1, 2016, when FOHP's initial 18 month budget (funded largely by the City's initial \$1 million investment) ended and October 1, 2016 when the FY16-17 budget would become effective. This bill appropriates the funds from the designated contingency account to a Parks, Recreation and Community Services Department expenditure account for transfer to Friends of Hemming Park. The City entered into a contract with 13-JAX, Inc. in September 2014 for the Friends of Hemming Park to manage and program activities in the park for a term of 3 years with two 1-year renewal options, and appropriated \$1 million in City funds for the first 18 months of the park's operations in return for a commitment by Friends of Hemming Park to raise an additional \$250,000 in private contributions within the first year of the agreement. In the summer of 2015 the Council approved a first amendment to the management agreement to clarify the definition of private contributions to include park revenues.

Policy Impact Area: Hemming Park operations

**Fiscal Impact:** The bill appropriates \$250,000 from the Special Council Contingency – Hemming Park account (after amendment in committee to the proper source account).
