Bill Summary: The bill approves a 5th amendment to the fair share agreement between the City and Signature Land, Inc. (assigned to Signature Parkway, LLP) for credits for developer construction of a portion of Duval Road. It provides that JIA CRA tax increment funds deposited into the Mobility Zone 4 account shall, after required payments are first made to the North Access Road project, be allocated to Signature for the payment of \$1.2 million in fair share credit in reimbursement for the cost of constructing the road.

Background Information: In 2008 the City and Signature Land entered into a fair share agreement under which the company would construct a 4-lane urban segment of Duval Road between Main Street and Airport Center Drive in exchange for a combination of reimbursement from the City from fair share proceeds and the issuance of fair share credits. Several subsequent amendments have provided cash reimbursement to Signature from fair share and mobility fee proceeds in the area, reducing the amount of fair share credits due by equivalent amounts. This bill provides that Signature shall be reimbursed an additional \$1.2 million of construction costs via future allocations of JIA CRA tax increment funds as they accrue in the JIA CRA account, subject to payment of a prior obligation from the fund to the North Access Road construction project.

Policy Impact Area: Roadway construction

Fiscal Impact: The bill appropriates \$1.2 million of future JIA CRA tax increment revenue to Signature Land.

Bill Summary: This bill amends Section 603.301(Procedures) of Chapter 603 (Children's Curfew), *Ordinance Code*, to provide protection for children in the custody of the Sheriff due to curfew violations; provides for a temporary change in the definition of "curfew hours" for ninety (90) days to lengthen the hours; and requests an emergency one cycle approval.

Background Information: The amendment adds language to Section 603.301 stating curfew violators shall not be detained or housed with criminal violators or offenders unless the child is suspected or charged with other criminal activity. Additionally, the amendment requires the Sheriff to extend every effort to care for and protect the child while in custody; and ensure no excessive force is used against juvenile curfew violators.

Bill Summary: The bill repeals prior Ordinance 2013-167-E relating to the pension plan membership eligibility of employees of the Office of Ethics, Compliance and Oversight and amends Ordinance Code Chapter 120 – General Employees and Correctional Officers Retirement Plans – to remove the language that limits appointed employees hired in the ECO Office on or after July 1, 2013 to joining only the General Employees Defined Contribution Plan.

Background Information: Ordinance 2013-167-E enacted in June 2013 provided that appointed employees hired by the ECO Office, if they chose to join a City-sponsored retirement program, would only be eligible to join the defined contribution plan, not the traditional defined benefit pension plan. The bill applied only to persons hired for managerial positions and provided that persons already participating in the defined benefit plan would have to agree, as a condition of employment, that they would no longer participate in that plan while working in the ECO Office. The office currently only has one employee – ECO Officer Carla Miller – and recruitment is underway to hire another staff person.

Bill Summary: The ordinance appropriates \$6,500 from the Environmental Protection Fund to provide funding which will allow up to ten members of the Environmental Quality Division staff and personnel from the Jacksonville Sheriff's Office to receive on-site training from Rutgers University, as initiated by B.T. 15-069; the ordinance waives Section 360.602, *Ordinance Code*, to allow monies from the Environmental Protection Fund to be used for training; the ordinance provides for oversight by the Regulatory Compliance Department.

Background Information: The Environmental Quality Division (EQD) receives a large number of noise pollution complaints from citizens throughout Jacksonville on an annual basis. Staff has become certified and responds to these complaints and is able to successfully defend the results of their investigation when enforcement actions ae required. Community Noise Measurement and Certification training occurs every three years. In the past, certification has been achieved by having a member of Rutgers University provide the training. EQD staff conducted an extensive search, but was unable to identify another training source at the present time that provides the depth of training and associated certification. It was determined that the most cost effective manner by which to achieve the community noise measurement training is to request approval to allow the trainer from Rutgers to travel to Jacksonville to provide in-house training as opposed to sending EQD and JSO staff to Rutgers University. In-house training will enable ten individuals (eight EQD and two JSO staff members) to receive the Community Noise Measurement and Certification training to continue the City's noise pollution program.

Background Information: Authorizing and approving the Non-Exclusive Grant of Easement is for the purpose of enabling JEA to install and maintain a 42" Force Main that will be placed 100 feet under the St. Johns River and emerge on the Southbank. The new sewer line will be placed into service upon completion of construction and the old line will remain in place as a backup and environmental safeguard. The temporary construction easements are necessary to provide a work area for the temporary use of land outside the normal easement areas and to allow harmonizing of the area once the work is completed. In exchange for the easements, JEA will make a contribution in the amount of \$100,000 for improvements to Metro Park. Such contribution shall be placed in the Metro Park Trust Fund. JEA will be coordinating with SMG regarding the Force Main Project so that it will not interfere with any scheduled events. The Real Estate Division has conducted an investigation of "need." As a result of that investigation, the Parks, Recreation & Community Services Department concurs with the easement.

Background Information: The Foster Grandparent Program (FGP) of Duval County is an organization which offers an opportunity for seniors 55 and older to give of their time and talents in tutoring, mentoring, and nurturing special and exceptional needs and at-risk children. An estimated 74 Foster Grandparent Program volunteers serve. The communities in which the 74 FGP volunteers serve are comprised of 600 children that attend one of 33 volunteer stations in Duval County Schools, three early child development settings and four exceptional student centers geographically located in low-to-moderate income areas. The Exceptional Student Education in grades 9-12 have developmental delays from birth through five years old, and thereafter are experiencing the symptoms of intellectual disability; speech and/or language impairment; an emotional or behavioral disability; a specific learning disability, such as dyslexia, deafness, hard of hearing or a dual sensory impaired condition. FGP has developed partnerships with the Children's Commission, Florida State College at Jacksonville, the Department of Children and Families, Sylvan, the Department of Health and Jacksonville Public Libraries as resources.

Background Information: The Jacksonville Children's Commission (JCC) in partnership with the Player's Center of Wolfson Children's Hospital, United Way, the Health Planning Council, and Duval County Public Schools were awarded an 18 month grant by the National League of Cities. The grant was awarded to create a campaign to reduce the number of uninsured children in Duval County by 20% by December 2015. The campaign is called Cover Jacksonville. Grant recipients are encouraged by the grantor to make adjustments in budgets to best meet the needs of the community. The reallocation breakdown shows:

- United Way increased from \$28,499 to \$53,000
- Health Planning Council decreased from \$35,424 to \$12,900
- Duval County Public Schools decreased from \$41,149 to \$24,000
- The Player's Center at Wolfson Children's Hospital decreased from \$33,999 to \$13,000

JCC requests flexibility to reallocate funding between the partnering agencies as needed and upon agreement without having to come back to City Council prior to the end of the grant which is December 2015. The amendment is requested to be retroactive as if it were in the original Ordinance 2014-481-E. All other respects shall remain unchanged and in full force and effect.

Background Information: The Ad Hoc Committee on Neighborhood Blight covered topic at its April 22nd meeting. There was discussion for a subcommittee to follow up on issue. The amendment prohibits donation collection bins, defined as, any stationary or free-standing container, receptacle or similar device located outdoors on any property and in any zoning within Duval County for the solicitation and collection of donated items.

The term "donation collection bins" <u>does not</u> include any of the following:

- (1) recycle bins used for the collection of recyclable materials associated with the City of Jacksonville Solid Waste Division;
- (2) a mobile trailer used for the solicitation and collection of donated items, where personnel are present to accept donations, provided it complies with all applicable ordinances and regulations, including those relating to special events; and
- (3) structures owned or operated by a governmental entity, such as but not limited to, post office mail drop boxes, bill payment drop boxes, or library collection boxes.

Existing donation collection bins must be removed within sixty (60) days of the effective date. Failure to comply will result in a civil infraction and removal of donation collection bin by the City of Jacksonville. All costs associated will be responsibility of the owner. If any part of the ordinance is deemed invalid, the remaining part shall not be affected by the invalidity.

(Vistakon) to support an expansion of the company's contact lens research and manufacturing operations in Jacksonville. It authorizes a Recapture Enhanced Value (REV) grant of up to \$7.1 million, designates the Office of Economic Development as the City's oversight agency, and affirms that the deal conforms to the criteria of the City's Public Investment Policy.

Background Information: Johnson and Johnson Vision Care has operated and expanded on Jacksonville's Southside for many years and currently employs approximately 2,000 on its 69 acre site in the city. The company proposes to renovate 17,000 square feet of existing space, construct 35,000 square feet of new manufacturing space, add new production lines and upgrade equipment on existing production lines for a total new capital investment of \$301 million, and hire 100 new full-time employees at an average wage of \$60,000 plus benefits of \$30,000. The City's REV grant of up to \$7.1 million represents an amount equal to 50% of county ad valorem taxes on the value of the new real and personal property for the first 6 years the value is on the tax rolls, and 25% of the additional value for the 7th year. The State of Florida will provide an additional \$91.5 million in incentives, including a \$1 million High Impact Performance Incentive, \$150,000 in Quick Response Training funds, and an estimated \$90.3 million in Capital Investment Tax Credits payable over 20 years.

Bill Summary: This ordinance regards the Avenues Walk Community Development District; it repeals Ordinance 2007-167-E, pursuant to §189.062(4), *Florida Statutes*, amending Section 92.22 (Existing Community Development Districts), *Ordinance Code*, to remove Avenues Walk Community Development District; provides for Municipal Code editor's note.

Background Information: On March 13, 2007, the City Council adopted Ordinance 2007-167-E creating the Avenues Walk Community Development District (the "District"). The District operations were funded by Kimco Avenues Walk, LLC. The development district, located in Council District 5, was supposed to have been comprised of approximately 131 acres; 1,050 residential units, 350,000 square feet of retail space, 400 hotel rooms, and 50,000 square feet of offices space on a Phillips Highway site were supposed to have been constructed. The District has not taken any actions regarding planned community development. The district's Board of Supervisors unanimously adopted a resolution declaring that the District is inactive, pursuant to Section 189.062(a)(6), Florida Statutes.

In accordance with Section 189.062(1) (b), Florida Statutes, the District published a newspaper notice requiring any party objecting to the inactive status to file an objection with the Department of Economic Opportunity within twenty-nine days after date of publication of the notice. The DEO has determined that no objections were filed and changed the District's status to inactive. Section 189.062(4), Florida Statutes, requires the entity that created a special district declared inactive to dissolve that special district by repealing its enabling legislation. By this ordinance the City Council dissolves the District and repeals its enabling law, Ordinance 2007-167-E.

Bill Summary: The bill amends Ordinance Code Chapter 179 – Mortgage Foreclosure Registration – to amend several definitions and add new definitions of terms. It requires inspection of foreclosed properties every 30 days by the mortgagee or mortgagee's representative and requires a separate foreclosure registration for each property, whether vacant or occupied. The bill increases the initial foreclosed property registration fee from \$150 to \$250 and requires subsequent annual renewals with a \$250 renewal fee. It provides that if the defaulted mortgage or mortgage servicing on a property is sold or transferred, the new mortgage is subject to all of the terms of the ordinance, including payment of a \$50 registration update fee, and provides for late fees when required registrations or renewals are not done in a timely manner. The bill provides for imposition of a civil penalty in the amount of \$500 for each non-compliance offense. The Housing and Community Development Division is authorized to adopt policies, rules and regulations necessary to carry out the terms of the chapter.

The bill provides that revenue collected from registrations and renewals shall be deposited in Subfund 1N1 for appropriation by the Council for use. The Housing and Community Development Division is required to make annual reports to the Finance Committee and the Council Auditor's Office of the collection and uses of the fund. It provides that if the City chooses to hire a contractor to administer the provisions of this chapter, the City shall have auditing rights of the contractor's books, records and tax returns insofar as they relate to compliance with the City's contract. The contractor is required to make monthly reports to the Planning Department of the gross receipts generated by the fees and must provide the City with an annual independent audit. The bill provides that the fee structure shall be in effect for 2 full City fiscal years, after which time the Planning and Development Department and the Housing and Community Development Division shall internally review the fee structure and assess the need to make changes in the fees.

Background Information: The Council adopted the Foreclosed Properties Registry ordinance in 2010 to provide a mechanism for tracking foreclosed properties to ensure that they are properly maintained by the mortgage holder and do not become a blight on the community. This bill makes changes dictated by several years of experience with the current system and rectifies problem areas and weaknesses in the current ordinance.

Bill Summary: This bill approves and authorizes the Mayor, or his designee, and the Corporation Secretary to execute and deliver, for and on behalf of the City, an agreement between the City of Jacksonville and First Tee of North Florida, Inc., to purchase capital items; appropriates \$75,000 from the General Fund/General Services District – Transfer Fund Balance Account to the First Tee of North Florida; provides oversight by the Department of Parks, Recreation and Community Services; and invokes the exception of 126.107(G), *Ordinance Code*.

Background Information: The First Tee of North Florida was established in 2000 to impact lives of young people by providing educational programs that build character, instill life-enhancing values and promote healthy choices through the game of golf. The First Tee of North Florida operates out of two locations: Brentwood Golf Course and St. Johns County 3-Hole Course.

The purpose of the appropriation is to match funds donated by PGA Tour, Inc. to purchase capital items. The exception exempts the procurement of the professional services of First Tee of North Florida from competitive solicitation. The capital items being purchased are for the Brentwood site and include:

- Purchase and installation of Pump Station PSS \$65,000
- 6" auto flush wye strainer \$1,380
- Wet well cleaning \$1,700
- Radio hardware for pump station access \$4,380
- Industrial router/VPN interface \$2,800

Bill Summary: The ordinance closes, abandons, and/or disclaims a portion of an opened and improved right-of-way established in Plat Book 6, page 20, dated June 18, 1914, on Van Wert Avenue between Richmond Street and the St. Johns River in Council District 14 (the "subject parcel"), at the request of John Surface, located at 3680 Richmond Street, and Charles Cousar, located at 3700 Richmond Street (the "applicants"), to allow the opened and improve right-of-way to be closed. The ordinance waives Section 744.104 (Street Closing Application), *Ordinance Code*, requiring that the Public Works Department perform an administrative review and receive favorable replies for all agencies, prior to legislation for closure being submitted to the Council for its consideration; it reserves an all utilities easement over the subject parcel in the name of the City and JEA.

Background Information: The subject parcel is closed and abandoned at the request of John Surface and Charles Cousar, the owner of all adjacent property lying north, south and east of the subject parcel. The closer and abandonment is requested to allow the opened and improved right-of-way to be closed reserve an "All Utilities Easement" in the name of the City and JEA, and to allow the right-of-way to revert to the property owners on either side of the property. This request was routed to state, municipal and utility agencies which might have an interest in this matter and there were objections. The ordinance waives Section 744.104 that states that "no right-of-way road, street or public access way capable of providing pedestrian access to any public waters in the City, shall be closed, vacated or abandoned except in those instances in which the applicant(s) conveys to the City comparable lands for a right-of-way, road, street or public access to provide access to the same body of water..." The Parks, Recreation and Community Services Department has objected to the street closure due to property having "pedestrian access" to the St. Johns River and no comparable lands for right of way or access to the same body of water being provided. The Planning & Development Department has objected to the street closure citing inconsistencies with the 2030 Comprehensive Plan's Conservation Coastal Management Element and the Recreational Open Space Element.
