**Background Information:** The Cultural Service Grant Committee is established pursuant to Chapter 118, Part 6, *Ordinance Code*, and charged to recommend to the Cultural Council Board of Directors the organizations to be funded and the amount of the funding. Section 118.605, *Ordinance Code*, provides that the membership of the committee shall include five Cultural Council Board members confirmed by the City Council.

Mr. Gasper received a degree in business administration from Everest University and is Assistant Vice President and Branch Manager at *Urban Trust Bank*. <u>He</u> serves on the Cultural Council of Greater Jacksonville and resides in the Riverview area within Council District #8.

**Bill Summary:** The bill amends Ordinance Code Chapter 602 – Jacksonville Ethics Code – to provide for a suspension of lobbying privileges for up to 1 year for any person who knowingly and willfully commits 2 or more violations of the code's lobbying regulations. A new Part 11 – Civil Fines – is created that authorizes the City's Ethics Commission to issue a public reprimand and/or to levy civil fines of up to \$500 for violations of any part of the Ethics Code. The amendment also provides that the Ethics Commission may request the City Council to rescind or declare null and void any contract, grant, subsidy, license, permit, franchise, use, certificate development order or other benefit issued as a result of a violation of the Ethics Code. The bill provides that the Ethics Code to the State Attorney for prosecution as a municipal code violation and designates the Ethics Commission as the oversight agency for the enforcement of the new provisions.

**Background Information:** The Beach Community Development District comprises the 780-acre Tamaya mixeduse residential, commercial, recreational and school site development on Beach Boulevard west of Hodges Boulevard. The developers of Tamaya plan to install a "graywater" reclaimed water system for irrigation in the development at an approximate cost of \$1 million. The City desires to extend that reuse water system through Tamaya to the Patton Park soccer complex behind the Tamaya development at a cost of an additional \$1 million to irrigate the park's soccer fields, a project listed in the current 5 year CIP and funded in the FY13-14 budget. This bill authorizes the execution of an agreement between the City and the district for the Beach Community Development District to construct the reclaimed water system to serve both the development and the park and for the City to reimburse the district up to \$1 million of the cost after the construction is completed and the reclaimed water system is dedicated to and accepted by the JEA.

**Background Information:** The ordinance is proposed as the result of an effort by Greg Pease, the Chief of Procurement, to modernize, simplify and tighten up the provisions of the Procurement Code. The bill authorizes an "informal purchase" process with new regulations to be developed by the Chief of Procurement and approved by the Mayor. It adds a requirement that mandates the inclusion of specific language in all procurement contracts and purchase orders regarding compliance with all applicable federal, state and local laws, ordinances and regulations, maximum indebtedness provisions, and non-discrimination requirements. New language is added regarding contract renewals and regulations on the change order process. The bill authorizes City Procurement to cooperatively purchase with other governmental entities where the process is fair and competitive and benefits the City. Provisions are added regarding debarment of a contractor for default or breach of contract, unsatisfactory performance, failure to comply with federal, state or local laws or regulations, or for other cause. An amendment provides that "advertisement" may be done by electronic means and no longer requires publication in a newspaper of general circulation.

The bill deletes references to the General Government Awards Committee, Professional Services Evaluation Committee and Competitive Sealed Proposal Evaluation Committee and replaces them with a single Jacksonville Procurement Awards Committee. The section on procurement protest procedures is extensively re-written and limits the number of times a protestor may protest the same set of facts at multiple stages in the procurement process. The JSEB section is substantially revised

The bill approves a REV grant of \$1.6 million, representing the value of 50% of incremental property taxes on the site over 10 years. The bill requests emergency approval to meet a State deadline of June 1, 2014 to accept the grant. The bill also waives the provisions of Ordinance Code Chapter 126 – Procurement Code – for the purpose of allowing Railex to construct the project according to statemandated standards but without having to comply with all aspects of the City's Procurement Code.

**Background Information:** Railex, LLC, headquartered in New York, proposes to construct a 250,000 square foot refrigerated warehouse and 21,000 linear feet of rail line and support yard rail to support the loading and distribution of refrigerated and frozen cargo. The company commits to create 310 new full-time jobs at an average wage of \$47,851 plus benefits.

**Bill Summary:** The bill authorizes the execution of an agreement between the City and Northeast Florida Equestrian Society/H.O.R.S.E. Therapies, Inc. for the operation and management of the City's Equestrian Center on the Westside.

**Background Information:** The Northeast Florida Equestrian Society (NFES) was incorporated in 2001 as a Florida not-for-profit organization for the purpose of advising and supporting the management of the Jacksonville Equestrian Center through education, consultation, advocacy and other activities. The organization was selected as the best respondent to a City 2013 RFP for an operator for the Equestrian Center. The operations service contract is for a term of 5 years through September 30, 2019 with two additional 5-year renewal options. The proposed operating budget for 2014-15 projects revenue of \$737,588 and expenses of \$1,024,405 for an operating deficit of \$286,816. The Scope of Services document provides that the NFES shall be in charge of day-to-day operations of the center under rules established by the City pertaining to the allocation of costs and expenses and to financial reporting. NFES shall be responsible for all advertising sales and sponsorships, contracting for events, and carrying out a defined capital improvements Work Plan developed in coordination with the City's Department of Parks, Recreation and Community Services. NFES shall have exclusive concession rights, which it may contract out to a third party operator.

The Work Plan lists numerous expectations on the part of the City for the operation, marketing, support and utilization of the facility, including broadening the public appeal of the facility and the types of activities scheduled there, including a specific emphasis on more smaller, local events. The City reserves the right to establish an Equestrian Committee to help advise on the marketing, funding and operation of the center.
