The grant covers the cost of permitting, labor, materials and installation of the Wind Retrofit Project at nine (9) local fire stations. The fire stations will have missile-impact resistant coverings, storm shutters for windows, apparatus bay doors, egress doors and other openings. The benefits of this project include damage prevention from winds up to 150 miles per hour; reduction of long-term risk of wind damage to the nine fire stations; decreased insurance claims; and increased rating through the Duval County Local Mitigation Strategy.

**Background Information:** The "West Burnside" street name was established by the plat of Westbrook subdivision recorded in Plat Book 4, page 61 in the public records of Duval County. The Addressing Section of the Planning & Development Department was advised by the 911 Call Center that the address of "2407 Burnside" does not appear in the Computer Aided Dispatch (CAD) system. Different variations of the "Burnside" name currently exist among several City agencies as "W. Burnside." "West Burnside," "Burnside," "Burnside Avenue," and "Burnside Street." The United States Postal Service recognizes the street name as "Burnside Street;" JEA recognizes the street name as "Burnside." Adding the street type to change "Burnside" to "Burnside Street" eliminates confusion and allows for the precise location of properties. The street name change affects the address assignment of one property owner who has met with the 911 Emergency Addressing Advisory Committee.

**Background Information:** This ordinance amendment is proposed to curb damage to public buildings, concrete steps, benches, walls, parking barriers and other public improvements caused by the inappropriate operation of skateboards. The new Ordinance Code section would make unlawful for any person to operate a skateboard in or upon locations such as: public sidewalks and walkways within the Downtown Overlay Zone; public property owned or controlled by the City including parks, community centers and fire stations; any public parking garage, including the access/egress ramp; on any public access ramps for persons with disabilities providing pedestrian access to a building; within the boundaries of a sidewalk café or within an area which has received a street closure permit for an event. Penalties are fines: First offense - \$25.00; second offense - \$50.00; third offense - \$100.00; Fourth and subsequent offenses, per offense - \$150.00.

**Background Information:** Environmental Quality Division administers and monitors the City of Jacksonville's air and water resource management activities, with particular emphasis on pollution control issues. It also enforces laws related to environmental quality issues.

The United States Environmental Protection Agency (EPA), Office of Air Quality Planning and Standards (OAQPS) is responsible for setting standards, also known as National Ambient Air Quality Standards (NAAQS), for pollutants which are considered harmful to people and the environment. OAQPS monitors for criteria pollutants through programs such as the Ambient Air Monitoring Program that collect air quality samples to judge attainment of ambient air quality standards, to prevent or alleviate air pollution emergencies, to observe pollution trends throughout regions, and to evaluate the effects of urban, land-use, and transportation planning relating to air pollution.

The appropriation covers the expense of two full-time civil service employees (Environmental Scientist Supervisor and Environmental Specialist) assigned to perform various air pollution monitoring test within Duval County. Both positions are required to be reauthorized for the grant period July 1, 2016 through June 30, 2017. The total budget is comprised on \$307,467 from FY2016 funds and \$45,694 from previously obligated funds.

**Background Information:** The option agreement is for a term of nearly 5 years from May 2016 through March 2021 and grants the City the non-exclusive option to locate and obtain a developer to purchase or lease the parcels of JPA property, subject to a more definitive future agreement among the selected developer, the City and Jaxport regarding the use of the property(s). Jaxport retains the right to identify and obtain a potential developer for the property during the option period. The properties in question were acquired by the JPA as part of its plan several years ago to develop a cruise ship terminal in Mayport, a plan that has since been abandoned. The option agreement permits the City's Office of Economic Development to partner with JPA in finding a developer for the property and bringing a project to fruition.

Mayor Alvin Brown, the City of Jacksonville and the Jacksonville Police and Fire Pension Fund Board of Trustees.* 

**Background Information:** The legal fees arise from the lawsuit filed by Mr. Denton, Editor of the *Florida Times-Union*, against the City and the Police and Fire Pension Fund Board of Trustees alleging that the parties negotiated certain pension plan benefits outside of properly noticed public meetings in violation of the Florida Government in the Sunshine Act. The court found for the plaintiff, the First District Court of Appeal upheld that finding, and the Florida Supreme Court denied a motion by the PFPF Board to hear the case on appeal. Mr. Denton has since filed a claim for attorney's fees and litigation costs and the parties have negotiated a settlement agreement in the amount of \$114,000 from the City, subject to City Council approval and the appropriation of the funds for the settlement, and \$156,000 from the Police and Fire Pension Fund Board of Trustees. This bill approves the settlement of the *Denton* case and appropriates the City's \$114,000 from the General Fund/GSD Fund Balance account. In addition to approval of the settlement of the case itself, City Council approval is required for a legal settlement exceeding \$50,000.

The Supervisor of Election is instructed to place the referendum on the November 8<sup>th</sup> general election ballot and to publicize the referendum by the publication of at least two newspaper advertisements in the manner required by law. The bill provides that, if the referendum is approved by the voters, the City Council shall, by subsequent action, adopt legislation necessary and appropriate to implement the referendum and authorize slot machine gaming in licensed pari-mutuel facilities, including a provision for payment of 1.5% of gross revenues from slot machine gaming to the City.

**Background Information:** In 2004 the voters of Florida approved a constitutional referendum authorizing the use of slot machines at certain Miami-Dade and Broward County pari-mutuel facilities, if approved by local voter referendum. Some seemingly ambiguous language in a state law enacted in 2009 by the legislature has caused some to believe that the law opens the door to the introduction of slot machines in state-licensed pari-mutuel gaming facilities in any county that approves of slot machines via referendum. The First District Court of Appeals first ruled that the state law does authorize slot machine approval referenda outside of Miami-Dade and Broward Counties but later reversed itself, ruled that the law does authorize such referenda outside of Miami-Dade and Broward Counties, and referred the case to the Florida Supreme Court for a final ruling on the question. Oral arguments on the case will be heard June 7<sup>th</sup>.

**Background Information:** The new Public Investment Policy PIP) is a result of more than a year of work by the Special Committee on Economic Development Incentives, reviewing and debating incentive program proposals developed by the Office of Economic Development and the Downtown Investment Authority. The new PIP refines some existing programs, eliminates references to enterprise zones (which were recently eliminated by state law), and adds several new types of targeted incentives (i.e. a Disabled Veterans Hiring Bonus, a Local Training Grant and a Closing Fund). Refinements to existing programs include development of variable incentive levels in some programs based on levels of economic distress (Tier 1 and Tier 2) at the census tract level as determined by the tract's unemployment rate and level of median household income. Programs with varying incentive levels based on Tier 1 and Tier 2 economic distress measures are the Recapture Enhanced Value (REV) grant, the Façade Renovation Grant program (outside of the downtown area), and the Economically Distressed Area Targeted Industry program.

The parties agree that in general the terms of the agreement between the City and the Association for conduct of the annual TaxSlayer.com Bowl will be in effect, except for certain specific amendments: a) the City agrees to designate the Navy/Notre Dame game as a "City-designated event" as defined in the lease with the Jacksonville Jaguars; b) the City releases to the Association 4 additional suites provided to the City by the Jaguars pursuant to their lease; c) the Association will pay the City \$95,000 in base rent; d) the City will bear the costs of operating the stadium on game day (field preparation, security, ushers, ticket-takers, scoreboard operators, concessions, emergency personnel, police, fire, traffic control, etc.) in an amount not to exceed \$350,000; e) the City agrees to install at its cost approximately 3,500 temporary seats in the Club seating areas to replace the seats being removed by the Jaguars pursuant to their latest stadium improvement agreement with the City; f) the City shall provide all parking personnel on game day; the Association shall pay the City \$3 per parking space used and shall retain the rest of the parking revenue; g) concession operations and revenues are subject to the Pre-Existing Rights of the Jaguars under their stadium lease and concession revenues will be apportioned among the parties consistent with the lease agreement for the TaxSlayer.com Bowl; h) the City releases to the Association all rights to licensing and all revenues from programs and merchandise sales, subject to the Jaguars' Pre-Existing Rights; i) the City releases to the Association all rights to operations and revenues from scoreboards and signage, subject to the Jaguars' preexisting rights; the Association will provide the City with signage and logo placement within the stadium and on the scoreboards and with four 30-second commercials on the video boards; i) the City is entitled to the usual \$1.25 ticket user fee for each ticket sold; the City releases to the Association all revenues from ticket sales (except the ticket user fee), television rights, title sponsor rights, uncommitted concession revenues and net parking revenues, which may be made available to the two universities. The Association agrees to provide the City with 100 game tickets, 50 parking passes, 50 pre-game hospitality passes and 24 tickets to the City's suite.

**Bill Summary:** The bill appropriates \$150,000 from the Special Council Contingency – Hemming Park account to the Department of Parks, Recreation and Community Services – Hemming Park account to provide funding to 13-JAX, Inc. (d/b/a Friends of Hemming Park) for the operation and management of the park for the remainder of the current fiscal year. The bill authorizes execution of a Third Amendment to Contract for the Operation of Hemming Plaza between the City and Friends of Hemming Park to increase the City's maximum indebtedness amount from \$1.1 million to \$1.25 million and to provide that the current \$150,000 appropriation shall be used solely to fund operational expenses as listed on Exhibit A (administration and management, cleanliness and safety, programming and marketing).

**Background Information:** The bill is introduced as an alternative/companion to Ordinance 2016-198 which, as introduced, would have appropriated \$250,000 from the Special Council Contingency – Hemming Park to for park operational expenses. Subsequent to the introduction of 2016-198, Friends of Hemming Park reached agreement with Community First Credit Union on a \$250,000 naming rights agreement for an improved stage structure to be constructed in the park which prompted discussion in the committees about the state of FOHP's budget and the allocation of funds for operational versus capital construction purposes. Ordinance 2016-198 was amended before adoption to appropriate \$100,000 to FOHP for park operational purposes through the end of June and this bill is introduced to deal with the other \$150,000, the use of which can be better determined once the Mayor's FY16-17 budget proposal is presented to Council in mid-July and the Mayor's recommended funding level for Hemming Park for next year is known.

**Policy Impact Area:** Hemming Park operations

**Fiscal Impact:** The bill appropriates \$150,000 from the Special Council Contingency – Hemming Park account to the Department of Parks, Recreation and Community Services – Hemming Park account.
