**Bill Summary:** The bill amends Ordinance Code Chapter 656 – Zoning Code – to reference various maximum impervious surface ratios in zoning categories as specified in the Code of Subdivision Regulations. The bill also amends Chapter 654 – Code of Subdivision Regulations – to provide the actual impervious surface ratios (ISRs) in the City's building regulations. The ISRs in Chapter 654 apply at the subdivision level and range from 30% ISR in RR-Acre zoning to 95% in the CCBD classification.

Background Information: This bill derives from the work of the administration's Storm Resiliency and Infrastructure Development Committee, of which the bill sponsors are members. The committee, composed of City Council members and representatives of the Mayor's Office, Planning and Development Department, Public Works Department, U.S. Army Corps of Engineers, St. Johns River Water Management District, and Florida Department of Environmental Protection, heard a variety of presentations regarding sea level rise, increasing frequency and intensity of rainfall events, state and federal regulations related to stormwater and flooding, and comparisons of Jacksonville's stormwater and floodplain management ordinance and practices with those of other Florida jurisdictions. One finding was that other Florida jurisdictions regulate the amount of impervious (nonwater absorbent) surface that can be present on lots as a means of controlling the amount of stormwater runoff that must be collected, treated, transported and disposed of by the public stormwater management system. Jacksonville currently regulates maximum lot coverage by principal structures on individual lots, but does not regulate associated patios, decks, accessory buildings, etc. which increase impervious coverage and thereby produce greater amounts of stormwater runoff. The City also does not currently regulate ISR at the subdivision level, which will take into account the impervious surfaces of roads, parking lots, clubhouses, pool decks, and the like.

**Bill Summary:** This bill establishes a Neighborhood Assessment Program (NAP) within the Ortega Point North for Underground Power and Communications Improvements. JEA will be the government entity providing NAP financing and project performance and will undertake the completion of all work associated with the planning, management, financing, supply of material and labor, and overall construction. All project costs will be initially funded by JEA, and all costs incurred in support of the Underground Power and Communication Improvements will be reimbursed to JEA through this NAP using the uniform method for the levy, collection, and enforcement of non-ad valorem assessments. The estimated total Underground Power and Communication Improvements cost is \$1,531,708. The estimated annual non-ad valorem assessment, per parcel, is \$1,075.22, for twenty (20) years.

**Background Information:** The purpose of this legislation is to convert overhead electric, telephone and cable television lines to underground utilities. Property owners within the Ortega Point North neighborhood filed a Petition signed by at least three-fourths of the owners of properties located within the area.

Policy Impact Area: Underground Power and Communications Improvements

Bill Summary: The bill approves execution of an economic development agreement between the City and Project Liberty (company name temporarily kept confidential) to support the expansion of the company's operations in Jacksonville. It commits the City to funding the local match of a Qualified Targeted Industry grant in an amount not to exceed \$198,000 and provides for oversight of the project by the Office of Economic Development. The project incentives are declared to be compliant with the City's Public Investment Policy and fast-track approval on 2 readings is requested.

Background Information: Project Liberty, a company with a current presence in Jacksonville, is an international information technology company that designs software for large corporations. Jacksonville and several other cities are under consideration as sites for the company's planned expansion. The company proposes to create a minimum of 198 new full-time jobs by the end of 2021 at an average wage of \$69,000 plus benefits. The City commits to a Qualified Targeted Industry local grant match of up to \$198,000 (\$1,000 per job) payable over 6 vears, which is a 20% match to the State's 80% commitment of \$792,000 (\$4,000 per job). The Office of Economic Development calculates the incentive's return on investment at 2.03.

Policy Impact Area: Economic development

Fiscal Impact: The City commits to a local QTI match of up to \$198,000.

**Bill Summary:** The bill appropriates \$6,246,725.33 within 19 all-years subfunds to balance revenue and expenses as part of a clean-up of financial accounts in preparation for the implementation of the new Enterprise Resource Planning (ERP) system in FY19-20. It provides for carry-over of the funds to future fiscal years.

**Background Information:** The City has used FAMIS as the financial system managed by the General Accounting Division for decades. This accounting software and the use of it never balanced revenues and expenses at the lowest level which is at the project level. A number of the subfunds that have been appropriated since 1996 used a single project to account for revenue and numerous projects to account for the expenses related to specific projects. As part of the conversion to the new ERP this clean-up is required. The requirement is due to the configuration of this new software and the conversion of the financial information from FAMIS to 1Cloud.

Policy Impact Area: Financial accounts clean-up and reconciliation

**Bill Summary:** This bill appropriates \$2,000,000.00 from a Capital Projects – Construction Account to a Capital Projects - Land Account to purchase property for new Fire Station No. 65; amends the 2019-2023 Five-Year Capital Improvement Program (CIP) approved by Ordinance 2018-505-E.

**Background Information:** Arlington Road and Atlantic Boulevard area was identified by the City's 2012-2016 Capital Improvement Program, and TriData reports for a new fire station to assist in reduction of response times for fire and EMS incidents. The project is entitled Fire Station #65 (New) and includes the purchase of the property, the construction, and staffing of the fire station. The property is located at 7600 Bailey Body Road. Also, the funding includes a new Fire Engine and Rescue Unit. The appropriation is initiated by B.T. 19-094. The amendment to the CIP is necessary to address the high call volume in the area and provide adequate protection to the community as soon as possible.

**Bill Summary:** This bill is an ordinance which calls for a special election to hold a referendum on November 5, 2019. The Duval County School Board has requested that the City Council call a referendum for approving the School Board's levy of a half-cent School Capital Outlay Sales Surtax. The Duval County School Board has adopted a resolution levying a half-cent School Capital Outlay Sales Surtax, subject to approval by the voters in a referendum, but only the City Council has the authority to place the referendum on the ballot.

**Background Information:** The purpose of this legislation is to determine if voters approve of a 15-year half-cent sales surtax to: upgrade aging schools through repairs and modernization, to improve technology, and to replace existing or build new schools. If the surtax is approved by a majority vote of the electors of Duval County, it will take effect on January 1 of the year immediately following the referendum and will be monitored by an independent citizens committee.

**Fiscal Impact:** Estimated cost of \$700,000 to \$1.4 million for election costs to be allocated from Duval County School Board budget

**Bill Summary:** This bill approves and authorizes the Mayor or his designee, and Corporation Secretary to execute and deliver, a certain License Agreement between the City of Jacksonville South Ortega Land Trust; provides for oversight by the Real Estate Division of the Department Of Public Works; appropriates \$212,655.00 from the Tax Collector's Fund Balance, as initiated by revised B.T. 19-093; and provides for a carryover of funds to subsequent fiscal years.

**Background Information:** The Tax Collector's office seeks to utilize the 8,300 square feet of office space located at 6331 Roosevelt Boulevard for the Cedar Hills Branch Office. The current location is too small to meet the needs of the more than 107,000 customers served each year. The term of the lease agreement is ten years and ten months (130 months) with two five-year renewal options. The appropriation covers the purchase of furniture, fixtures and equipment, infrastructure technology, mail equipment, and other expenses necessary for the relocation of the Cedar Hills Branch.

Bill Summary: The bill authorizes the issuance of Special Revenue and Refunding Bonds in an amount to produce net project funds of no more than \$85 million to refinance outstanding bond issues and to finance the acquisition and construction of certain capital equipment and improvements. The bill waives the provisions of Ordinance Code Sec. 104.211 – Procedure for Sale of Bonds – to allow the bonds to be awarded on a limited competitive basis, on a negotiated basis, or as a private placement to institutional investors rather than on a solely competitive basis.

**Background Information:** The bill authorizes borrowing to cover the costs of 187 previously authorized projects and fixes out existing short-term interim borrowing for 124 projects. As a result of this transaction, the City will have reimbursed itself for spending on previously-authorized projects, refunded certain bonds to achieve savings, fixed-out certain variable rate and short-term rate mode bonds, and fixed-out certain short-term debt in times of historically low interest rates. The waiver of the competitive award requirement is requested because of the flexibility is provides to time the issuance of the bonds during preferred market conditions. The use of a negotiated sale procedure using one or more investment banking firms acting in consultation with the City Treasury and the City's financial advisors is anticipated.

Policy Impact Area: Debt management

Fiscal Impact: The bill authorizes issuance of up to \$85 million in bonds for net project funds, which is estimated to cost less than \$6 million per year in debt service and will be amortized in accordance with the City's Debt Management Policy such that the useful life of the debt does not exceed the useful life of the various projects being financed. The bonds will be secured by the Special Revenue pledge of all City revenue sources except ad valorem taxes.

The City has filed an application with FDOT to offset the expansion of the Nira Street railroad-highway public at grade crossing to close permanently a railroad-highway public at grade crossing at Gary Street and a railroad-highway public at grade crossing at Naldo Avenue. Through a separate agreement with the Florida East Coast Railway, the City will agree to pay the annual license fee and maintenance fees for the crossing surface within the crossing area at the Nira Street railroad-highway public at grade crossing.

**Background Information:** The purpose of this legislation is to permanently close two railroad-highway public at grade crossings. The railroad (at the City's expense) will: provide the materials, install the automated crossing warning device, flashing lights and gates. The City will: remove all parts of the old crossing, restore the right of way, and provide closure signs and object markers.

**Background Information:** The Florida Housing Finance Corporation provides funds to local governments as an incentive to create partnerships that produce and preserve affordable homeownership and multifamily housing. SHIP dollars may be used for emergency repairs, new construction, rehabilitation, down payment and closing costs assistance, impact fees, construction and gap financing, mortgage buy-downs, acquisition of property for affordable housing, matching dollars for federal housing grants and programs, and homeownership counseling.

The City was awarded \$1,294,383.00 in 2019-2022 SHIP program funds from the Florida Housing Finance Corporation and \$438,611.00 in recaptured funds. The funding includes an administrative cap of 10% equal to \$129,428.00. The funds will be available by July 1, 2019.

The positions approved to administer the program include Affordable Housing Assistant Administrator, Housing Services Manager, Housing Loan Analyst, and a Housing Rehabilitation Specialist. The grant period for the employees begins October 1, 2019.

All funds must be obligated within 2 years and spent within 5 years of the agreement signage.

**Background Information:** The purpose of the appropriation is to provide funding for a wide range of activities, including building, buying, and/or rehabilitating affordable housing for rent or homeownership for, or providing direct rental assistance to, low income individuals and families. The appropriate funds will be spent for the City's limited repair program, development subsides for certified Community Housing Development Organizations, and a revolving loan fund and administrative costs.

**Bill Summary:** This bill is an appropriation of \$4,619,801 (\$3,464,850.75 from the Federal Emergency Management Agency (FEMA) through the State of Florida Division of Emergency Management and a 25% City match of \$1,154,950.25 from the General Fund. This bill also authorizes the Federally-Funded Sub-award and Grant Agreement between the Florida Division of Emergency Management (FDEM) and the City of Jacksonville. The 2019-2023 CIP is amended to provide funding for this project. FDEM will provide oversight. All funding for this project will expire February 28, 2021.

If the developer fails to commence construction of the Project by December 31, 2020, then the City has the option to repurchase the Property in accordance with the repurchase option in the Agreement.

When the City performed a Site Assessment Report and subsequently a Supplemental Site Assessment Report ("SSAR") on the Property, certain environmental contamination on the Property was identified, and the City is currently performing quarterly groundwater monitoring on the Property related to a groundwater plume. Due to contamination that remains on the Property and on the adjacent City right-of-way, the FDEP has a closure process available that will require that the City enter into a Declaration of Restrictive Covenant with FDEP on the affected portion of the City-owned right-of-way.
