Pine Castle, organized in 1952, is a Florida nonprofit corporation that provides service and facilities to the developmentally disabled (mental retardation, down syndrome, cerebral palsy). The services include vocational training, community job placement, residential housing in the greater Jax area. JEDC has been created to act as the sole industrial development authority for Jacksonville, enabling the agency to issue Industrial Revenue Bonds or similar tax exempt financing. By utilizing JEDC's IRB program, Pine Castle will be eligible to borrow funds on a tax-exempt basis which results in a cheaper cost of borrowed capital to finance the new Enrichment Center. The new building will include classrooms, computer labs, an assembly room, sport/recreational facilities and a therapy room. Pine Cast will be able to service approximately 41 new individuals and anticipates that eleven new jobs will be created.
