Bill Summary: This ordinance amends Section 21.03 (Composition; Compensation; Officers; Meetings), of Article 21 (JEA), *City Charter*, to provide that JEA board shall hold meetings at least every other month rather than monthly.

Background Information: At a Rules Special Meeting, JEA's Chairman of the Board, Tom Petway, requested that the City Council amend the City's charter to enable the JEA's Board to meet every other month instead of the monthly basis that it currently meets. He explained that monthly meetings were particularly hard on JEA staff. Mr. Petway explained that the JEA Board wanted to have a meeting requirement similar to that of the Port Authority.

Policy Impact: JEA; City Charter

Bill Summary: The bill amends Ordinance Code Chapters 30 – Planning and Development Department, 31 – Fire and Rescue Department, 32 – Public Works Department, 55 – Downtown Investment Authority, and 90 – Board of Library Trustees to modify the requirements for appointed officials to have four-year degrees "<u>from an accredited college or university</u>." Chapter 116 – Employees and Employee Benefits – is amended to provide a definition of "accredited university or college degree" to mean a degree from an institution accredited by an accrediting agency or state approval agency recognized by the U.S. Department of Education.

Background Information: The City's Inspector General recently investigated a whistleblower complaint about several current appointed officials and a nominee for an appointed position alleging that the employees and nominee did not have degrees from accredited colleges or universities as required by the Ordinance Code. The IG's investigation substantiated the allegation and found that the Employee Services Department lacked sufficient internal controls to verify college degrees and transcripts and to verify that the degrees were awarded by accredited colleges. This bill is intended to provide a clear definition of what constitutes an "accredited college or university" for this purpose. It also inserts language requiring a degree from an <u>accredited</u> college or university into several Code chapters where college degrees are required as credentials for various appointed officials, but the sections do not mention accreditation. Other chapters already require degrees from accredited colleges.

The U.S. Department of Education does not accredit colleges and universities, but the Secretary of Education is required by law to publish a list of nationally recognized accrediting agencies that the Secretary determines to be reliable authorities as to the quality of education or training provided by the institutions of higher education and the higher education programs they accredit.

Bill Summary: The bill amends Ordinance Code Chapter 112 – Claims By and Against the City – to add "code enforcement liens" to the list of claims, bills and judgements that may be settled by the Finance Director, Office of General Counsel or Mayor (depending on the principal amount of the lien) if s/he determines that it is in the City's best interests to settle a case for less than the full amount due, and eliminates the requirement that a department head must approve the settlement of code enforcement liens originating in their department. The bill amends Ordinance Code Chapter 518 – Jacksonville Property Safety and Maintenance Code – to provide that a nuisance abatement lien may not be settled until the property complies with the Jacksonville Property Safety and Maintenance Code, replacing the current provision which allows settlement to proceed if the property is rehabilitated to the satisfaction of Chief of the Code Enforcement Division.

Background Information: The preamble to the bill states that in numerous instances in which the City imposes liens for funds expended in remedying nuisance code violations, the City never collects on the lien from the original owner and is petitioned by a subsequent owner (who often takes possession of the property via foreclosure or tax deed sale) to reduce or cancel the lien because that owner was not responsible for the original violation. The Ordinance Code currently provides a mechanism for administrative settlement of delinquent bills, claims and judgements, but not code enforcement liens. This bill adds code enforcement liens to the list of items that can be settled administratively. The amendment will allow nuisance abatement liens with a principal amount of \$1,000 up to \$4,999 to be settled by the Director of Finance; liens with a principal amount of \$5,000 to \$9,999 to be settled by the Finance Director's concurrence; and liens with a principal amount of \$10,000 to \$99,999 to be settled by the Mayor with the concurrence of the General Counsel and the Finance Director.

Policy Impact Area: Nuisance abatement liens

Fiscal Impact: Undetermined; will authorize administrative settlement of liens for less than the full amount of principal and interest due.

Additionally, it de-authorizes \$12,500 from the trust fund for Fiscal Year 2013 funding that was not realized, as initiated by B.T. 17-022.

NOTE: the term "appropriating \$25,000" in the bill title appears confusing, as the action authorized in the bill is an appropriation of \$12,500 and a de-appropriation of \$12,500.

Background Information: This legislation is necessary to authorize the transfer from \$12,500 from the Special Law Enforcement Trust Fund to the Police Explorer Trust Fund to fund the FY16-17 operating budget for the Post. Additionally, another transfer cleans up the trust fund (an all-years fund) by de-appropriating \$12,500 allocated to the fund in FY13 that was never realized within the account.

Policy Impact: Jacksonville Sheriff's Office

Fiscal Impact: The ordinance appropriates \$12,500 from the Special Law Enforcement Trust Fund to the Police Explorer Trust Fund and de-appropriates \$12,500 never realized in the fund in a previous fiscal year.

Bill Summary: This bill appropriates \$672,284.00 from the United States Department of Justice (DOJ), with no local match, for the Sexual Assault Kit Initiative (SAKI II); approves and authorizes the Mayor, or his designee, and Corporation Secretary to execute and deliver the Cooperative Agreement between the City and the U.S. Department of Justice, Bureau of Justice Assistance; provides for City oversight by the Department of Investigation and Homeland Security of the Jacksonville Sheriff's Office; and approves a position, as initiated by R.C. 17-040.

Background Information: DOJ provides funding through a competitive grant program to support multidisciplinary community response teams engaged in the comprehensive reform of jurisdictions' approaches to sexual assault cases resulting from evidence found in previously unsubmitted and untested sexual assault kits (SAK) which are definded as:

- unsubmitted kits SAKs that have not been submitted to a forensic laboratory for testing and analysis
- untested kits SAKs that have been submitted to forensic labs but are delayed for testing for longer than 30 days, for example, as a result of a backlog of work in the laboratory

In 2015, it was reported that there were 1,726 untested SAKs within the 4th Judicial Circuit. In FY15, The State Attorney's Office along with several other local agencies applied and were awarded grant funds from the SAKI and the District Attorney of New York (DANY) Initiative to assist the jurisdiction in expanding resources to address untested SAKs. These funds did not provide JSO with funding for investigative resources.

SAKI (II) grant period is 10/01/2016 through 09/30/2019. This grant will fund:

- one full-time program coordinator
- overtime hours for additional personnel (detectives, detective sergeant, crime analysts, and police service technicians)
- purchase of specialized training/travel
- computer hardware and software
- renovate the HVAC system at the Property & Evidence Storage Facility

The exemption allows for the procurement of services from the Boys' and Girls' Club without utilizing competitive solicitation.

The FY16-17 budget for Community Connections was \$355,646.00. The following is breakdown of funds reallocated on Schedule A-2:

- 1. \$285,606.00 for afterschool services
 - a. Martin Luther King \$157,896.00
 - b. Hyde Grove Elementary \$127,710.00
- 2. \$29,500.00 to operate the Normandy community based afterschool site (appropriation to Parks, Recreation & Community Services Department)
- 3. \$40,540.00 to cover increased seats for 2017 Summer Learning Camps

It is detrimental to the safety of the public to defer this amendment until the next annual budget and CIP review.

Background Information: Carr, Riggs and Ingram is in the second year of its three-year contract to serve as independent auditor of the City's financial reports for FY15, FY16 and FY17. The separate audits of the CRA accounts is intended to provide greater transparency to the Council and the general public about the financial condition of the various CRA accounts.

Policy Impact Area: Tax increment district finances

Fiscal Impact: The addition of the \$15,000 for the CRA audit work will bring the total contract amount to \$303,500 for the FY16 audit. The amount for the FY17 audit will be increased by \$15,000 to \$313,500.

Bill Summary: The ordinance endorses and requests delivery by the Florida Department of Transportation of the Edison Avenue/McCoy's Creek Bridge Replacement Project (No. 724080/FIN #409267-1-52-01) and the Howell Drive/Ribault River Bridge Replacement Project (No. 724147/FIN #415250-1-52-01) to the City. It approves and authorizes the Mayor and Corporation Secretary to execute and deliver the Construction & Maintenance Agreement for the Edison Avenue/McCoy's Creek Project (No. 724080/FIN #409267-1-52-01) and provides for oversight by the Right-of-Way and Stormwater Maintenance Division of the Department of Public Works.

Background Information: The Florida Department of Transportation (FDOT), at their own cost, will replace the bridges on Edison Avenue over McCoy's Creek and Howell Drive over the Ribault River. Both bridges are in the FDOT Five Year work program and will be completely replaced. The Edison Avenue Bridge was constructed in 1929 and is a multi-span reinforced concrete slab on steel girder structure that crosses McCoy's Creek in Jacksonville's Westside. It serves the local community with approximately 5400 average trips a day. It is currently a load restricted bridge and has been designated by FDOT as "structurally deficient." Edison Avenue runs approximately parallel to and north of I-10 and the Edison Avenue Bridge is near the Roosevelt Boulevard exit. Should the bridge crossing be lost, residents will be forced to use McCoy's Creek Boulevard as an east-west corridor which currently accommodates only half the traffic volume of Edison Avenue. The Howell Drive Bridge was constructed in 1964 and is a reinforced concrete multi-span structure that crosses the Ribault River in Jacksonville's Northside. It serves the local community with approximately 8600 average trips per day. It's currently a load restricted bridge and has been designated by FDOT as structurally deficient having an "unknown foundation" and is rated as "scour critical." The City shall own, operate, maintain and repair the improvements at the City's sole cost and expense.

Policy Impact: Public Works/Engineering & Construction Maintenance

Fiscal Impact: Minimal. The FDOT is replacing the two bridges at its expense.

Bill Summary: The bill authorizes execution of a property interest donation agreement and stormwater system maintenance agreement with the Florida Department of Transportation for the City to provide a perpetual easement to facilitate the Crystal Springs Drainage Improvement Project. It designates the Department of Public Works as the City's oversight agency for the agreement.

Background Information: The Crystal Springs Road drainage improvement contract was executed in July 2016 and the project is underway at the intersection of Joes Road and Blair Road adjacent to the Glenda's Meadow subdivision. Part of the work involves the construction of a linear stormwater pond by expanding an existing drainage ditch, the replacement of the cross-drain under Joes Road and improvements to the stormwater collection system in the adjacent neighborhoods. The City and FDOT will share the increased water storage capacity, which will reduce flooding at the intersection and provide greater ingress and egress from the Glenda's Meadow neighborhood in periods of heavy rain. A number of homes have only one means of access through the Joes Road/Blair Road intersection which can be cut off when the creek beneath the intersection floods.

Policy Impact Area: Drainage improvement

Fiscal Impact: None. The drainage project is already funded and under construction and the Public Works Department anticipates no additional maintenance costs resulting from the construction of the new pond.

Thus, the annual lease payment of \$60,000.00 will be prorated for the closure which will reduce Dania Pier's obligation by \$5,500.00 per month.

Bill Summary: The bill approves a new set of Goals, Policies and Guidelines for the Northwest Jacksonville Economic Development Fund (NWJEDF) at the request of the NWJEDF Advisory Board and the Office of Economic Development.

NOTE: The bill will need an amendment in committee to replace Exhibit 1. The attachment as filed is the Project Evaluation and Underwriting Criteria for the NWJEDF, which was not intended to be adopted by the Council; the correct Exhibit should be the Goals, Policies and Guidelines document.

Background Information: The current Goals, Policies and Guidelines for the NWJEDF were adopted in 2007 and the preamble to the bill states that over the years several worthwhile projects have made application for use of the fund that have required waivers of the established policies for a variety of reasons. The NWJEDF Advisory Board and Office of Economic Development have rewritten the Goals, Policies and Guidelines to reflect the preferred use of the fund to generate the desired economic impacts in the targeted area.

The four overarching goals of the NWJEDF as proposed are: 1) create access to jobs for Northwest area residents; 2) support the expansion of existing businesses within the Northwest area and encourage the creation of new service and retail businesses to serve the needs of the community; 3) encourage redevelopment of vacant and underutilized buildings within the Northwest area; and 4) stimulate new investment within the Northwest area adding to the tax base. The policies include provision of loans (secured by liens on the property) rather than grants; a limit on NWJEDF funding of no more than 25% of the total project cost; and reimbursement to the City of a portion of the assistance provided (on a declining scale) if the property is sold or otherwise transferred within the first 5 years after the grant. A list of 11 eligible and 7 ineligible categories of expenditures is adopted. Eleven types of businesses are declared to be ineligible for NWJEDF funding, including adult entertainment and adult gaming businesses, bars, nightclubs, tattoo parlors, used car lots, check cashing establishment and the like.

Bill Summary: The bill authorizes the Jacksonville Housing Finance Authority to issue up to \$20 million in multifamily housing revenue bonds on behalf of SP TT Apartments, LLC to acquire and rehabilitate the Timberwood Trace apartments for low- to moderate-income housing. It declares that the bond issue does not constitute a debt, liability or obligation payable by the City or the JHFA and requests one-cycle emergency approval of the bill.

Background Information: SP TT Apartments, LLC proposes to acquire the 224-unit Timberwood Trace Apartments complex at 12250 Atlantic Boulevard for \$17.7 million and to invest \$5.57 million in rehabilitation (\$24,874 per unit). Total development cost for the project (acquisition, construction, financial costs, general development costs, and developer fees) is estimated at \$29,518,762 or \$131,780 per unit. One-cycle emergency approval is requested so that the JHFA can apply before the end of the calendar year to the Florida Division of Bond Finance for a portion of excess housing revenue bond allocation currently available for use, with the goal of closing the bond transaction in February of 2017.

Bill Summary: The bill expresses the Council's support for passage of legislative bill J-1 which would amend the Florida statute regarding votes by school boards to provide that the vote of the Duval County School Board Chair shall not be deemed to determine the prevailing side in the event of a tie vote, so long as the board chair is elected by the School Board members themselves.

Background Information: In 2006 the Florida Legislature adopted Chapter 2006-256, *Laws of Florida*, to provide that in the event that a vote of a school board in a charter county with a population of between 800,000 and 900,000 (as of the last decennial census) ends in a tie, the side on which the school board chair voted is considered to be the majority side and to have prevailed. The proposed local bill J-1 adds an exception to Section 1001.365, *Florida Statutes*, to provide that the general rule shall not apply to the Duval County School Board as long as the board chairperson is elected annually by the board members from among their colleagues. Some counties elect their school board chair by vote of the electors rather than internally by the school board. A review of the 2000 U.S. Census data finds that when the statute was adopted in 2006 it would have applied only to Orange County (population 896,344). Duval County's population in 2000 was 778,879; as of 2010 Census it had increased to 864,263, therefore making the School Board subject to the provision of the statute. The county's U.S. Census Bureau estimated population as of July 1, 2015 was 913,010 which, if maintained through 2020, would make the county exempt from the statute again as of the next census.

Bill Summary: The bill expresses the Council's support for local legislative bill J-2 that would amend Chapter 87-471, *Laws of Florida* (as amended by Chapters 2011-255 and 2016-248) to add additional exceptions to the state's floor space and seating requirements for liquor licenses in restaurants in particularly designated "commercial area" zones in the Springfield and Murray Hill neighborhoods.

Background Information: Chapter 87-471, Laws of Florida, is a law creating defined zones in Jacksonville where the Florida Division of Alcoholic Beverages and Tobacco may issue special alcoholic beverage licenses for liquor sales to restaurants that do not meet the current size criteria if the facilities have at least 1,800 square feet of floor space and at least 100 seats and produce at least 51% of their revenue from the sale of food. ABT regulations normally require a building of at least 2,500 square feet and 150 seats. This bill adds 96 individual parcels of property in the Murray Hill Commercial Area (excluding all churches, schools, non-profits, vacant lots and parking lots), on both sides of Edgewood Avenue between I-10 and Roosevelt Boulevard, parcels fronting Roosevelt Boulevard between Edgewood Avenue and Owen Avenue, and in the polygon formed by I-10, Lenox Avenue and Woodruff Avenue. The bill adds 234 parcels of property in the Springfield area generally described as both sides of Main Street from 1st Street north to 20th Street and on both sides of 8th Street from Pearl Street on the west to Walnut Street on the east (excluding churches, schools and non-profits, but not excluding vacant lots or parking lots).

Policy Impact Area: Alcoholic beverage licensing

Fiscal Impact: The state cost estimate filed with the bill states "Like similar bills that have been approved, this bill is revenue positive with an increase in sales tax revenue and licensing revenue, which is not possible to quantify. However, easing restrictions for a bona fide restaurant to serve all alcohol increases the opportunity for profit, thus creating more jobs and sales tax revenue." The economic impact statement says "The bill enables more sales tax revenue without increasing services or staff. 2 COP licenses return \$392 per year and 4 COP licenses return \$1,820 per year in Duval County."

Background Information: Over the past twenty years, Northeast Florida has struggled with fixing a transportation gridlock impacting both sides of the St. Johns River in Downtown Jacksonville. The issue involves the convergence of two Class 1 railroads (CSX and Norfolk Southern), and FEC Railroad which have grown as freight traffic, highway traffic and the Northeast Florida community has expanded. The North Florida Freight Rail Enhancement Program will significantly improve freight and mobility in the area adjacent to the Jacksonville Regional Transportation Center and Prime F. Osborn Convention Center. Funding from the North Florida Freight Rail Enhancement Program will assist in:

- improving rail fluidity in the region, which will in turn expedite statewide and national freight movement;
- reducing vehicle conflicts on streets leading to downtown Jacksonville;
- improving safety and air quality;
- improving freight and trains ability to travel more efficiently through the area unencumbered by switching delays;
- removing system constraints and upgrade operations to improve efficiency/safety of operations;
