Bill Summary: The bill approves an economic development agreement between the City and Ecolab Inc. to support the company's relocation and expansion in Jacksonville. It approves award of a Recapture Enhanced Value (REV) grant in the amount of \$214,000 over 5 years and waives the City's Public Investment Policy to the extent required to make the REV grant to a project that does not meet the minimum scores on the City's project evaluation matrix to qualify for a 50% rebate of increased taxes over 5 years. The bill designates that Office of Economic Development as the oversight agency for the agreement and requests emergency action on second reading after one committee cycle.

Background Information: Ecolab, a Fortune 500 company, has operated in Jacksonville since 2007 and currently employees 55 workers at its facility on the Southside where it manufactures medical devices. The company intends to expand by up to 35 new full-time jobs (paying an average wage of \$28,000 plus benefits) and to lease a new build-to-suit building in the Jacksonville International Airport Community Redevelopment Area at a total development and furnishing cost of \$9 million. The City proposes to offer a REV grant of up to \$214,000 payable over 5 years from the revenues of the JIA CRA. The Public Investment Policy waiver is required because the company does not meet the minimum project evaluation matrix score to qualify for the full 50% REV grant for 5 years.

Fiscal Impact: The City commits to payment of a REV grant of up to \$214,000 payable over 5 years from the revenues of the JIA CRA.

Background Information: By Ordinance 2014-519-E enacted in October 2014 the City Council created an Office of Inspector General, the head of which is an Inspector General to be selected by an Inspector General Selection and Retention Committee and confirmed by the City Council. This bill provides that the Inspector General and any other managerial employees in the office shall be eligible to join the City's General Employees Defined Contribution retirement plan, not the defined benefit General Employees' Pension Plan.

Background Information: There are currently three streets in Jacksonville named "Park Street". The oldest one is located in Maxville area. In an effort to eliminate potential confusion and the delay in emergency response, 911 Emergency Addressing Advisory Committee along with Planning and Development staff recommended renaming the Maxville area "Park Street" to "Maxville Park Drive".

The name change impacts two properties. The owners and residents of the affected properties were provided various opportunities to participate in renaming the street. The Jacksonville Historic Preservation Commission reviewed the recommendation of the 911 Emergency Addressing Advisory Committee on May 28, 2014, and determined there was no historical impact preventing the name change. All provisions have been met pursuant to Chapter 745 Ordinance Code.

Bill Summary: This bill reappoints Raymond S. Pringle, Jr., to the Jacksonville Waterways Commission, for a second three-year term ending December 31, 2017.

Background Information: The Jacksonville Waterways Commission is established pursuant to Chapter 95, *Ordinance Code*, and charged to study and make recommendations to the Council with respect to the improvement, development and protection of the St. Johns River and all tidal waters, and all saltwater, estuarine and riverine wetlands in Duval County; formulate an overall plan for dealing with any problems that exist concerning the St. Johns River and all tidal waters in Duval County; devise methods of developing future uses of the St. Johns River and all tidal waters in Duval County; serve as the Duval County committee to review rules proposed by the Florida Fish and Wildlife Conservation Commission governing speed and operation of motorboats to protect manatees; assist the City in achievement of its state goal to improve the water quality of the City's wetlands resources over the long term and improve the water quality and fish and wildlife value of wetlands by review and making recommendations to the Council with respect to proposed land use amendments; conduct research, studies, collect and analyze data and prepare maps, charts and tables for accomplishment of its purposes; and advise governmental units and the public concerning the improvement, development and protection of the St. Johns River and all tidal waters in Duval County; act as a coordinating agency for programs and activities affecting the improvement, development and protection of the St. Johns River and all tidal waters in Duval County.

Section 95.103(c), *Ordinance Code*, provides that nine of the members of the Jacksonville Waterways Commission shall be members of the general public appointed by the Council.

Pastor Pringle is President and Senior Pastor with *Calvary Chapel Church*. He is a former President of the North Florida Chapter of the Safari Club International and has served on various boards and committees within the state addressing waterways and waterfront issues. Pastor Pringle resides in the Dinsmore area within Council District #11.

Attendance: According to information provided by the staff for the Jacksonville Waterways Commission, Pastor Pringle has attended 85% of the meetings of the commission since his initial appointment in 2011.

Bill Summary: The bill directs the General Counsel to initiate legal action to determine the legal validity of the establishment by the Police and Fire Pension Fund Board of Trustees of a Senior Staff Voluntary Retirement Plan (SSVRP) for the top administrators of the Police and Fire Pension Fund. The General Counsel is also directed to investigate whether claims against the PFPF Board of Trustees are appropriate for mismanagement and/or unauthorized actions in the creation of the SSVRP and, if appropriate, to include such claims in the authorized litigation.

Background Information: By action of the Florida Legislature in 1990 the Police and Fire Pension Fund was separated from management by the City's Finance Department and became an independent agency with its own staff of fund administrators. At some point in 2012 the City became aware that the PFPF Board of Trustees had created a Senior Staff Voluntary Retirement Plan to provide pension benefits to the managers of the fund who are not eligible to join either the Police and Fire Pension Fund, the City's General Employees' Pension Plan or the Florida Retirement System. Then-General Counsel Cindy Laquidara issued a legal opinion finding that the creation of the SSVRP was not an authorized function of the PFPF board. The PFPF's attorney contended that the board did have the authority to create such a plan as part of its power to set the compensation for the senior staff. The City Council authorized the General Counsel, via Resolution 2012-624-A, to initiate litigation to determine the legality of the SSVRP. Since then the issue of the SSVRP has become incorporated into negotiations between the City and the PFPF on the broader subject of revisions to the benefits, management and funding of the PFPF. This bill directs the General Counsel to pursue to completion litigation on the legality of the SSVRP, and potentially claims against the PFPF Board of Trustees for mismanagement of the fund and unauthorized actions in the creation of the SSVRP.

Bill Summary: This resolution expresses the City's support of the Community Development Coalition Corporation's (CDCC) application to participate in the Florida Community Contribution Tax Credit program.

Background Information: The Community Contribution Tax Credit allows corporations making contributions of cash or goods to approved not-for-profit organizations to take a credit against their corporate income taxes for the amount of the donation. CDCC, located at 1501 North Main Street, is a Florida not For Profit Corporation that provides revitalization, rehabilitation and redevelopment to improve housing and home ownership opportunities in the City of Jacksonville at no cost to the tax payer.

CDCC intends to accept charitable donations of cash and or property to assist in the making necessary revitalization and redevelopment improvements. Their participation in the Community Contribution Tax Credit program permits businesses making donations to the improvement projects eligible to claim a credit for the amount of the donations against their state corporate tax bill. The Planning and Development Department has certified that the planned projects are consistent with local plans and regulations, including the City's 2030 Comprehensive Plan.
