Bill Summary: The bill amends the Ordinance Code by creating a new Chapter 14 – Office of Legislative Counsel to provide for the City Council to hire legal counsel to support its legislative needs. The office may be staffed by attorneys working for the City on a full-time or part-time basis or by private attorneys working for the Council pursuant to engagement agreements. The bill sets out 4 "guiding principles" for the relationship between the Office of Legislative Counsel and the Office of General Counsel: 1) traditional legal services and staffing provided to the Council by the OGC shall continue; 2) the two offices shall, to the maximum extent practicable, cooperate and share legal resources, opinions, research, experts and expertise and maintain open and active lines of communication; 3) the Office of Legislative Counsel and the Council Director/Secretary shall coordinate with the OGC to make available hard copy and electronic research in the most cost effective manner; and 4) nothing in this chapter is intended to limit the General Counsel's authority to issue binding legal opinions as provided by the City Charter.

Background Information: City Councils have from time to time expressed an interest in utilizing the authorization provided in the Charter for the council to hire its own legislative counsel to provide legal research, advice and legislative support independent of the assistance provided by the Office of General Counsel, particularly in instances where the City Council and a mayoral administration have very differing views on a particular matter. In such instances the Council may desire to independently verify information or legal advice it is given by the OGC to ensure the impartiality of the information or to explore alternatives that may not have been proposed or recommended by the OGC. The Council did create an Office of Legislative Counsel for a brief period in the mid-1980s and hired Jim Robinette as Legislative Counsel; the office was disbanded a year later.

The bill creates a new Part 5 – Administration; Enforcement – in Chapter 220 setting forth procedures for seizure and impoundment of motor vehicles operated in violation of the chapter; for administrative hearings, citations, appeals and vehicle forfeitures; and for disposition of abandoned vehicles.

Background Information: The bill is being introduced to deal with allegations that companies using Internet services to connect riders with non-taxi vehicles for hire are skirting the City's vehicle-for-hire ordinance. The bill expands enforcement efforts by authorizing the Sheriff's Office to participate in enforcement and authorizes the seizure and impoundment of vehicles suspected of violating the ordinance until an administrative hearing can be convened.

Policy Impact Area: Vehicle-for-hire regulation

Fiscal Impact: Undetermined; the amendment provides that civil penalties collected from enforcement efforts shall be allocated to funding the enforcement activities.

Bill Summary: This ordinance amends Chapter 804 (Jacksonville Traffic Code) *Ordinance Code*; Creating New section 804.406 (Speed Limit Reduction on Local Roads by Petition), *Ordinance Code*, to Provide for a Petition Process for Reduction of Speed Limits on Local Roads.

Background Information: Residents are seeking opportunities to lower speed limits on public residential streets similar to the lower posted speed limits found throughout the City on private streets. As freeways and arterial routes in the City become more congested, motorists often seek alternative routes, utilizing local streets; neighborhoods are impacted with additional traffic. This proposed legislation would enable a neighborhood homeowner's association or group of residents to petition to have the speed limit on a local road within a residence district reduced from 30 miles per hour to a maximum speed limit of 20 or 25 miles per hour on local streets. The petition form would be generated by the Department of Public Works. The process would entail the neighborhood group filing the petition to contact their Council Member; the Council Member would proceed to schedule a public meeting with the Traffic Engineering Division and JFRD to discuss the proposed petition. After the scheduled meeting, the neighborhood group has to circulate the petition to affected property owners (owners of property along the road segment of the local road in question). At least 75% of the property owners of the local road segment impacted must be in accord with the proposed speed limit change. Once the petition process is completed, the Public Works Department will invoice the neighborhood for 50% of the costs for signage and other applicable costs. To complete the process, the City Highway Engineer has to determine if the changes conform with FDOT criteria for speed zoning and are reasonable; the Sheriff's input and approval is required, as well.

A process is created that enables a City Council Member to request the installation of a marked crosswalk. Upon a review of input from the community, a Council Member can request the Public Works Department to install an un-signalized intersection crossing, also known as a crosswalk, at specific intersection locations on local roads. Legislation to appropriate funding to install a marking device and signage would be required.

Background Information: Carla Miller was appointed the City's Ethics Officer in December 2011 and was confirmed by Council as the first Director of ECO in March 2012. Ms. Miller, a resident of St. Johns County, serves on a part-time basis at an hourly rate of \$85, with a total annual salary cap of \$75,000. The employment agreement provides that she shall not work more than 25 hours per week without advance approval of the Chair of the Ethics Commission and that no work week shall exceed 40 hours. The position is not entitled to pension or insurance benefits.

The bill designates the Department of Parks, Recreation and Community Services as the City's oversight agency for the contract.

Background Information: Comstock Golf leased a portion of the site of the former Blue Cypress Golf Club on University Boulevard North when the City constructed a new park on the closed course and constructed a new 9-hole golf course on the site. The original lease term was for 20 years with two 10-year renewal options. Comstock has been struggling to make the golf course a going concern in recent years and the City has previously amended the lease to make the financial terms more achievable for the company. Comstock was unable to make its gross revenue percentage payments for 2012/13 and 2013/14. This Second Amendment releases Comstock Golf from its obligation to pay the City 2% of its gross revenue (as defined) from operations from June 2012 through May 2013 and 3% of gross revenue from June 2013 through May 2014. The original terms provide that Comstock is still obligated to pay the City 4% of gross revenue for operations from June 2014 through May 2015 and 5% on gross revenue from June 2015 through May 2016 and for each year thereafter through the completion of the lease term.

Policy Impact Area: Golf course lease agreement

Fiscal Impact: Comstock's gross revenues percentage payment due for FY12-13 was \$7,610.94 and for FY13-14 was \$11,624.07.

The wording of the previous ordinance did not make clear that the Council intended the prospective residency requirement, if implemented, to apply only to employees hired on or after January 1, 2016 and not to current employees and appointees. Bill Summary: This resolution expresses the Council's support for Local Bill J-2, to be considered by the Duval County Legislative Delegation for the 2015 Legislative Session, which would amend Chapter 2014-70, Laws of Florida; it provides for an exemption to Section 327.37(6), Florida Statutes, for kite surfing or kite boarding activities in Huguenot Memorial Park in the City of Jacksonville.

Background Information: In Spring 2014, Senate Bill 320 was introduced in the Florida Senate; the bill would regulate and restrict kite surfing. The bill was subsequently enacted and signed into law by the Governor. The bill (effective October 1st) restricts kite surfing at Huguenot Park because of the park's close proximity to an air strip at Naval Station Mayport. Naval Station Mayport spokesperson indicated that the Navy has no problem with kite surfing or kite boarding at Huguenot Park. This proposed J-Bill would exempt Huguenot Park from the restrictions and penalties that are in the White-Miskill Act.

Bill Summary: The bill expresses the City Council's support of proposed local legislative bill J-3 which would amend Section 17.04 of the City Charter to clarify the Civil Service Board's authority, as a quasi-judicial body, to hear appeals, grievances and complaints regarding grievable Civil Service and personnel rules and regulations authorized by ordinance or by the Charter.

Background Information: The J-bill would amend City Charter Article 17 – Civil Service – to clarify that the jurisdiction of the Civil Service Board extends to persons covered by civil service rules and regulations who initiate a grievance alleging violations of grievable civil service rules and regulations authorized by ordinance or Charter, not to all employees or prospective employees alleging violation of any term or provision of the City's employment, hiring, promotion or disciplinary regulations.

Bill Summary: This bill appoints Harold D. Briscoe, Jr. to the Public Service Grant Council, in a seat established via Ordinance 2013-116-E, for a first term ending December 31, 2016.

Background Information: The Public Service Grant Council is established pursuant to Chapter 118, *Ordinance Code*, and charged with the review and evaluation of all Public Service Grant applications and responsibility for making funding recommendations to the Mayor and City Council for Public Service Grants. Ordinance 2013-116-E, enacted March 12, 2013, increased the membership of the Public Service Grant Council from seven to thirteen voting members, including three additional members appointed by the City Council President and confirmed by the City Council.

Mr. Briscoe received master's degrees in theological studies and in public service and administration. He is an Adjunct Professor with the *University of North Florida* and a Pastor with *Southpoint Community Church*. He resides Council District #3.

Bill Summary: The bill authorizes and supports an application to the Florida Department of Economic Opportunity for a Florida Sports Development Program sales tax rebate incentive as a result of qualifying improvements made to EverBank Field. The bill requests emergency approval of the bill on one cycle in order to meet a November 1 application deadline for the incentive.

Background Information: In the 2014 legislative session the Florida Legislature passed a law providing for state financial assistance in the form of a sales tax rebate to local governments that construct, reconstruct, renovate or improve facilities (stadiums, arenas, racetracks, etc.) that host professional sports franchises or "signature events". The assistance is provided via a competitive application process to the Florida Department of Economic Opportunity and must ultimately be approved by the Florida Legislature. The assistance takes the form of a rebate of 75% of the new sales taxes generated by events held at the new or renovated facility, with an annual cap based on the cost of the construction or improvement project. The Jacksonville Jaguars intend to apply to an incentive based on the recent and upcoming improvements to EverBank Field. The deadline for applying for assistance to be considered by the FDOE and the 2015 Florida Legislature is November 1, 2014.

Policy Impact Area: Financial assistance for stadium improvement costs

Fiscal Impact: Based on a project cost of at least \$100 million, the maximum assistance would be \$2 million per year if approved by the Florida Legislature.
