Ticket sales for the 2007 game resulted in a deficit of \$719,146.25 from the guaranteed minimum. The Gator Bowl Association has negotiated with the ACC to accept an alternative payment of \$430,000 to settle the City/GBA liability. The Juvenile Justice Miscellaneous account was chosen to fund the payment because the fund had a sufficient fund balance at the end of FY07-08 to allow the payment to be made from the budget of the fiscal year within which the liability was incurred. The Juvenile Justice Miscellaneous account is used to pay the state for housing of City juvenile offenders in state facilities, and the state billed the City for less than the budgeted amount in the account during the last fiscal year.

This project ultimately provides water quality improvements into the Lower St. Johns River. The previously constructed detention pond reduces total nitrogen by 30%. The State Financial Assistance Agreement approved by this ordinance stipulates that the City is eligible for \$100,000 on a cost reimbursement basis toward the total project cost estimate of \$3,600,000. *Reference is made to a City minimum match of \$100,000 toward the project though there is no reference to a match in the ordinance*. The project site is located in Council District 7.

The amendment inserts language providing that Cultural Services Grant Capital Program funds shall be allocated in a lump sum to the Cultural Council on the first day of the fiscal year or as soon thereafter as is practical after the execution of the annual contract. Non-capital cultural grant funds shall be disbursed in equal quarterly shares on the first day of each fiscal quarter or as soon thereafter as is practical, and quarterly fiscal and programmatic reports on the use of the funds from the Cultural Council shall be due to the Recreation and Community Services Department within 30 days of the end of each quarter. City funding may be withheld for future quarters if a required quarterly report is not received in a timely manner.

Emergency approval is requested in order to make the revised policies applicable to the new fiscal year's cultural grant funding that became available on October 1st.

Background Information: The current procedure is worded so as to effectively require cultural groups to be reimbursed by City funds for expenses already incurred in producing cultural events upon the submission of a report specifying the expenditures made in the previous fiscal quarter that are eligible for reimbursement according to the organization's Cultural Services Grant application. In practice, many grant recipients do not have a sufficient budget to be able to produce events and then request reimbursement at a later time. Without access to Cultural Services Grant funds up-front, some grant-eligible productions may not be financially feasible.

Bill Summary: This bill confirms the reappointment of Nathaniel Glover, Jr., to the Jacksonville Police and Fire Pension Fund Board of Trustees, for a second two-year term ending October 15, 2010.

Background Information: Sections 175.061 and 185.05, *Florida Statutes*, provide that one of the members of the Police and Fire Pension Board shall be chosen by a majority of the other members of the Board and as a ministerial act, appointed by Council. Former Sheriff Glover is retired from the Jacksonville Sheriff's Office (JSO). During his employment with the JSO, he served as Chief of Police Services, Deputy Director of Police Services and Director of Police Services. He was elected Sheriff in 1995 and served two terms. Former Sheriff Glover also serves on the Jacksonville Children's Zone Committee and previously served on the Jacksonville Commission on Family and Marriage and the Jacksonville Journey Steering Committee.

Bill Summary: This bill confirms the Council President's reappointment of M.G. Orender, as a member of the Comcast Settlement Community Panel, for a third one-year term ending December 31, 2009.

Background Information: Resolution 2003-186-A, approved February 25, 2003, authorized a settlement between the City and *Comcast of Greater Florida/Georgia, Inc.* The settlement agreement provided for Comcast to make annual payments of \$150,000 over a period of 10-years. Grants from the settlement payments are to be awarded by a community panel comprised of five members, of which one member is to be appointed by the Council President and ratified by the Council.

Mr. Orender is the President of Hampton Golf, Inc. and resides in Jacksonville Beach within Council District #13.
