The majority of the department's road right-of-way mowing and all of the mowing of grass around public buildings is done by private contractors. The Municipal Code Compliance Division of the Neighborhoods Department contracts out all of its mowing for remediation of code compliance violations on private properties.

Policy Impact Area: Centralization of mowing and landscape maintenance activities

Background Information: The Arlington Lions Club has submitted a request to change the name of Commerce Street that extends from Rogero Road to Westdale Drive to "Lions Club Way." The service organization owns all properties located on the north side of the segment roadway, including the facility at 6523 Commerce Street. The Jacksonville Historic Preservation Commission has reviewed the street name change and recommended denial of the request, feeling that there were no compelling reasons to change the street name. the 911 Addressing Advisory Committee (Planning & Development Department) reviewed the request and recommended denial of the street name change request feeling that the name change could create confusion for emergency vehicles. Another issue that concerned the 911 Committee: the Lions Club contends that Lions Clubs in major cities throughout Florida are requesting this type of name change in the location of their facilities and that the Lions Club at Jax Beach has already named the street in which this facility is located to a Lions Club street name. The Committee did not like the idea of purposely creating another Lions Club road in Duval County.

Bill Summary: The bill authorizes the execution of easement agreements with private property owners for location, access to and maintenance of the reconstructed Southbank Riverwalk on those properties. The bill designates the Parks and Recreation Department to oversee the project, and authorizes the Mayor or his designee to make technical corrections to the easements as necessary to carry out the intention of the ordinance.

Background Information: The Southbank Riverwalk was constructed in the mid-1980s and has reached the end of its useful life. The Riverwalk is proposed to be reconstructed primarily on land (similar to the Northbank Riverwalk) rather than on pilings over water. This relocation of the Riverwalk requires easements from the property owners on the Southbank to allow the walkway to be constructed on their property and thereafter accessed for public use and for maintenance purposes. Easements will be required from 7 property owners, including the FDOT and School board. The easement term is for 30 years to January 2043.

Policy Impact Area: Capital improvement; public river access

Fiscal Impact: The easements will be granted for a token sum of \$10 per year. The City is responsible for all operations, maintenance and utility costs associated with the Riverwalk.

Bill Summary: The bill authorizes execution of Amendment #12 to the City's lease with the Jacksonville Jaguars for use of EverBank Field, which provides for the financing and construction of various improvements to the stadium, including new video boards and renovations and improvements to the North End Zone (NEZ). The bill authorizes the issuance of \$43,109,000 in commercial paper and the appropriation of the proceeds of that borrowing to the stadium improvement project. It waives the provisions of Ordinance Code Chapter 656 – Zoning Code – in Part 13, Subpart B – Downtown Sign Overlay Zone – with regard to its application to the North End Zone video board; and waives the provisions of Chapter 126 – Purchasing Code, except for any provisions pertaining to the Equal Business Opportunity Program. The bill authorizes the City to directly procure certain construction materials for the project on a sales tax-free basis. It waives the provisions of Ordinance Code Section 320.409 – Schedule of Permit Fees - to waive building permit fees for the project, and waives the provisions of Section 122.811(a) - Sales of Tangible Personal Property, Prohibition of Sales to Certain Persons to permit the direct disposition of tangible personal property being removed from the stadium outside of the normal City requirements. The bill provides that it shall be construed in accordance with Ordinance 2010-493-E which approved Amendment #10 to the stadium lease and created a Capital Maintenance Fund for the Sports Complex facilities. The bill designates the Office of Economic Development as the oversight agency for the project.

Background Information: The Jaguars and the City have discussed a program of improvements to EverBank Field, encompassing new, larger video boards and a north end zone "fan zone", to be constructed at a total cost of approximately \$63 million. The Jaguars have committed \$20 million to the project, with the City paying the remaining \$43 million. Mayor Brown has proposed that the City's contribution be funded using a portion of the tourist development tax ("bed tax"). This bill authorizes short-term commercial paper borrowing to provide initial funding to start construction in January 2014 after the conclusion of the NFL season and Gator Bowl game.

Policy Impact Area: EverBank Field capital improvements

Fiscal Impact: The City commits to appropriate \$43,109,000 in borrowed funds to the improvements.
