**Bill Summary**: The ordinance reappropriates \$1,234,335.00 from the Drainage System Rehabilitation Project within the Stormwater Capital Projects fund to provide funding for four specific drainage projects, the Herschel Street Culvert Project, the Nolan Street Drainage Improvements Project, the Reed Street Drainage Improvements Project, as initiated by B.T. 15-100; it provides a carryover of funds to fiscal year 2015-2016; it amends the 2015-2019 five-year Capital Improvement Program, approved by Ordinance 2014-467-E, to provide funding for the projects entitled "Herschel Street Culvert," "Nolan Street Drainage Improvements," "Reed Street Drainage Improvements," and "Oakwood Street Drainage Improvements; provides for City oversight by the Engineering Division of the Department of Public Works.

Background Information: The Herschel Street culvert is failing; some of the metal culvert has rusted away; both headwalls ae cracked. The roadway has settled along the curbs, creating standing pockets of water. The channel is choked with debris and sediment. The proposed solution is to close the road, remove the failed culvert, and replace it with a precast culvert. The Nolan Street Drainage Improvements improves drainage for Nolan Street, Shearer Avenue and Arney Street. The current drainage system is a combination of ditches and shallow pipes. The pipes are too shallow to permit proper drainage. The project corrects the drainline elevations and provides adequate drainage for these streets. The Reed Street Drainage Improvements project corrects drainage issues along Reed Street that tend to flood several garages and localized flooding along the road. This project is complicated in that there are wetlands involved which elevates the difficult in obtaining a St. Johns River Water Management District permit. Ultimately, the plan is to control the elevation of the Reed Street pond and improve drainage on Reed Street. The Oakwood Street Drainage Improvements are needed because there is no existing drainage infrastructure. A drainage study was initiated that validated several options that would expand the infrastructure and resolve the flooding issue. A piped system will be constructed that will collect drainage from the bottom of the hill where the flooding occurs and deliver it to an existing storm drain manhole two blocks away.

The Nocatee developers have paid hurricane shelter mitigation payments totaling \$89,100 over the course of (three years FY12-13, FY13-14 and FY14-15) that were never transmitted to the Fire and Rescue Department as intended. This bill transmits those hurricane mitigation fees to the JFRD for use.

The enacting legislation provided that credits would be applied first to BJP projects, then "excess credits" could be sold to other users and the revenues deposited into the mitigation fund for future capital improvements for conservation and park uses as appropriated by City Council. A Master Recreation Improvement Plan was commissioned by the City in 1992 to meet the requirements of the Recreation and Open Space Element of the City's newly-adopted Comprehensive Plan which identified and evaluated the condition of all of the City's recreational assets. Another comprehensive inventory and evaluation of recreational facilities and their conditions was performed by the Parks, Recreation and Entertainment Department in 2004.

Ordinance 2013-264-E appropriated \$2.8 million to create 14 council district park improvement funds of \$200,000 apiece.

Background Information: Citizens Property Insurance Company has announced that it will be consolidating 1,038 workers from across the state into a new facility in the EverBank Center on Bay Street in downtown Jacksonville. A material consideration for Citizens in choosing downtown Jacksonville as its location is the availability of parking for the 1,000+ employees. This bill authorizes a license agreement with Amkin West Bay, LLC, the owner of the EverBank Center, to lease the right to park 850 company and employee vehicles in the Water Street Garage, although not in specifically reserved spaces. The license agreement also provides Amkin with a right of first refusal to license additional available parking spaces in the future as such spaces may become available. The term of the agreement is for 5 years (through 2020) at a rate of \$45 per month per licensed and used space, adjusting annually by the lesser of 3% or the CPI Index for All Urban Consumers. The agreement provides that Amkin shall pay an option price of 10% of the then-current lease rate per month for any licensed but unused spaces (850 spaces minus the number of active access cards in use that month).

The agreement grants to Amkin the right to make certain "Licensee Improvements" at its expense to accommodate the storage of several oversized vehicles (including emergency response trailers) on the ground floor of the garage. These licensee improvements include installation of security fencing and gates around the vehicle storage space, modification of an existing curb and installation of an interior ramp. Upon completion the licensee improvements shall become property of the City.

**Background Information:** Ordinance Code Section 129.101 – Pay Grades, Salary Ranges, and Salaries – authorizes the Director of the Employee Services Department to recommend assignment of each appointed official in the Executive Branch to one of the existing pay grades based upon market surveys, internal equity and other relevant factors. The Mayor has final authority to assign appointed officials to pay grades. The section also provides that when an appointed official's job duties change materially, the Director of Employee Services shall recommend assignment to a new pay grade commensurate with the responsibilities; the final placement decision is the Mayor's. The section specifically prohibits reassignment of a position to pay grade more than 2 grades higher than its original level.

The City Treasurer is assuming additional duties following the departure of the City's investment manager.

The new Supervisor of Elections has opted to take a monthly auto allowance rather than drive a fleet vehicle, so the monthly allowance language needs to be restored. The Code currently provides for a vehicle allowance for the Tax Collector of \$300 per month; for the Clerk of the Courts of \$250 per month; and for the Property Appraiser of an amount "not to exceed the maximum amount per month in accordance with the mileage guidelines established in the City's Vehicle Use and Allowance Policy."

The funds are authorized to carry-over to FY2015-16 and the Office of Economic Development is designated as the City's oversight agency for the project. One cycle emergency action is requested on the bill.

**Background Information:** In 2004 the City approved an economic development agreement with RAMCO Jacksonville LLC to incentivize construction of the River City Marketplace shopping center on Duval Road near the Jacksonville International Airport, including a REV grant based on a percentage of property taxes paid by the developer each year. In FY14-15 the City appropriated \$415,000 of JIA CRA tax increment revenue to pay the REV grant, which proved insufficient as both RAMCO's real and personal property tax levies increased substantially during calendar year 2014. The Office of Economic Development has requested appropriation of an additional \$128,629.07 to cover the additional REV grant cost from the JIA CRA's cash carryover account.
