The grant amount is \$29,464.00 less \$589.00 retained by Volunteer Florida for administrative cost. The grant period is August 1, 2016 – July 31, 2017. The Jacksonville Children's Commission is providing \$10,254.00 in-kind match toward personnel services.

The Sheriff's Office is designated as the oversight agency for the fund.

Background Information: The Inmate Welfare Fund receives the net proceeds from the operation of the commissaries at the City's correctional facilities and uses those funds "only for the overall welfare of the inmates" for purposes authorized under Sec. 951.23, *Florida Statutes*. An Inmate Welfare Fund Committee makes recommendations on use of the funds, with the ultimate decision being made by the JSO's Director of Corrections. It is an all-years fund and at the end of each year the Sheriff's Budget Officer calculates actual net profits on the commissary operation and estimates the next year's net revenues to determine how much is available for expenditure in the upcoming fiscal year.

Policy Impact Area: Inmate Welfare Trust Fund use

Background Information: Curtis Lee and the Concerned Taxpayers of Duval County sued the City and the Police and Fire Pension Fund board in 2011 alleging that pension benefits for police officers and firefighters were negotiated in meetings held outside of the requirements of the Florida Government in the Sunshine Act. The trial court found in favor of the plaintiffs. The Police and Fire Pension Fund board appealed the verdict (the City did not appeal) and the appellate court upheld the circuit court's ruling. The City and the PFPF board have negotiated separate settlements of plaintiff's legal fees in the amount of \$331,800 from the PFPF and \$255,000 from the City. This bill approves the City settlement agreement with Curtis Lee and Concerned Taxpayers and appropriates the \$255,000 from General Fund – GSD fund balance to the Judgements, Claims and Losses account.

Bill Summary: The bill amends several sections of Ordinance Code Chapter 666 – Duval County Tourist Development Plan – to adopt a new plan for allocation of the tourist development tax proceeds. The bill adds language to Sec. 666.106 - Tourist Development Tax – to provide that 2% of the 2 cent bed tax shall be allocated to the Tourist Development Council for administrative costs and that 1% of the first 2 cents shall be allocated to the Tax Collector for that office's cost of collecting the tax. The bill amends Sec. 666.108 – Tourist Development Plan – to provide for allocation of the TDC tax revenues on a variable basis as follows:

Advertising, marketing and public relations to promote tourism	71%	40%	50%
Fund convention bureaus, tourist bureaus, visitor information centers	5%	0%	0%

Language is added prohibiting use of tourist development tax funds: 1) to finance capital improvements through the use of public or private debt; 2) to construct, furnish or equip a hotel, whether or not adjacent to a county owned and operated facility; 3) for the use of privately owned facilities.

The bill deletes all of the language from the prior Tourist Development Plan and almost all of the language from Sec. 666.109 regarding administration of the plan.

Background Information: The City's current Tourist Development Plan was adopted in October of 1978 and became effective January 1, 1979; it has not been changed since that time. Pursuant to state law, amendments to the Tourist Development Plan must be adopted by the governing body of the county by affirmative vote of a majority of the body plus one.

The Duval County Tourist Development Council debated the proposed percentage allocations in the plan at length and recommended them to the Council.

Policy Impact Area: Tourist development tax use

Fiscal Impact: The 2 cents of the bed tax allocated to the Tourist Development Plan is anticipated to generate approximately \$7.4 million in FY16-17, an increase of nearly \$600,000 over the FY15-16 budgeted amount of \$6.8 million.

Bill Summary: The bill approves a development agreement between the City and the University of North Florida for the transportation impacts of improvements identified in the 2025 UNF Campus Master Plan. The bill authorizes reimbursement to UNF of a portion of the cost of road improvements to be constructed by UNF from the UNF Campus Development Agreement Special Revenue Fund which was funded by UNF through Fair Share payments. The Planning and Development Department is designated as the City's oversight agency for the project.

Background Information: The City and UNF previously entered into a UNF Campus Development Agreement in 2006 for projects listed in a previous edition of the UNF campus master plan; that agreement expires on December 31, 2016. The City created the UNF Campus Development Agreement Special Revenue Fund as one of the City's Fair Share Specific Project Special Revenue accounts to receive the revenues generated by fair share assessments generated from UNF to be automatically appropriated to the widening and reconfiguration of First Coast Technology Parkway adjacent to the college campus. That project has since been abandoned.

UNF has adopted a new campus master plan and this bill approves a new development agreement between the parties reflecting the revised master plan projects. The term of the new agreement is through December 31, 2025. The parties agree that campus developments shall not negatively impact the concurrency Levels of Service of public facilities and services in the area. A trip generation study by Prosser for UNF found that because UNF's enrollment has not increased as much as projected in the earlier master plan, the impact on City roadways would be considerably less than projected and the fair share assessments already collected from UNF far exceed the transportation impacts. The agreement finds that the estimated fair share impact of UNF's master plan projects on City roadways is less than the \$3,050,940 currently available in the UNF Campus Development Agreement Special Revenue Fund, and the City agrees to appropriate those funds to UNF to accomplish the transportation improvements shown in the new master plan, comprising the 2-lane extensions of two on-campus roads - Eco Road on the university's western edge and Osprey Ridge Road on the east side of campus.

Policy Impact Area: UNF campus development

Fiscal Impact: The bill authorizes the disbursement of up to \$3,050,940 currently available in the UNF Campus Development Agreement Special Revenue Fund -16 as reimbursement to the university for the cost of constructing the two roadway extensions.

Bill Summary: The bill amends the FY15-16 budget to revise the budgets of the Jacksonville International Airport Community Redevelopment Area, the KingSoutel Crossing Community Redevelopment Area, the Combined Northbank Community Redevelopment Area and the Southside Community Redevelopment Area to revise the budgetary allocations for various projects. One-cycle emergency approval is requested.

Background Information: The City Council recently met in its role as the governing board of the JIA CRA and voted to amend the CRA's FY15-16 budget to appropriate \$432,000 to a proposed Safariland Inc. economic development incentive and to allocate \$123,098 to reduce the CRA's future years' indebtedness on the RAMCO project debt service. The Council, meeting as the KingSoutel Crossing CRA, voted to amend that CRA's FY15-16 budget to allocate \$125,000 for a CRA plan update and allocate the balance of \$381,351 for the Gateway Minor Project, Soutel Dr. and Norfolk Blvd. (creation of a landscaped community gateway at the intersection).

The DIA board, which governs the downtown Combined Northbank and Southside CRAs, has requested that the budgets of those CRAs be amended to 1) appropriate \$233,824 from the Southside tax increment district toward the Riverplace Road Diet project (increased on-street parking, widened sidewalks, bike lanes, etc.); 2) appropriate \$550,000 from the Southside TID to the Southbank Parking FDOT project; 3) appropriate \$1,309,732 from the Southside TID for public infrastructure improvements to the former JEA Southside Generating Station redevelopment site; 4) transfer \$894,911 from the Downtown Economic Development Fund to cover contractual subsidies to the MPS Parking Solutions downtown garage; 5) reflect the prior transfer of \$759,218 from the City General Fund to the North East TID as a debt obligation to be repaid by the TID to the General Fund; and 6) make an intra-fund transfer of \$2,429,615 from the Northwest to the North East TID.

Policy Impact Area: CRA projects and budgets

Fiscal Impact: The bill allocates \$4,049,916 to 8 projects, reflects a transfer of \$759,218 as a loan from one fund to another, and makes an intra-fund transfer of \$2,429,615 within a TID fund.

Bill Summary: The bill approves the renewal of the certificate of public convenience and necessity (CON) for Old Kings Road LLC to operate the Old Kings Road construction and demolition debris disposal at 8540 Old Kings Road, subject to 29 specific conditions.

Background Information: Pursuant to Chapter 380, Ordinance Code, Old Kings Road Solid Waste, LLC has applied for renewal and modification of its Certificate of Public Convenience and Necessity to operate a construction and demolition debris landfill recycling facility at 8540 Old Kings Road in Council District 8. The Solid Waste Division of the Public Works Department has determined that there is a need for the facility and supports the approval of its CON renewal. The CON for this facility was originally granted in 1996 and has been in the name of Old Kings Road Solid Waste LLC since 2002, with previous renewals in 2006 and 2009.

The 29 conditions include regulations on acceptable and unacceptable wastes; hours of operation; personnel training; reporting to the City; payment of a solid waste host fee; noise, odor and litter controls, and site security, among others.

Policy Impact Area: Solid waste disposal

Fiscal Impact: The company is required to pay a solid waste host fee (currently \$7.16) per ton of waste received; the facility is permitted to receive 3,000 tons of waste per year.

Bill Summary: The bill appropriates a \$2.8 million grant from the Florida DOT Economic Development Transportation Fund to the City to provide financial assistance to the construction of a new roadway to service the Amazon distribution center to be constructed at Pecan Park Road and I-295 near Jacksonville International Airport. It waives provisions of Ordinance Code Chapter 126 – Procurement Code – to permit RELP Duval LLC to construct the road without being selected by a competitive bidding process, and invokes the exception provided in Sec. 126.107(g) of the Procurement Code to allow the hiring of any FDOT-qualified consultant construction engineering inspection firm without a competitive procurement process. The bill authorizes execution of various grant receipt, grant disbursement, economic development agreement amendment, and property exchange agreements among a variety of parties to the transaction. It authorizes two land swap agreements and designates the Public Works Department and Office of Economic Development as the City's administration and monitoring agencies for various functions related to these agreements.

Background Information: In order to incentivize the construction of a new Amazon.com distribution facility on the City's Northside, the Florida DOT and City of Jacksonville have agreed to provide \$2.8 million and \$2.5 million, respectively, to the construction of a new alignment of Pecan Park Road between I-295 and the airport to accommodate the new facility. Pursuant to the terms of the various agreements, RELP Duval LLC, the owner of the property and a subsidiary of USAA, a national insurance and financial services company that acts as a site developer for Amazon facilities, will contract for the construction of a new alignment of Pecan Park Road at an estimated cost of \$4.8 million. The FDOT grant will pay for the first \$2.8 million of the cost, with RELP paying the contractor in installments as work is done and requesting reimbursement by the City from its \$2.5 million grant, which the City will in turn get reimbursed from the state grant. After the FDOT's \$2.8 million is fully received by the City, the City will pay 50% of the remaining cost of the project up to a maximum of \$2.5 million on a reimbursement basis after the roadway is complete and conveyed to the City. RELP Duval is responsible for any costs in excess of \$4.8 million. The company will continue to own the property and building and will lease the site to Amazon for an initial term of 20 years.

The bill provides for an exchange of properties between the City and the JAA, and another exchange between the City and RELP Duval of parcels of similar size and value in order to assemble a parcel in the location desired by RELP and Amazon. The City will be responsible for maintenance of the road once it is completed by RELP and conveyed to the City.

The bill amends the existing economic development incentive agreement between the City and Amazon to provide that the payment of the City road infrastructure grant may be made to RELP Duval rather than to Amazon.com

Policy Impact Area: Economic development

Fiscal Impact: The City has committed up to \$2.5 million in the form of an infrastructure grant for construction of a roadway, paying half of the cost of the road construction after the FDOT's grant of \$2.8 million is fully expended.
