The Recreation and Community Services Department respectfully requests approval to initiate legislation and to authorize the Mayor to approve and execute all documentation relating to State Statute 316.195 which requires City legislation to allow angled parking on a two lane roadway. The parking area and cul-de-sac will be constructed by the Florida Department of Transportation in conjunction with improvements at the Trout River Pier, a Florida Inland Navigation District (FIND) grant funded project located in Council District 7.
