- **PURPOSE/SUMMARY:** Draft the legislation necessary for the City Council to consider a Resolution regarding the acceptance of four (4) surplus parcels from the FDOT. A map of the parcels is enclosed.
- One parcel (#81) was requested by the city's library system to add to the Mandarin Branch's inholdings, primarily to protect the branch from a potential nuisance situation where the eventual owner may seek to harass city to re-sell at a profit.
- The remaining three (#s 112, 113, 142) were requested by the Right of Way and Grounds Maintenance Division to enhance the present cul-de-sacs allowing for emergency vehicles to have sufficient space to turn around.
