SPONSOR (Department/Division/Agency/Council Member):

PURPOSE/SUMMARY: Authorize the redistribution of funds for the 2010 Urban Areas Security Initiative Homeland Security Grants within specific city accounts. The movement of funds is due to new Department of Homeland Security Grant Guidance that requires that the spend down of Grants be expedited. This caused the reprioritization of funds within the grants, primarily from salaries for grant funded employees, rental fees, and maintenance to specific equipment projects. The reprioritized funds have been approved by the Urban Area Working Group (UAWG) and State Administrative Agency.
