PURPOSE/SUMMARY: To appropriate funds from FEMA through the Florida Division of Emergency Management for Repetitive Flood Claim (RFC) mitigation project. This grant provides funding for a Property Acquisition/ Demolition of Structures project between the City of Jacksonville, and property owners Mr. and Mrs. Ronald and Lorann Poudrier, 6768 Bakersfield Drive, which has sustained repetitive flooding. The City will enter into agreement with Mr. & Mrs. Poudrier with FEMA grant funding, for the expenses to acquire properties, demolish structures and slabs, and remove debris associated with the project and file a perpetual open/space conservation easement on the property. **FEMA will pay 100% of the project expenses.**
