PURPOSE/SUMMARY: Creates new Part III within Chapter 55, Ordinance Code which establishes a Downtown Investment Authority to serve as the Community Redevelopment Agency ("CRA") as defined in Florida Statutes, Chapter 163, Part III; Amends and creates various other Ordinance Code provisions to provide for Council approval of a new Downtown Investment Authority, along with their respective powers, duties, and responsibilities; Creates a new Redevelopment Trust Fund of the Downtown Investment Authority in Chapter 111, Ordinance Code; Amends Chapter 500, Ordinance Code to establish the DIA's role as the City's CRA for Downtown community redevelopment areas and the City Council as the City's CRA for non-Downtown Areas; Clarifies the Downtown Overlay Zone Map and Boundaries as set forth in 656.361.2, Ordinance Code; Approves forms for Economic Development Redevelopment and Ground Lease, within Downtown; Amends Section 17.06 of City Charter to provide for civil service exemptions; Provides for certain codifications; Authorizes the Council Auditor and General Counsel's office to make technical amendments; Provides for an effective date.
