Amend ordinance 98-1053-E to establish an "All Years" Criminal Justice Training Trust Fund in accordance with Chapter 943.25 Florida Statutes, and to appropriate funds for the 2012-2013 fiscal year (07.01.12 -06.30.13). These funds are to be used only for advanced and specialized training for law enforcement and correctional officers and for administrative costs as approved by the Criminal Justice Standards and Training Commission (CJSTC).
