PURPOSE/SUMMARY: This bill repeals the current part 4 of Ch. 636 which has been preempted by Florida law and creates a new part 4 to Ch. 636 authorizing the Sheriff to utilize traffic infraction detectors (red light cameras) for the purpose of issuing notices of violations and traffic citations, in compliance with Florida's Mark Wandall Traffic Safety Act, Ch. 2010-80, Laws of Fla. This bill also creates sections 636.402 and 111.397, creating and authorizing the Sheriff's Red Light Safety Revenue Fund, requiring annual reporting and annual deposits of net revenues from the traffic infraction detector program into the City's General Fund.
