PURPOSE/SUMMARY: **During the 2012 Legislative Session, SB 704 amended the definition of contractor found in s. 105 (3) F.S. Due to this change, all demolition of buildings now requires licensure as a Ch. 489, Part I (General Building or Residential) Contractor, or as a locally licensed Demolition Specialty Contractor. This proposed amendment to Ch. 342 M.O. would create a local Demolition Specialty Contractor category. Further it provides a Grand Fathering option for the existing, currently unregulated, local demolition contractors.**
