PURPOSE/SUMMARY:

- Please provide the Real Estate Division with authority to request the legislation necessary for the City Council to approve the conveyance of a Perpetual Drainage Easement, in accordance with Section 122.421 (b), and authorize the Mayor and Corporation Secretary to execute all the necessary documentation to convey said Perpetual Drainage Easement to FDOT.
- The Perpetual Drainage Easement is for the purpose of accessing, constructing and maintaining existing headwalls, proposed side drain culverts, and re-grading the area in front of existing headwalls within an existing open drainage ditch. The subject drainage ditch carries storm water through the area of Hamilton Street and Jersey Street in the vicinity of Edgemont Street. Both FDOT and City storm drainage flows through this area, before it flows under Roosevelt Blvd., and ultimately flowing into the Ortega River.
- This request has been sent to the various municipal agencies. There is no objection to granting the easement.
